- 1 A BILL to amend and reenact §5B-2-17 of the Code of West Virginia, 1931, as amended, relating
- 2 to the West Virginia Motorsport Committee; expanding the membership from five to 18
- 3 members, including the chairperson; and designating the motorsport that shall be
- 4 represented by the increased membership.

Be it enacted by the Legislature of West Virginia:

ARTICLE 2. DEPARTMENT OF ECONOMIC DEVELOPMENT.

§5B-2-17. West Virginia Motorsport Committee.

- 1 (a) The West Virginia Motorsport Committee is hereby created.
- 2 (b) The committee consists of five <u>18</u> members, including its chairperson, appointed by the
- 3 Governor to serve at his or her will and pleasure. <u>The committee members shall represent:</u>

- 6 <u>(3) Dirt oval racing;</u>
- 7 <u>(4) Drag racing;</u>
- 8 <u>(5) Drift racing;</u>

- 10 (7) Karting racing;
- 11 (8) Motor cross racing;
- 12 (9) Motorcycle road course racing;
- 13 <u>(10) Mud racing;</u>
- 14 (11) Off-road racing;
- 15 <u>(12 Rallying racing;</u>
- 16 (13) Rallycross racing;
- 17 (14) Road course racing;
- 18 (15) Time Trials racing;
