1	A BILL to amend the Code of West Virginia, 1931, as amended by adding a new article,
2	designated §37-3A-1 and §37-3A-2, relating to prohibiting ownership and possession of
3	real estate by foreign adversaries.
	Be it enacted by the Legislature of West Virginia:
	ARTICLE 3A. PREVENTING FOREIGN ADVERSARIES FROM OWNING REAL
	ESTATE IN WEST VIRGINIA.
	§37-3A-1. Foreign adversaries prohibited from owning real estate in West Virginia.
1	Except as otherwise provided in this article, any resident alien or citizen may acquire, hold,
2	and transfer real estate in this state by deed, will, or other instrument, including in fee simple or any
3	lesser estate.
	§37-3A-2. Definitions.
1	As used in this article:
2	(1) "Controlling interest" means an ownership interest of 50 percent or more in the
3	aggregate.
4	(2) "Prohibited foreign-party-controlled business" means a corporation, company,
5	association, firm, partnership, joint-stock company, trust, estate, or other legal entity in which a
6	controlling interest is owned or operated, in whole or in part, by a prohibited foreign party.
7	(3) "Owned or operated in whole or in part" means:
8	(A) For a publicly traded company, the person or entity has the ability to control the
9	company, access any material nonpublic technical information in the possession of the company,
10	or exercise any other rights or involvement in substantive decision-making beyond those of a retail
11	investor holding an equivalent ownership share;

(B) For a privately held company, the person or entity possesses any ownership interest.

(4) "Control" means the power, direct or indirect, whether or not exercised, to determine,

15	ownership of at least 20 percent of the total outstanding voting interest, board representation, the					
16	ability to appoint or remove board members, proxy voting rights, special shares, contractual					
17	arrangements, legal obligations, or other formal or informal mechanisms to act in concert.					
18	(5) "Prohibited foreign party" means:					
19	(A) A citizen or resident of the People's Republic of China who is not a resident alien or					
20	citizen of the United States;					
21	(B) The government of the People's Republic of China or any of its political subdivisions;					
22	(C) Any party other than an individual or government:					
23	(i) Created or organized under the laws of any state or foreign country; and					
24	(ii) In which a significant interest or substantial control is held directly or indirectly by:					
25	(I) A person described in paragraph (A) of this subdivision;					
26	(II) A government described in paragraph (B) of this subdivision;					
27	(III) Any combination of the above; or					
28	(IV) An agent, trustee, fiduciary, or other entity acting on behalf of any of the foregoing;					
29	(D) Any foreign government, entity, or individual identified annually by the West Virginia					
30	Secretary of Homeland Security, and also by consultation of the Governor of West Virginia, the					
31	West Virginia Secretary of State, and the Attorney General, as hostile to the interests of the United					
32	States or the State of West Virginia.					
	§37-3A-3. Prohibition on Ownership by Prohibited Foreign Parties.					
1	(a) A prohibited foreign-party-controlled business may not acquire or own, directly or					
2	indirectly, any interest in any real estate in this state, including mineral rights.					
3	(b) No person may hold any interest in real estate as an agent, trustee, or fiduciary on					
4	behalf of a prohibited foreign-party-controlled business.					
5	(c) Any such interest in any real estate that is held on the effective date of this article shall					
6	be divested within six months of the effective date.					

	§37-3A-4.	Enforcement;	Judicial	Sale.	
1	(a) A prohibited foreign-party-controlled business that acquires real estate in violation of				
2	this article shall divest such interest within six months of acquisition.				
3	(b) If the business fails to divest, the Attorney General shall file a civil action in the circuit				
4	court of the county where the real estate is located.				
5	(c) Upon a circuit court finding by a preponderance of the evidence that a violation of the				
6	provisions of this article have occurred, the circuit court shall order the real estate to be sold				
7	through judicial sale under terms and conditions that are to be set by the circuit court.				
8	(d) Proce	eeds of the sale shall be distributed to	lienholders according to price	ority, excluding	
9	liens that remain	n on the real estate under the terms of	sale. Lienholders may credi	t bid.	
10	<u>(e) The /</u>	Attorney General shall promptly file in t	the office of the county clerk	where the real	
11	estate is located	I the following:			
12	(1) A no	tice of the pending action in the coun	ty in which the real estate is	s located upon

2	violation of this	article by a previous owner.			
3	(b) A per	son who is not subject to the prohibition	ns contained in this article is	not required to	
4	investigate whe	ther another person or entity is subject	to the prohibitions contained	d in this article.
