A BILL to amend the Code of West Virginia, 1931, as amended, by adding thereto a new article, designated §31A-8H-1, §31A-8H-2, §31A-8H-3, §31A-8H-4, and §31A-8H-5; and to amend said code by adding a new article, designated §46A-6O-1, §46A-6O-2, §46A-6O-3, §46A-6O-4, §46A-6O-5, §46A-6O-6, §46A-6O-7, §46A-6O-8, §46A-6O-9, §46A-6O-10, and §46A-6O-11, relating to the Safe Harbor for Cybersecurity Programs and the Consumer Data Protection Act; providing for an affirmative legal defense to certain types of businesses against demands for an award of exemplary or punitive damages in lawsuits claiming that the business failed to implement reasonable cybersecurity protections and that as a result, a data breach of personal information or restricted information occurred if the business creates, maintains, and complies with a written cybersecurity program that contains administrative, technical, operational, and physical safeguards for the protection of personal information as set forth in this act; defining terms; describing the requirements of the cybersecurity program; construction of article; clarifying no private cause of action provided by article; and providing immunity in certain circumstances to certain institutions of higher education in this state that offer a cybersecurity assessment program as part of an undergraduate or graduate program relating to cybersecurity to any business in the state; establishing a framework for controlling and processing personal data of consumers in this state; creating definitions; limiting application to all persons that conduct business in this state and either control or process personal data of at least 100,000 consumers or derive over 50% of gross revenue from the sale of personal data and control or process personal data of at least 25,000 consumers; providing exemptions; delineating responsibilities and privacy protection standards for data controllers and processors; clarifying standards do not apply to state or local governmental entities; providing exceptions for certain types of data and information governed by federal law; providing that consumers have rights to access, correct, delete, obtain a copy of personal data, and to opt out of the processing of personal data for the purposes of targeted advertising;

providing standards for data protection assessments; delineating processing of deidentified data; specifying limitations upon scope of the article; providing for civil penalty for violations of provisions of the article; clarifying that the Attorney General has exclusive authority to enforce violations of the law; providing for assistance of the Attorney General in obtaining relief; and providing for construction and an effective date.

Be it enacted by the Legislature of West Virginia:

CHAPTER 31A. BANKS AND BANKING.

ARTICLE 8H. SAFE HARBOR FOR CYBERSECURITY PROGRAMS.

§31A-8H-1. Definitions.

As used in this article:
(1) "Business" means any limited liability company, limited liability partnership,
corporation, sole proprietorship, association, or other group, however organized and
whether operating for profit or not for profit, including a financial institution or bank holding
company organized, chartered, or holding a license authorizing operation under the laws
of this state, any other state, the United States, or any other country, or the parent or
subsidiary of any of the foregoing.
"Business" does not include any body, authority, board, bureau, commission,
district, or agency of the state or of any political subdivision of the state.
(2) "Contract" means the total legal obligation resulting from the parties' agreement
as affected by this article and other applicable law.
(3) "Covered entity" means a business that accesses, maintains, communicates, or
processes personal information in or through one or more systems, networks, or services
located in or outside this state.
(4) "Data breach" means unauthorized access to and acquisition of computerized

data that compromises the security or confidentiality of personal information owned by or

17	licensed to a covered entity and that causes, reasonably is believed to have caused, or
18	reasonably is believed will cause a material risk of identity theft or other fraud to person or
19	property. "Data breach" does not include either of the following:
20	(A) Good faith acquisition of personal information by the covered entity's employee
21	or agent for the purposes of the covered entity provided that the personal information is not
22	used for an unlawful purpose or subject to further unauthorized disclosure;
23	(B) Acquisition of personal information pursuant to a search warrant, subpoena, or
24	other court order, or pursuant to a subpoena, order, or duty of a regulatory state agency.
25	(5) "Distributed ledger technology" means an electronic ledger or other record of
26	transactions or other data to which all of the following apply:
27	(A) The electronic ledger is uniformly ordered.
28	(B) The electronic ledger is redundantly maintained or processed by more than one
29	computer or machine to guarantee the consistency or nonrepudiation of the recorded
30	transactions or other data.
31	(6) "Electronic record" means a record created, generated, sent, communicated,
32	received, or stored by electronic means.
33	(7) "Encryption" means the use of an algorithmic process to transform data into a
34	form in which there is a low probability of assigning meaning without use of a confidential
35	process or key.
36	(8) "Individual" means a natural person.
37	(9)(A) "Personal information" means any information relating to an individual who
38	can be identified, directly or indirectly, in particular by reference to an identifier such as a
39	name, an identification number, social security number, driver's license number or state
40	identification card number, passport number, account number, or credit or debit card
41	number, precise location data, biometric data, an online identifier, or to one or more factors

42	specific to the physical, physiological, genetic, mental, economic, cultural, or social identity
43	of that individual.
44	(B) "Personal information" does not include publicly available information that is
45	lawfully made available to the general public from federal, state, or local government
46	records or any of the following media that are widely distributed:
47	(i) Any news, editorial, or advertising statement published in any bona fide
48	newspaper, journal, or magazine, or broadcast over radio, television, or the internet.
49	(ii) Any gathering or furnishing of information or news by any bona fide reporter,
50	correspondent, or news bureau to news media identified in this paragraph.
51	(iii) Any publication designed for and distributed to members of any bona fide
52	association or charitable or fraternal nonprofit business.
53	(iv) Any type of media similar in nature to any item, entity, or activity identified in this
54	paragraph.
55	(10) "Record" means information that is inscribed on a tangible medium or that is
56	stored in an electronic or other medium and is retrievable in perceivable form.
57	(11) "Redacted" means altered or truncated so that no more than the last four digits
58	of a social security number, driver's license number, state identification card number,
59	passport number, account number, or credit or debit card number is accessible as part of
60	the data.
61	(12) "Smart contract" means an electronic record that is an event-driven program or
62	computerized transaction protocol that runs on a distributed, decentralized, shared, and
63	replicated ledger that executes the term of a contract, including but not limited to, taking
64	custody over and instructing the transfer of assets.
65	(13) "Transaction" means a sale, trade, exchange, transfer, payment, or conversion
66	of virtual currency or other digital asset or any other property or any other action or set of

§31A-8H-2. Affirmative defenses.

1	(a) A covered entity seeking an affirmative defense against demands for an award
2	of exemplary or punitive damages under this chapter shall create, maintain, and comply
3	with a written cybersecurity program that reasonably conforms to an industry recognized
4	cybersecurity framework, as described in §31A-8H-3; and which contains administrative,
5	technical, operational, and physical safeguards for the protection of personal information.
6	(b) A covered entity's cybersecurity program shall be designed to do all of the
7	following with respect to the information described in §31A-8H-2(a):
8	(1) Protect the security and confidentiality of the information;
9	(2) Protect against any anticipated threats or hazards to the security or integrity of
10	the information;
11	(3) Protect against unauthorized access to and acquisition of the information that is
12	likely to result in a material risk of identity theft or other fraud to the individual to whom the
13	information relates; and
14	(4) Set out a process for communicating to affected parties in the event of a known
15	material data breach.
16	(c) The scale and scope of a covered entity's cybersecurity program under §31A-
17	8H-2(a) is appropriate if it is based on all of the following factors:
18	(1) The size and complexity of the covered entity;
19	(2) The nature and scope of the activities of the covered entity;
20	(3) The sensitivity of the information to be protected;
21	(4) The cost and availability of tools to improve information security and reduce
22	vulnerabilities;

(5) The resources available to the covered entity.

24	(d) (1) A covered entity that satisfies the provisions of §31A-8H-2(a), §31A-8H-2(b),
25	and §31A-8H-2(c), is entitled to an affirmative defense to any demands for an award of
26	exemplary or punitive damages that is brought under the laws of this state or in the courts
27	of this state which alleges that the failure to implement reasonable information security
28	controls resulted in a data breach concerning personal information.
29	(2) A covered entity satisfies all requirements of this section if its cybersecurity
30	program reasonably conforms to an industry-recognized cybersecurity framework, as
31	described in §31A-8H-3 of this code.
	§31A-8H-3. Cybersecurity program framework.
1	(a) A covered entity's cybersecurity program, as described in §31A-8H-2 of this
2	code, reasonably conforms to an industry-recognized cybersecurity framework for
3	purposes of this article if the cybersecurity program meets any of the following three
4	requirements as applicable:
5	(1)(A) The cybersecurity program reasonably conforms to the current version of
6	any of the following or any combination of the following, subject to §31A-8H-3(a)(1)(B) and
7	§31A-8H-3(b):
8	(i) The framework for improving critical infrastructure cybersecurity developed by
9	the National Institute of Standards and Technology.
10	(ii) National Institute of Standards and Technology special publication 800-171.
11	(iii) National Institute of Standards and Technology special publications 800-53 and
12	<u>800-53a.</u>
13	(iv) National Institute of Standards and Technology special publication 800-76-1.
14	(v) The federal risk and authorization management program security assessment
15	framework.
16	(vi) The Center for Internet Security critical security controls for effective cyber
17	defense.

18	(vii) The International Organization for Standardization/International
19	Electrotechnical Commission 27000 family — information security management systems.
20	(viii) The Cybersecurity Maturity Model Certification at a minimum of Level 2 with
21	external certification.
22	(B) When a final revision to a framework listed in §31A-8H-3(a)(1)(A) is published,
23	a covered entity whose cybersecurity program reasonably conforms to that framework
24	shall reasonably conform the elements of its cybersecurity program to the revised
25	framework within the time frame provided in the relevant framework upon which the
26	covered entity intends to rely to support its affirmative defense, but in no event later than
27	one year after the publication date stated in the revision.
28	(2)(A) The covered entity is regulated by the state, by the federal government, or
29	both, or is otherwise subject to the requirements of any of the laws or regulations listed
30	below, and the cybersecurity program reasonably conforms to the entirety of the current
31	version of any of the following, subject to §31A-8H-3(a)(2)(B):
32	(i) The security requirements of the federal Health Insurance Portability and
33	Accountability Act of 1996, as set forth in 45 C.F.R. pt. 164, subpt. C.
34	(ii) Title V of the federal Gramm-Leach-Bliley Act of 1999, Pub. L. No. 106-102, as
35	amended.
36	(iii) The federal Information Security Modernization Act of 2014, Pub. L. No. 113-
37	<u>283.</u>
38	(iv) The federal Health Information Technology for Economic and Clinical Health
39	Act as set forth in 45 C.F.R. pt. 162.
40	(v) Any applicable rules, regulations, or guidelines for critical infrastructure
41	protection adopted by the federal Environmental Protection Agency, the federal
42	Cybersecurity and Infrastructure Security Agency, or the North American Reliability
43	Corporation.

(B) When a framework listed in §31A-8H-3(a)(2)(A) is amended, a covered entity
whose cybersecurity program reasonably conforms to that framework shall reasonably
conform the elements of its cybersecurity program to the amended framework within the
time frame provided in the relevant framework upon which the covered entity intends to
rely to support its affirmative defense, but in no event later than one year after the effective
date of the amended framework.

(3)(A) The cybersecurity program reasonably complies with both the current version of the payment card industry data security standard and conforms to the current version of another applicable industry-recognized cybersecurity framework listed in §31A-8H-3(a)(1), subject to the provisions of §31A-8H-3(a)(3)(B) and §31A-8H-3(b).

(B) When a final revision to the payment card industry data security standard is published, a covered entity whose cybersecurity program reasonably complies with that standard shall reasonably comply the elements of its cybersecurity program with the revised standard within the time frame provided in the relevant framework upon which the covered entity intends to rely to support its affirmative defense, but not later than the effective date for compliance.

(b) If a covered entity's cybersecurity program reasonably conforms to a combination of industry-recognized cybersecurity frameworks and two or more of those frameworks are revised, the covered entity whose cybersecurity program reasonably conforms to or complies with, as applicable, those frameworks shall reasonably conform the elements of its cybersecurity program to or comply with, as applicable, all of the revised frameworks within the time frames provided in the relevant frameworks but in no event later than one year after the latest publication date stated in the revisions.

§31A-8H-4. Limitation on private right of action.

This article shall not be construed to provide a private right of action, including a class action, with respect to any act or practice regulated therein.

§31A-8H-5. Security assessments; limitation on liability.

1	(a) Any institution of higher education in this state may offer a cybersecurity
2	assessment program as part of an undergraduate or graduate program relating to
3	cybersecurity to any business in the state.

(b) An institution of higher education in this state, or any employee or student thereof, offering a cybersecurity assessment program shall be immune from civil liability that arises from the failure of a covered entity to conform to the provisions of this article.

CHAPTER 46A. WEST VIRGINIA CONSUMER CREDIT AND PROTECTION ACT.

ARTICLE 60. CONSUMER DATA PROTECTION ACT.

§46A-6O-1. Definitions.

- 1 As used in this article, unless the context requires a different meaning:
- 2 "Affiliate" means a legal entity that controls, is controlled by, or is under common control
- 3 with another legal entity or shares common branding with another legal entity. For the purposes of
- 4 this definition, "control" or "controlled" means:
- 5 (1) Ownership of, or the power to vote, more than 50 percent of the outstanding shares of 6 any class of voting security of a company;
 - (2) Control in any manner over the election of a majority of the directors or of individuals exercising similar functions; or
- 9 (3) The power to exercise controlling influence over the management of a company.
- 10 "Authenticate" means verifying through reasonable means that the consumer, entitled to 11 exercise his consumer rights in §46A-6O-3 of this code, is the same consumer exercising such 12 consumer rights with respect to the personal data at issue.
- 13 "Biometric data" means data generated by automatic measurements of an individual's biological characteristics, such as a fingerprint, voiceprint, eye retinas, irises, or other unique 14

15	biological patterns or characteristics that is used to identify a specific individual. "Biometric data"
16	does not include a physical or digital photograph, a video or audio recording or data generated
17	therefrom, or information collected, used, or stored for health care treatment, payment, or
18	operations under HIPAA.
19	"Business associate" means the same meaning as the term established by HIPAA.
20	"Child" means any natural person younger than 13 years of age.
21	"Consent" means a clear affirmative act signifying a consumer's freely given, specific,
22	informed, and unambiguous agreement to process personal data relating to the consumer.
23	Consent may include a written statement, including a statement written by electronic means, or
24	any other unambiguous affirmative action. Consent does not include consent induced by use of a
25	user interface designed or manipulated with the substantial effect of subverting or impairing user
26	autonomy, decision-making, or choice.
27	"Consumer" means a natural person who is a resident of the State acting only in an
28	individual or household context. It does not include a natural person acting in a commercial or
29	employment context.
30	"Controller" means the natural or legal person that, alone or jointly with others, determines
31	the purpose and means of processing personal data.
32	"Covered entity" means the same as the term is established by HIPAA.
33	"Data broker" means a business, or unit or units of a business, separately or together, that
34	knowingly collects and sells to third parties the personal information of a consumer with whom the
35	business does not have a direct relationship. Examples of a direct relationship with a business
36	include if the consumer is a past or present:
37	(1) Customer, client, subscriber, user, or registered user of the business's goods or
38	services;
39	(2) Employee, contractor, or agent of the business;
40	(3) Investor in the business; or

41	(4) Donor to the business.
42	"Decisions that produce legal or similarly significant effects concerning a consumer
43	means a decision made by the controller that results in the provision or denial by the controller of
44	financial and lending services, housing, insurance, education enrollment, criminal justice
45	employment opportunities, health care services, or access to basic necessities, such as food and
46	water.
47	"De-identified data" means data that cannot reasonably be linked to an identified o
48	identifiable natural person, or a device linked to such person, if the controller that possesses such
49	<u>data:</u>
50	(1) takes reasonable measures to ensure that such data cannot be associated with ar
51	individual,
52	(2) publicly commits to process such data only in a de-identified fashion and not attempt to
53	re-identify such data, and
54	(3) contractually obligates any recipients of such data to satisfy the criteria set forth in
55	subdivisions (1) and (2) of this definition. A controller that possesses "de-identified data" shall
56	comply with the requirements of §46A-6O-7(a) of this code.
57	"Fund" means the Consumer Privacy Fund established pursuant to §46A-6O-11 of this
58	code.
59	"Health record" means any written, printed or electronically recorded material maintained
60	by a health care entity in the course of providing health services to an individual concerning the
61	individual and the services provided. "Health record" also includes the substance of any
62	communication made by an individual to a health care entity in confidence during or in connection
63	with the provision of health services or information otherwise acquired by the health care entity
64	about an individual in confidence and in connection with the provision of health services to the
65	individual.

66	"HIPAA" means the federal Health Insurance Portability and Accountability Act of 1996 (42
67	<u>U.S.C.§1320d et seq.).</u>
68	"Identified or identifiable natural person" means a person who can be readily identified,
69	directly or indirectly.
70	"Institution of higher education" means a state institution of higher education as defined in
71	§18B-1-2 of this code and, includes further, any private institution of higher education.
72	"Nonprofit organization" means any corporation organized under the West Virginia
73	Nonprofit Corporation Act, §31-1-101 et seq. of this code, any organization exempt from taxation
74	under §§501(c)(3), 501(c)(6), or 501 (c)(12) of the Internal Revenue Code, any federal or state
75	governmental entity or any organization exempt from taxation under § 501(c)(4) of the Internal
76	Revenue Code which are established for the purposes of detecting and preventing insurance
77	fraud, and the National Insurance Crime Bureau.
78	"Personal data" means any information that is linked or reasonably linkable to an identified
79	or identifiable natural person. "Personal data" does not include de-identified data or publicly
80	available information.
81	"Precise geolocation data" means information derived from technology, including, but not
82	limited to, global positioning system level latitude and longitude coordinates or other mechanisms,
83	that directly identifies the specific location of a natural person with precision and accuracy within a
84	radius of 1,750 feet. "Precise geolocation data" does not include the content of communications,
85	or of any data generated by or connected to advanced utility metering infrastructure systems or
86	equipment for use by a utility."
87	"Process" or "processing" means any operation or set of operations performed, whether by
88	manual or automated means, on personal data or on sets of personal data, such as the collection,
89	use, storage, disclosure, analysis, deletion, or modification of personal data.
90	"Processor" means a natural or legal entity that processes personal data on behalf of a
91	controller.

92	"Profiling" means any form of automated processing performed on personal data to
93	evaluate, analyze, or predict personal aspects related to an identified or identifiable natural
94	person's economic situation, health, personal preferences, interests, reliability, behavior, location,
95	or movements.
96	"Protected health information" means the same as the term is established by HIPAA.
97	"Pseudonymous data" means personal data that cannot be attributed to a specific natural
98	person without the use of additional information, provided that such additional information is kept
99	separately and is subject to appropriate technical and organizational measures to ensure that the
100	personal data is not attributed to an identified or identifiable natural person.
101	"Publicly available information" means information that is lawfully made available through
102	federal, state, or local government records, or information that a business has a reasonable basis
103	to believe is lawfully made available to the general public through widely distributed media, by the
104	consumer, or by a person to whom the consumer has disclosed the information, unless the
105	consumer has restricted the information to a specific audience.
106	"Sale of personal data" means the exchange of personal data for valuable consideration by
107	the controller to any third party. "Sale of personal data" does not include:
108	(1) The disclosure of personal data to a processor that processes the personal data on
109	behalf of the controller;
110	(2) The disclosure of personal data to a third party for purposes of providing a product or
111	service requested by the consumer;
112	(3) The disclosure or transfer of personal data to an affiliate of the controller;
113	(4) The disclosure of personal data where the consumer directs the controller to disclose
114	the personal data or intentionally uses the controller to interact with a third party;
115	(5) The disclosure of information that the consumer;
116	(i) intentionally made available to the general public via a channel of mass media and

118	(6) The disclosure or transfer of personal data to a third party as an asset that is part of a
119	merger, acquisition, bankruptcy, or other transaction in which the third party assumes control of all
120	or part of the controller's assets.
121	"Sensitive data" means a category of personal data that includes:
122	(1) Personal data revealing racial or ethnic origin, religious beliefs, mental or physical
123	health diagnosis, sexual orientation, or citizenship or immigration status;
124	(2) The processing of genetic or biometric data for the purpose of uniquely identifying a
125	natural person;
126	(3) The personal data collected from a known child; or
127	(4) Precise geolocation data.
128	"State agency" means the same as that term is defined in §6D-1-1 of this code and
129	"Targeted advertising" means displaying advertisements to a consumer where the
130	advertisement is selected based on personal data obtained from that consumer's activities over
131	time and across nonaffiliated websites or online applications to predict such consumer's
132	preferences or interests. "Targeted advertising" does not include:
133	(1) Advertisements based on activities within a controller's own websites or online
134	applications;
135	(2) Advertisements based on the context of a consumer's current search query, visit to a
136	website, or online application;
137	(3) Advertisements directed to a consumer in response to the consumer's request for
138	information or feedback; or
139	(4) Processing personal data processed solely for measuring or reporting advertising
140	performance, reach, or frequency.
141	"Third party" means a natural or legal person, public authority, agency, or body other than
1/12	the consumer controller processor or an affiliate of the processor or the controller

143	"Trade secret" means information, without regard to form, including, but not limited to,					
144	technical, nontechnical, or financial data, a formula, pattern, compilation, program, device,					
145	method, technique, plan, or process, that:					
146	(1) Derives independent economic value, actual or potential, from not being generally					
147	known to, and not being readily ascertainable by proper means by, other persons who can obtain					
148	economic value from the information's disclosure or use; and					
149	(2) Is the subject of efforts that are reasonable under the circumstances to maintain the					
150	information's secrecy.					
	§46A-6O-2. Scope; exemptions.					
1	(a) This article applies to persons that conduct business in the state or produce products or					
2	services that are targeted to residents of the state and that:					
3	(1) During a calendar year, control or process personal data of at least 100,000					
4	consumers;					
5	(2) Control or process personal data of at least 25,000 consumers and derive over 50					
6	percent of gross revenue from the sale of personal data; or					
7	(3) Have annual gross revenues generated in this state which exceed \$25,000,000.					
8	(b) This article shall not apply to any:					
9	(1) Body, authority, board, bureau, commission, district, or agency of the state or of any					
10	political subdivision of the state;					
11	(2) Financial institutions, affiliates, or data subject to Title V of the federal Gramm-Leach-					
12	Bliley Act (15 U.S.C.§6801 et seq.);					
13	(3) Covered entity or business associate governed by the privacy, security, and breach					
14	notification rules issued by the United States Department of Health and Human Services, 45					
15	C.F.R. Parts 160 and 164 established pursuant to HIPAA, and the Health Information Technology					
16	for Economic and Clinical Health Act (Public Law 111-5);					
17	(4) Nonprofit organization; or					

18	(5) Institution of higher education.
19	(c) The following information and data is exempt from this article:
20	(1) Protected health information under HIPAA;
21	(2) Health records for purposes of Title 32.1;
22	(3) Patient identifying information for purposes of 42 U.S.C.§290dd-2;
23	(4) Identifiable private information for purposes of the federal policy for the protection of
24	human subjects under 45 C.F.R. Part 46; identifiable private information that is otherwise
25	information collected as part of human subjects research pursuant to the good clinical practice
26	guidelines issued by The International Council for Harmonisation of Technical Requirements for
27	Pharmaceuticals for Human Use; the protection of human subjects under 21 C.F.R. Parts 6, 50,
28	and 56, or personal data used or shared in research conducted in accordance with the
29	requirements set forth in this chapter, or other research conducted in accordance with applicable
30	<u>law;</u>
31	(5) Information and documents created for purposes of the federal Health Care Quality
32	Improvement Act of 1986 (42 U.S.C.§11101 et seq.);
33	(6) Patient safety work product for purposes of the federal Patient Safety and Quality
34	Improvement Act (42 U.S.C.§299b-21 et seq.);
35	(7) Information derived from any of the health care-related information listed in this
36	subsection that is de-identified in accordance with the requirements for de-identification pursuant
37	to HIPAA;
38	(8) Information originating from, and intermingled to be indistinguishable with, or
39	information treated in the same manner as information exempt under this subsection that is
40	maintained by a covered entity or business associate as defined by HIPAA or a program or a
11	qualified service organization as defined by 42 U.S.C.§290dd-2;
12	(9) Information used only for public health activities and purposes as authorized by HIPAA

43	(10) The collection, maintenance, disclosure, sale, communication, or use of any personal

The controller bears the burden of demonstrating the manifestly unfounded, excessive, or repetitive nature of the request.
- (4) If a controller is unable to authenticate the request using commercially reasonable efforts, the controller shall not be required to comply with a request to initiate an action under §46A-6O-3(a) and may request that the consumer provide additional information reasonably necessary to authenticate the consumer and the consumer's request.
- (5) A controller that has obtained personal data about a consumer from a source other than the consumer shall be deemed in compliance with a consumer's request to delete such data pursuant to §46A-6O-3(a)(3) by either
- (A) retaining a record of the deletion request and the minimum data necessary for the purpose of ensuring the consumer's personal data remains deleted from the business's records and not using such retained data for any other purpose pursuant to the provisions of this chapter or
- (B) opting the consumer out of the processing of such personal data for any purpose except for those exempted pursuant to the provisions of this chapter.

(c) A controller shall establish a process for a consumer to appeal the controller's refusal to take action on a request within a reasonable period of time after the consumer's receipt of the decision pursuant to §46A-6O-3(b)(2) of this code.
