| | §17C-7-1. Driving on right side of roadway <u>; driving on the right side of a roadway having</u> |
| | two or more lanes for traffic moving in the same direction; exceptions; penalty. |
| 1 | (a) Upon all roadways of sufficient width, a vehicle shall be driven upon the right half of |
| 2 | the roadway, except as follows: |
| 3 | (1) When overtaking and passing another vehicle proceeding in the same direction under |
| 4 | the rules governing such movement; |
| 5 | (2) When an obstruction exists that makes it necessary to drive to the left of the center of |
| 6 | the highway: Provided, That any person doing so shall yield the right-of-way to all vehicles |
| 7 | traveling in the proper direction upon the unobstructed portion of the highway within such distance |
| 8 | as to constitute an immediate hazard; |
| 9 | (2)(3) When the right half of a roadway is closed to traffic while under construction or repair; |
