A BILL to amend and reenact §17A-3-14 of the Code of West Virginia, 1931, as amended, relating
 to the authority of the Division of Motor Vehicles to issue a special registration plate for
 autism awareness.

Be it enacted by the Legislature of West Virginia:

ARTICLE 3. ORIGINAL AND RENEWAL OF REGISTRATION; ISSUANCE OF CERTIFICATES OF TITLE.

§17A-3-14. Registration plates generally; description of plates; issuance of special numbers and plates; registration fees; special application fees; exemptions; commissioner to promulgate forms; suspension and nonrenewal. suspension of registration;

(a) The division, upon registering a vehicle, shall issue to the owner one registration plate
 with a registration number consisting of a combination of letters, numerals, symbols, or characters
 in a configuration determined by the commissioner.

- 4 (b) Registration plates <u>issued by the division</u> shall meet the following requirements:
- 5 (1) Plates must incorporate reflectorized material.

6 (2) Registration numbers shall be plainly readable from 100 feet during daylight.

7 (3) The commissioner may assign any additional feature to facilitate reciprocal
8 agreements, facilitate interstate travel, promote highway safety, or promote the efficient operation
9 of the division.

(c) The commissioner may suspend the registration of any owner who displays a damaged
or illegible plate or otherwise fails to comply with the requirements of §17A-3-19 of this code.

12 <u>The division may issue a special registration plate for autism awareness as follows:</u>

(1) Upon appropriate application, the division may issue a special registration plate
 designed by the commissioner for any number of vehicles titled in the name of the qualified
 applicant.

16	(2) The division shall charge a special one-time initial application fee of \$10 in addition to
17	all other fees required by law. This special fee shall be collected by the division and deposited in
18	the State Road Fund.
19	(3) An annual fee of \$15 shall be charged for each plate in addition to all other fees required
20	by this chapter.
21	(d) Any license plate issued or renewed pursuant to this chapter which is paid for by a
22	check that is returned for nonsufficient funds is void without further notice to the applicant. The
23	applicant may not reinstate the registration until the returned check is paid by the applicant in cash,
24	money order, or certified check and all applicable fees assessed as a result thereof have been
25	paid.
26	(e) In furtherance of the Uniform Electronic Transactions Act, §39A-1-1 et seq. of this code,
27	the division may accept or authorize an electronic signature in any instance the law required to be

28 enforced by the commissioner requires a signature or a pen and ink signature.

NOTE: The purpose of this bill is to authorize the Division of Motor Vehicles to issue special registration plates for autism awareness.
