1 A BILL to amend and reenact §61-8-12 of the Code of West Virginia, 1931, as amended, relating to

24	(12) "Sexual intercourse" means any act between persons involving penetration, however
25	slight, of the female sex organ by the male sex organ or involving contact between the sex organs
26	of one person and the mouth or anus of another person;
27	(13) "Sexual intrusion" means any act between persons involving penetration, however
28	slight, of the female sex organ or of the anus of any person by an object for the purpose of
29	degrading or humiliating the person so penetrated or for gratifying the sexual desire of either party;
30	(14) "Sister" means the daughter of a person's father or mother;
31	(15) "Son" means a person's natural son, adoptive son, or the son of a person's husband
32	or wife; and
33	(16) "Uncle" means <u>:</u>
34	(A) the The brother of a person's father or mother; or
35	(B) The husband of a person's uncle or aunt.
36	(b) A person is guilty of incest when such person engages in sexual intercourse or sexual
37	intrusion with his or her father, mother, brother, sister, daughter, son, grandfather, grandmother,
38	grandson, granddaughter, nephew, niece, uncle, or aunt.
39	(c) Any person who violates the provisions of this section shall be guilty of a felony, and,
40	upon conviction thereof, shall be imprisoned in the penitentiary not less than 5 years nor more than
41	15 years, or fined not less than \$500 nor more than \$5,000 and imprisoned in the penitentiary not
42	less than five years nor more than fifteen years.
43	(d) In addition to any penalty provided under this section and any restitution which may be
44	ordered by the court under §61-11A-1 et seq. of this code, the court may order any person
45	convicted under the provisions of this section, where the victim is a minor, to pay all or any portion
46	of the cost of medical, psychological, or psychiatric treatment of the victim, the need for which

results from the act or acts for which the person is convicted, whether or not the victim is considered to have sustained bodily injury.

(e) In any case where a person is convicted of an offense described in this section against a child and further has or may have custodial, visitation, or other parental rights to the child, the court shall find that the person is an abusing parent within the meaning of §49-4-601 through §49-4-610 of this code, and shall take further action in accord with the provisions of those sections.

NOTE: The purpose of this bill is to expand definitions of certain relatives under the statute governing incest to include aunts and uncles by marriage, and aunts and uncles in same-sex marriages.

Strike-throughs indicate language that would be stricken from a heading or the present law and underscoring indicates new language that would be added.
