1	A BILL supplementing and amending the appropriations of public moneys out of the Treasury from			
2	the balance of moneys remaining as an unappropriated balance in the State Fund, General			
3	Revenue, to the Department of Homeland Security, Division of Corrections and			
4	Rehabilitation – Correctional Units, fund 0450, fiscal year 2025, organization 0608, and to			
5	the Department of Homeland Security, Division of Corrections and Rehabilitation – Bureau			
6	of Juvenile Services, fund 0570, fiscal year 2025, organization 0608, by increasing the			
7	appropriations for the fiscal year ending June 30, 2025.			
1	WHEREAS, The Governor submitted the Executive Budget Document to the Legislature			
2	on February 12, 2025, containing a statement of the State Fund, General Revenue, setting forth			
3	therein the cash balance as of July 1, 2024, and further included the estimate of revenue for the			
4	fiscal year 2025, less net appropriation balances forwarded and regular and surplus			
5	appropriations for the fiscal year 2025, and further included recommended supplemental			
6	appropriations from the balance of the State Fund, General Revenue; and			
1	WHEREAS, It appears from the Governor's Statement of the State Fund, General			
2	Revenue, there now remains an unappropriated balance in the Treasury which is available for			
3	appropriation during the fiscal year ending June 30, 2025; therefore			
	Be it enacted by the Legislature of West Virginia:
