1 A BILL supplementing and amending the appropriations of public moneys out of the Treasury from  
2 the balance of moneys remaining as an unappropriated surplus balance in the State Fund,  
3 General Revenue, to the Department of Arts, Culture, and History, Division of Culture and  
4 History, fund 0293, fiscal year 2025, organization 0432, by adding new items of  
5 appropriation for the fiscal year ending June 30, 2025.

1 WHEREAS, The Governor submitted the Executive Budget Document to the Legislature  
2 on February 12, 2025, containing a statement of the State Fund, General Revenue, setting forth  
3 therein the cash balance as of July 1, 2024, and further included the estimate of revenue for the  
4 fiscal year 2025, less net appropriation balances forwarded and regular and surplus  
5 appropriations for the fiscal year 2025, and further included recommended supplemental  
6 appropriations from the balance of the State Fund, General Revenue; and

1 WHEREAS, The Governor also recommends a further expiration of General Revenue  
2 funds remaining from previous fiscal years to the unappropriated surplus balance of the State  
3 Fund, General Revenue; and

1 WHEREAS, It appears from the Governor's Statement of the State Fund, General  
2 Revenue, and the additional recommended expiration to the unappropriated surplus balance of  
3 the State Fund, General Revenue, there now remains an unappropriated surplus balance in the  
4 Treasury which is available for appropriation during the fiscal year ending June 30, 2025; therefore

*Be it enacted by the Legislature of West Virginia:*

1 That the total appropriation for the fiscal year ending June 30, 2025, to fund 0293, fiscal  
2 year 2025, organization 0432, be supplemented and amended by adding new items of  
3 appropriation as follows:
