## **House Bill 3521**

By Delegates Rohrbach, Hornbuckle, Mazzocchi,  
Hott, and Fehrenbacher.

[Originating in the Committee on Finance; Reported  
on April 9, 2025]

1 A BILL expiring funds to the surplus balance in the State Fund, General Revenue, for the fiscal  
2 year ending June 30, 2025, in the amount of \$1,192,452 from the Attorney General –  
3 Consumer Protection Recovery Fund, fund 1509, fiscal year 2025, organization 1500, and  
4 making a supplementary appropriation of public moneys out of the Treasury from the  
5 balance of moneys remaining as a surplus balance in the State Fund, General Revenue, to  
6 the Department of Health – Central Office, fund 0407, fiscal year 2025, organization 0506,  
7 by supplementing and amending the appropriations for the fiscal year ending June 30,  
8 2025.

9 WHEREAS, The Legislature finds that the account balance in the Attorney General –  
10 Consumer Protection Recovery Fund, fund 1509, fiscal year 2025, organization 1500, exceeds  
11 that which is necessary for the purposes for which the account was established; and

12 WHEREAS, The Governor submitted the Executive Budget Document to the Legislature  
13 on February 12, 2025, containing a statement of the State Fund, General Revenue, setting forth  
14 therein the cash balance as of July 1, 2024, and further included the estimate of revenue for the  
15 fiscal year 2025, less net appropriation balances forwarded and regular and surplus  
16 appropriations for the fiscal year 2025, and further included recommended supplemental  
17 appropriations from the balance of the State Fund, General Revenue; and

1 WHEREAS, It appears from the Governor's Statement of the State Fund, General  
2 Revenue, and this legislation, there now remains a surplus balance in the Treasury which is  
3 available for appropriation during the fiscal year ending June 30, 2025; therefore

*Be it enacted by the Legislature of West Virginia:*

1 That the balance of the funds available for expenditure in the fiscal year ending June 30,  
2 2025, Attorney General – Consumer Protection Recovery Fund, fund 1509, fiscal year 2025,  
3 organization 1500, be decreased by expiring the amount of \$1,192,452 to the surplus balance of  
4 the State Fund, General Revenue, to be available for appropriation during the fiscal year 2025.

And, That the total appropriation for the fiscal year ending June 30, 2025, to fund 0407, fiscal year 2025, organization 0506 be supplemented and amended by adding a new line item of appropriation as follows:
