1 A BILL to amend the Code of West Virginia, as amended, by adding a new article, designated §16-2 64A-1, §16-64A-2, §16-64A-3, and §16-64A-4; and to repeal §16-64-1, §16-64-2, §16-64-3 3, §16-64-4, §16-64-5, §16-64-6, §16-64-7, §16-64-8, §16-64-9, and §16-64-10, relating to 4 syringe exchange services programs; defining terms; making syringe exchange service 5 programs unlawful; setting date for closure of existing programs; permitting harm reduction 6 services to continue to operate provided no syringe services are provided; allowing for an 7 administrative timeframe for referral; requiring the imposition of fees for noncompliance; 8 and permitting injunctive relief. As used in this article: 1 2 "Director" means the director of the Office of Health Facility Licensure and Certification. 3 "Harm reduction program" means a program that provides services intended to lessen the 4 adverse consequences of drug use and to protect public health and safety, by providing direct 5 access to a referral to substance use disorder program treatment programs, screenings, 6 vaccinations, education about overdose prevention, wound care, opioid antagonist distribution 7 and education, and other medical services. "Syringe services program" means a program, whether offered by an individual or a 8 9 provider, where an individual can access sterile syringes or needles and other injection 10 paraphernalia without a prescription. §16-64A-2. Syringe Service Programs Unlawful. (a) Syringe services programs shall be considered unlawful in the State of West Virginia; 1 2 <u>and</u> 1 (b) An owner, operator, or other individual shall cease and desist operations of the syringe 2 the effective date of this services program on article. §16-64A-3. Harm reduction services and care transition. 1 (a) An owner, operator, or individual may offer harm reduction services after the effective 2 date of this article: Provided, That the owner, operator or individual does not offer a syringe 3 services program.

NOTE: The purpose of this bill is to make syringe services unlawful and provide for penalties for violation of the article. The proposed bill permits the provision of harm reduction services not associated with a syringe exchange program and permits an administrative timeframe for the transition of care. Requiring the Office for Health Facilities Licensure and Certification to seek penalties and the ability to seek injunctive relief for violations of the article.
