### **Senate Bill 676**

By Senators Rucker and Thorne

[Introduced March 4, 2025; referred  
to the Committee Government Organization]

1 A BILL to amend and reenact §30-10-8 and §30-10-10 of the Code of West Virginia, 1931, as  
2 amended, relating to providing reciprocity for veterinarians who are licensed in other states  
3 to practice veterinary medicine; providing for the process and requirements; providing for  
4 reciprocity to veterinary technicians who are licensed to practice in other states; and  
5 providing for the process and requirements for that reciprocal license.

*Be it enacted by the Legislature of West Virginia:*

**ARTICLE** **10.** **VETERINARIANS.**  
**§30-10-8. Requirements for Veterinary License.**

1 (a) To be eligible for a license to practice veterinary medicine under the provisions of this  
2 article, the applicant must:

- 3 (1) Be of good moral character;  
4 (2) (A) Be a graduate of an accredited school approved by the board; or  
5 (B) Be a graduate of a foreign veterinary school and hold a certificate of competence  
6 issued by a foreign veterinary graduate educational organization as approved by the board;  
7 (3) Have passed the examinations required by the board;  
8 (4) Be at least 18 years of age;  
9 (5) Be a citizen of the United States or be eligible for employment in the United States;  
10 (6) Not have been convicted of a crime involving moral turpitude;  
11 (7) Not have been convicted of a felony under the laws of any jurisdiction within five years  
12 preceding the date of application for licensure which conviction remains unreversed; and  
13 (8) Not have been convicted of a misdemeanor or a felony under the laws of any  
14 jurisdiction at any time if the offense for which the applicant was convicted related to the practice of  
15 veterinary medicine or animal abuse or neglect.

16 (b) A person seeking a license under the provisions of this article shall submit an  
17 application on a form prescribed by the board and pay all applicable fees.

18 (c) An applicant from another jurisdiction shall comply with all the requirements of this

19 ~~article~~ section: *Provided*, That the board may issue a license to an applicant who holds and, for the  
20 five years immediately preceding the submission of his or her application, has held an active  
21 license, or similar credential, in good standing to practice veterinary medicine in a state, district, or  
22 territory of the United States that has licensure requirements that are substantially equivalent to  
23 the requirements of this article, and who avers that his or her license has never been suspended or  
24 revoked as a result of a disciplinary action in any state, district, or territory in which he or she has  
25 held a license to practice as veterinary medicine: *Provided, however*, That the board may require  
26 by rule, promulgated pursuant to §29A-3-1 *et seq.*, that an applicant must provide a letter of good  
27 standing or other documentation demonstrating that his or her license has never been suspended  
28 or revoked as a result of a disciplinary action in each state, district, or territory where he or she  
29 holds and has held a license.

30 (d) A license to practice veterinary medicine issued by the board prior to July 1, 2010, shall  
31 for all purposes be considered a license issued under this article and may be renewed under this  
32 article.

33 (e) An application for a license to practice veterinary medicine submitted to the board prior  
34 to July 1, 2010, shall be considered in conformity with the licensing provisions of this article and  
35 the rules promulgated thereunder in effect at the time of the submission of the application.

**§30-10-10. Requirements for a registered veterinary technician.**

1 (a) To be eligible for a registration to practice veterinary technology under the provisions of  
2 this article, the applicant must:

3 (1) Be of good moral character;

4 (2) Have a degree in veterinary technology from an accredited school, approved by the  
5 board;

6 (3) Have passed the examinations required by the board;

7 (4) Be at least 18 years of age;

8 (5) Be a citizen of the United States or be eligible for employment in the United States;

9 (6) Not have been convicted of a crime involving moral turpitude;

10 (7) Not have been convicted of a felony under the laws of any jurisdiction within five years  
11 preceding the date of application for registration which conviction remains unreversed; and

12 (8) Not have been convicted of a misdemeanor or a felony under the laws of any  
13 jurisdiction at any time if the offense for which the applicant was convicted related to the practice of  
14 veterinary technology or animal abuse or neglect.

15 (b) A person seeking registration under the provisions of this  
16 article shall submit an application on a form prescribed by the board and pay all applicable  
17 fees.

18 (c) A person registered to practice veterinary technology issued by the board prior to July  
19 1, 2010, shall for all purposes be considered registered under this article and may renew pursuant  
20 to the provisions of this article.

21 (d) An applicant from another jurisdiction shall comply with all the requirements of this  
22 section: *Provided*, That the board may issue a license to an applicant who holds and, for the five  
23 years immediately preceding the submission of his or her application, has held an active license,  
24 or similar credential, in good standing to practice veterinary technology in a state, district, or  
25 territory of the United States that has licensure requirements that are substantially equivalent to  
26 the requirements of this article, and who avers that his or her license has never been suspended or  
27 revoked as a result of a disciplinary action in any state, district, or territory in which he or she has  
28 held a license to practice as veterinary technology: *Provided, however*, That the board may require  
29 by rule, promulgated pursuant to §29A-3-1 *et seq.*, that an applicant must provide a letter of good  
30 standing or other documentation demonstrating that his or her license has never been suspended  
31 or revoked as a result of a disciplinary action in each state, district, or territory where he or she  
32 holds and has held a license.

NOTE: The purpose of this bill is to provide reciprocity for licensed veterinarians and  
veterinary technicians who are licensed and in good standing in other states.
