A BILL to amend and reenact §11-6B-3 and §11-6B-7 of the Code of West Virginia, 1931, as
amended; and to repeal §11-8-6e, relating to taxation; providing for a phased-in increase in
the homestead exemption; providing that change to exemption is contingent on passage of
constitutional amendment; and repealing limitation on levy rates resulting in property tax
increase.

Be it enacted by the Legislature of West Virginia:

ARTICLE6B.HOMESTEADPROPERTYTAXEXEMPTION.§11-6B-3.Twenty thousand dollarPhase in of increasing homestead exemption allowed.

1 (a) General. – Beginning January 1, 2027, an exemption from ad valorem property taxes 2 shall be allowed for the first \$20,000 not less than \$25,000 of assessed value of a homestead that 3 is used and occupied by the owner thereof exclusively for residential purposes, when such owner 4 is sixty-five 65 years of age or older or is certified as being permanently and totally disabled 5 provided the owner has been or will be a resident of the State of West Virginia for the two 6 consecutive calendar years preceding the tax year to which the homestead exemption relates. 7 Beginning January 1, 2028, the amount of the exemption of assessed value of a homestead as 8 provided in this section shall increase to \$30,000, beginning January 1, 2029, the amount of the 9 exemption of assessed value of a homestead as provided in this section shall increase to \$35,000. 10 and beginning January 1, 2030, the exemption of assessed value of a homestead as provided in 11 this section shall increase to \$40,000: *Provided*. That an owner who receives a similar exemption 12 for a homestead in another state is ineligible for the exemption provided by this section. The 13 owner's application for exemption shall be accompanied by a sworn affidavit stating that such 14 owner is not receiving a similar exemption in another state: Provided, however, That when a 15 resident of West Virginia establishes residency in another state or country and subsequently 16 returns and reestablishes residency in West Virginia within a period of five years, such resident 17 may be allowed a homestead exemption without satisfying the requirement of two years

consecutive residency if such person was a resident of this state for two calendar years out of the

19 ten calendar years immediately preceding the tax year for which the homestead exemption is 20 sought. Proof of residency includes, but is not limited to, the owner's voter's registration card 21 issued in this state or a motor vehicle registration card issued in this state. Additionally, when a 22 person is a resident of this state at the time such person enters upon active duty in the military 23 service of this country and throughout such service maintains this state as his or her state of 24 residence, and upon retirement from the military service, or earlier separation due to a permanent 25 and total physical or mental disability, such person returns to this state and purchases a 26 homestead, such person is deemed to satisfy the residency test required by this section and shall 27 be allowed a homestead exemption under this section if such person is otherwise eligible for a 28 homestead exemption under this article; and the Tax Commissioner may specify, by regulation 29 promulgated under chapter twenty-nine-a of this code, what constitutes acceptable proof of these 30 facts. Only one exemption shall be allowed for each homestead used and occupied exclusively for 31 residential purposes by the owner thereof, regardless of the number of gualified owners residing 32 therein.

33 (b) *Attachment of exemption.* -- This exemption shall attach to the homestead occupied by 34 the qualified owner on the July first assessment date and shall be applicable to taxes for the 35 following tax year. An exemption shall not be transferred to another homestead until the following 36 July first. If the homestead of an owner qualified under this article is transferred by deed, will or 37 otherwise, the \$20,000 exemption <u>as provided in subsection (a) of this section</u> shall be removed 38 from the property on the next July first assessment date unless the new owner qualifies for the 39 exemption.

40 (c) *Construction.* -- The residency requirement specified in subsection (a) is enacted 41 pursuant to the Legislature's authority to prescribe by general law requirements, limitations and 42 conditions for the homestead exemption, as set forth in section one-b, article ten of the 43 Constitution of this state. Should the Supreme Court of Appeals or a federal court of competent 44 jurisdiction determine that this residency requirement violates federal law in a decision that

45 becomes final, this section shall then be construed and applied, beginning with the July first 46 assessment day immediately following the date the decision became final, as if the residency 47 requirement had not been enacted, thereby preserving the availability of the homestead 48 exemption and the fiscal integrity of local government levying bodies.

- 49 (d) Effective date -- The changes made to this section during the 2025 Regular Session of
- 50 the Legislature shall become effective only upon the ratification of the constitutional amendment

51 proposed in Senate Joint Resolution 14, which will be submitted to the voters following the

52 adoption of that resolution by the Legislature during the 2025 Regular Legislative Session, or any

53 other amendment to the Constitution of West Virginia permitting a homestead property exemption.

§11-6B-7. Property tax books.

1 (a) *Property book entry.* -- The exemption of the first \$20,000 of assessed value as set forth

2 <u>in §11-6B-3 of this code</u> shall be shown on the property books as a deduction from the total

- 3 assessed value of the homestead.
- 4 (b) Levy; statement to homestead owner. -- When the \$20,000 exemption as set forth in
- 5 <u>§11-6B-3 of this code</u> is greater than the total assessed value of the eligible homestead, no taxes
- 6 shall be levied. The sheriff shall issue a statement to the owner showing that no taxes are due.

ARTICLE 8. LEVIES.

§11-8-6e. Effect on regular levy rate when appraisal results in tax increase; public hearings.

1 [Repealed.]

NOTE: The purpose of this bill is to provide for a phased in increase in the homestead exemption; provide that change to exemption contingent on passage of constitutional amendment; and repeal limitation on levy rates when appraisal results in tax increase.
