1	WHEREAS, The Governor submitted the Executive Budget Document to the Legislature					
2	on February 12, 2025, containing a statement of the State Fund, General Revenue, setting forth					
3	therein the cash balance as of July 1, 2024, and further included the revised estimate of revenue					
4	for the fiscal year 2025, less net appropriation balances forwarded and regular and surplus					
5	appropriations for the fiscal year 2025; and					
1	WHEREAS, It appears from the Executive Budget document, Statement of the State Fund,					
2	General Revenue, and this legislation, there remains an unappropriated balance in the State					
3	Treasury which is available for appropriation during the fiscal year ending June 30, 2025; therefore
