1	A BILL supplementing and amending the appropriations of public moneys out of the Treasury from			
2	the balance of moneys remaining as an unappropriated balance in the State Fund, Genera			
3	Revenue, to the Department of Health, Bureau for Public Health – Office of Maternal,			
4	Child, and Family Health – West Virginia Birth-to-Three, fund 0426, fiscal year 2025			
5	organization 0506, by increasing an existing item of appropriation for the fiscal year ending			
6	June 30, 2025.			
7	WHEREAS, The Governor submitted the Executive Budget Document to the Legislature			
8	on February 12, 2025, containing a statement of the State Fund, General Revenue, setting forth			
9	therein the cash balance as of July 1, 2024, and further included the estimate of revenue for the			
10	fiscal year 2025, less net appropriation balances forwarded and regular and surplus			
11	appropriations for the fiscal year 2025, and further included recommended expirations to the			
12	unappropriated surplus balance of the State Fund, General Revenue; and			
1	WHEREAS, It appears from the Governor's Statement of the State Fund, General			
2	Revenue, there now remains an unappropriated balance in the Treasury which is available for			
3	appropriation during the fiscal year ending June 30, 2025; therefore			
	Be it enacted by the Legislature of West Virginia:			
1	That the total appropriation for the fiscal year ending June 30, 2025, to fund 0426, fiscal			
2	year 2025, organization 0506, be supplemented and amended by increasing an existing item of			
3	appropriation as follows:
