|    | Be it enacted by the Legislature of West Virginia:   |
|    | ARTICLE 29. TAX AND EXPENDITURE LIMITATION ACT.  |
|    | <u>§11-29-1. Short title.</u>  |
| 1  | This article shall be known as the "Tax and Expenditure Limitation Act".                             |
|    | §11-29-2. Provisions.  |
| 1  | For any fiscal year that commences on or after December 31, 2025, state and local                    |
| 2  | government districts must have voter approval in advance for any new tax rate increase, mill levy    |
| 3  | above that for the prior year, valuation for assessment ratio increase for a property class, or      |
| 4  | extension of an expiring tax, any markup on products sold through state-controlled enterprises, or   |
| 5  | a tax policy change directly causing a net tax revenue gain to any district. Voter approval is also  |
| 6  | required for creation of any multi-fiscal year direct or indirect district debt or other financial   |
| 7  | obligation without adequate present cash reserves pledged irrevocably and held for payments in       |
| 8  | all future years, except for refinancing district bonded debt at a lower interest rate or adding new |
| 9  | employees to existing district pension plans. Voter approval is also required for suspension of the  |
| 10 | spending limits imposed by this Act.   |

| 1  | (a) For any fiscal year that commences on or after December 31, 2025, the maximum                   |

17 the emergency reserve fund shall accrue to the fund.

18 (c) Each local government district shall transfer revenue in excess of the spending limit in 19 an emergency reserve cash fund, which fund is hereby created, to the extent necessary to ensure 20 the balance in the fund at the end of the year is an amount equal to two and one-half percent of the 21 spending limit. The emergency reserve cash fund can only be used for declared emergencies as 22 defined in this Act. Unused emergency funds apply to the next years emergency cash reserve 23 fund. Any excess reserves that remain after the local government district has made transfers to the 24 emergency cash reserve fund shall be refunded during the next fiscal year through temporary 25 property or sales tax rate reductions. §11-29-7. Budget stabilization fund. 1 (a) For any state fiscal year that commences on or after December 31, 2025, if revenue 2 from sources not excluded from total state revenues exceeds the limit on total state revenue 3 calculated in accordance with §11-29-5 of this code, for that fiscal year the excess shall be 4 reserved or refunded as follows: 5 (B) The state treasurer shall first transfer the excess to the emergency reserve cash fund to 6 the extent necessary to ensure that the balance of the fund at the end of the fiscal year is an 7 amount equal to two and one-half percent of the total state revenues limit for the fiscal year as 8 required by §11-29-4 of this code. The state treasurer shall transfer additional excess to the 9 budget stabilization fund which fund is hereby created, to the extent necessary to ensure that the 10 balance of the fund at the end of the fiscal year is an amount equal to two and one-half percent of 11 the total state revenue limit for the fiscal year. The state treasurer shall not transfer any monies 12 other than the revenues in excess of the total state revenues limit to the fund. Interest or other 13 income earned on the budget stabilization fund shall accrue to the fund. 14 (C) For any state fiscal year that commences on or after December 31, 2026, if the amount 15 of the total state revenues is less than the amount of total state revenues for the prior fiscal year, 16 the state treasurer shall transfer money from the budget stabilization fund to the general fund in an
