1 A BILL to amend and reenact §15A-12-9 of the Code of West Virginia, as amended; and to amend
 2 the code by adding a new section, designated §15-3D-10, relating to preserving records
 3 and evidence in missing persons cases that are unresolved after one year.

Be it enacted by the Legislature of West Virginia:

ARTICLE 12. WEST VIRGINIA FUSION CENTER.
§15A-12-9. Cold case database.

1 (a) As used in this section:
 2 "CODIS" means the Combined DNA Index System;
 3 "Cold case" means any investigation into a qualifying crime, ~~a missing person,~~ or
 4 unidentified human remains where all investigative leads have been exhausted and the crime
 5 remains unsolved;
 6 "Database" means the cold case database;
 7 "NAMUS" means the National Missing and Unidentified Persons System;
 8 "NCIC" means the National Crime Information Center;
 9 "NCMEC" means the National Center for Missing and Exploited Children;
 10 "Qualifying crime" means felony offenses set forth in §61-2-1 *et seq.*, §61-3-1, §61-3-2,
 11 §61-3-7, §61-3C-14b, §61-3E-1 *et seq.*, §61-8-1 *et seq.*, §61-8A-1 *et seq.*, §61-8B-1 *et seq.*, §61-
 12 8C-1 *et seq.*, and §61-8D-1 *et seq.* of this code; and
 13 "Unresolved missing persons case" is a missing person's case that is unresolved one year
 14 from the date it was opened.
 15 "ViCAP" means the Violent Crime Apprehension Program.
 16 (b) The West Virginia Fusion Center shall develop a secure database that contains all
 17 information related to each cold case and all unresolved missing persons cases in any jurisdiction
 18 in the state.
 19 (c) The West Virginia Fusion Center shall adopt policies and procedures to collect
 20 information for the database and for its maintenance.

21 (d) (1) Each law-enforcement agency in the state and the State Fire Marshal's Fire
22 Investigation Division may provide the information required by the West Virginia Fusion Center for
23 inclusion in the database for each cold case.

24 (2) Each law-enforcement agency in the state must provide the information required by the
25 West Virginia Fusion Center for inclusion in each missing person case that is older than one year.

26 (3) Each law-enforcement agency and the office of the State Fire Marshal may maintain its
27 physical evidence and investigation files for each cold case until the investigation is resolved.

28 (e) Information to be collected and maintained in the cold case database. – Each law-
29 enforcement agency in the state and the Fire Marshal's Fire Investigation Division may provide a
30 written report or other information to the West Virginia Fusion Center for inclusion in the database
31 containing the following:

32 (1) The victim's:

33 (A) Name;

34 (B) Gender;

35 (C) Race;

36 (D) Ethnicity; and

37 (E) Date of birth;

38 (2) The ViCAP number if the case has been entered into the ViCAP system;

39 (3) The NCMEC number if the case has been entered into the NCMEC system;

40 (4) Whether the case was entered into the NAMUS system;

41 (5) The NCIC number if entered into the NCIC system;

42 (6) The Medical Examiner case number;

43 (7) Whether a probative, unanalyzed suspect referenced DNA is available;

44 (8) Whether a probative crime scene DNA profile from the putative perpetrator has been
45 uploaded to CODIS;

46 (9) Whether reference DNA from the victim is available;

- 47 (10) The West Virginia State Police Forensic Lab case number;
- 48 (11) The name of the agency investigating the case;
- 49 (12) The investigating agency's phone number;
- 50 (13) The agency case number;
- 51 (14) Whether the victim was a juvenile or adult victim at the time the crime occurred;
- 52 (15) The date the crime was reported to the investigating agency;
- 53 (16) The date or approximate date the victim was last seen;
- 54 (17) The date or approximate date of death;
- 55 (18) The cause or manner of death;
- 56 (19) The location where the body was found;
- 57 (20) Whether a weapon was used, and the type of weapon used;
- 58 (21) Whether the following evidence is available:
- 59 (A) Fingerprints;
- 60 (B) Palm prints;
- 61 (C) Latent prints;
- 62 (D) Dental records;
- 63 (E) Shell casings; or
- 64 (F) Other physical evidence;
- 65 (22) Whether a suspect or person of interest has been identified;
- 66 (23) Scars, marks, tattoos, and any other unique distinguishing features of any suspects or
- 67 persons of interest;
- 68 (24) A case narrative; and
- 69 (25) Any other additional information that is pertinent to the case.
- 70 (f) The following information may be entered if applicable to either the victim or the suspect,
- 71 but the law-enforcement agency shall specify which individual is being referenced:
- 72 (1) Vehicle information;

- 73 (2) Aliases;
- 74 (3) Associated case addresses;
- 75 (4) Associated phone numbers;
- 76 (5) Associated names;
- 77 (6) Case photos or composite drawings at the discretion of the investigating agency; and
- 78 (7) Any other additional information that is pertinent to the case.
- 79 (g) The West Virginia Fusion Center shall maintain the information contained within the
- 80 database indefinitely.

ARTICLE 3D. WEST VIRGINIA'S MISSING PERSON'S ACT.
§15-3D-10. Unresolved missing persons cases.

- 1 (a) Unresolved missing persons case records and evidence must be retained permanently
- 2 and may not be destroyed.
- 3 (b) Resolved missing persons cases may follow the state's existing record-retention
- 4 schedules.
- 5 (c) Law enforcement agencies must digitize active and unresolved case files within one
- 6 year of the case being opened, ensuring that all related documentation and evidence are scanned,
- 7 uploaded, or otherwise preserved in a secure, searchable digital format.
- 8 (d) All unresolved missing persons cases that are unresolved one year after the date they
- 9 are opened must be uploaded to the West Virginia Fusion Center.

NOTE: The purpose of this bill is to establish specific protocol for preserving records and evidence in missing persons cases that are unresolved after one year.

Strike-throughs indicate language that would be stricken from a heading or the present law and underscoring indicates new language that would be added.
