1 A BILL to amend and reenact §5F-2-1, §11B-1-2, §13-3-3, §13-3-6, and §13-3-7 of the Code of
2 West Virginia, 1931, as amended, to amend said code by adding a new section,
3 designated §12-6A-8, relating generally to the Municipal Bond Commission governance;
4 designating the State Treasurer as chairman of the commission; requiring the State
5 Treasurer to provide office space and staff to support the commission; increasing the per
6 diem rate for members of the commission; requiring the commission to produce quarterly
7 financial statements; requiring the commission to undergo an annual audit; providing for an
8 exemption from state purchasing; permitting the commission to conduct business via video
9 conferencing; authorizing the commission to enter into any existing contracts or
10 agreements with financial institutions; removing obsolete language; and making technical
11 corrections.

Be it enacted by the Legislature of West Virginia:

**CHAPTER 5F. REORGANIZATION OF THE EXECUTIVE BRANCH OF
STATE GOVERNMENT.**

ARTICLE 2. TRANSFER OF AGENCIES AND BOARDS.

§5F-2-1. Transfer and incorporation of agencies and boards; funds.

1 (a) The following agencies and boards, including all of the allied, advisory, affiliated, or
2 related entities and funds associated with any agency or board, are incorporated in and
3 administered as a part of the Department of Administration:
4 (1) Public Employees Insurance Agency provided in §5-16-1 *et seq.* of this code;
5 (2) Governor's Mansion Advisory Committee provided in §5A-5-1 *et seq.* of this code;
6 (3) Commission on Uniform State Laws provided in §29-1A-1 *et seq.* of this code;
7 (4) West Virginia Public Employees Grievance Board provided in §6C-3-1 *et seq.* of this
8 code;
9 (5) Board of Risk and Insurance Management provided in §29-12-1 *et seq.* of this code;

- (6) Boundary Commission provided in §29-23-1 *et seq.* of this code;
- (7) Public Defender Services provided in §29-21-1 *et seq.* of this code;
- (8) Division of Personnel provided in §29-6-1 *et seq.* of this code;
- (9) West Virginia Ethics Commission provided in §6B-2-1 *et seq.* of this code;
- (10) Consolidated Public Retirement Board provided in §5-10D-1 *et seq.* of this code; and
- (11) Real Estate Division provided in §5A-10-1 *et seq.* of this code.

(b) The following agencies and boards, including all of the allied, advisory, affiliated, or entities and funds associated with any agency or board, are incorporated in and registered as a part of the Department of Commerce:

(1) Division of Labor provided in §21-1-1 *et seq.* of this code, which includes the Board of Manufactured Housing Construction and Safety provided in §21-9-1 *et seq.* of this code.

(2) Office of Miners' Health, Safety, and Training provided in §22A-1-1 *et seq.* of this code, the Board of Coal Mine Health and Safety and the Coal Mine Safety and Technical Review Committee provided in §22A-6-1 *et seq.* of this code are transferred to the Office of Miners' Health, Safety, and Training for purposes of administrative support and liaison with the Office of the Governor.

(3) Division of Natural Resources and Natural Resources Commission provided in §20-1-1 of this code;

(4) Division of Forestry provided in §19-1A-1 *et seq.* of this code;

(5) Geological and Economic Survey provided in §29-2-1 *et seq.* of this code;

(6) Workforce West Virginia provided in chapter 21A of this code, which includes:

(A) Division of Unemployment Compensation;

(B) Division of Employment Service;

(C) Division of Workforce Development;

(D) Division of Research, Information and Analysis;

(7) Division of Rehabilitation Services provided in §18-10A-1 *et seq.* of this code; and

45 executive branch.

46 (e) The West Virginia Educational Broadcasting Commission provided in §10-5-1 *et seq.* of
47 this code is continued as a separate agency within the Department of Tourism, which shall provide
48 administrative support for the authority.

49 (f) The following agencies and boards, including all of the allied, advisory, and affiliated
50 entities, are transferred to the Department of Environmental Protection for purposes of
51 administrative support and liaison with the Office of the Governor:

115 (3) Division of Motor Vehicles provided in §17A-2-1 *et seq.* of this code;

116 (4) Driver's Licensing Advisory Board provided in §17B-2-1 *et seq.* of this code; and

117 (5) Division of Multimodal Transportation Facilities provided in §17-16F-1 *et seq.* of this

118 code.

119 (I) Effective July 1, 2011, the Veterans' Council provided in §9A-1-1 *et seq.* of this code,
120 including all of the allied, advisory, affiliated, or related entities and funds associated with it, is
121 incorporated in and administered as a part of the Department of Veterans' Assistance.

122 (m) Except for powers, authority, and duties that have been delegated to the secretaries of
123 the departments by §5F-2-2 of this code, the position of administrator and the powers, authority,
124 and duties of each administrator and agency are not affected by the enactment of this chapter.

125 (n) Except for powers, authority, and duties that have been delegated to the secretaries of
126 the departments by §5F-2-2 of this code, the existence, powers, authority, and duties of boards
127 and the membership, terms, and qualifications of members of the boards are not affected by the
128 enactment of this chapter. All boards that are appellate bodies or are independent decision makers
129 may not have their appellate or independent decision-making status affected by the enactment of
130 this chapter.

131 (o) Any department previously transferred to and incorporated in a department by prior
132 enactment of this section means a division of the appropriate department. Wherever reference is
133 made to any department transferred to and incorporated in a department created in §5F-1-2 of this
134 code, the reference means a division of the appropriate department and any reference to a
135 division of a department so transferred and incorporated means a section of the appropriate
136 division of the department.

137 (p) When an agency, board, or commission is transferred under a bureau or agency other
138 than a department headed by a secretary pursuant to this section, that transfer is solely for
139 purposes of administrative support and liaison with the Office of the Governor, a department

140 secretary, or a bureau. Nothing in this section extends the powers of department secretaries under
141 §5F-2-2 of this code to any person other than a department secretary and nothing limits or
142 abridges the statutory powers and duties of statutory commissioners or officers pursuant to this
143 code.

144 (q) The Department of Economic Development as established in §5B-2-1 *et seq.* of this
145 code is continued as a division of the Department of Commerce.

146 (r) The Department of Tourism as established in §5B-2I-1 *et seq.* of this code is continued
147 as a separate independent agency within the Executive Branch, which includes the following
148 sections and commissions listed under §29-1-1 of this code:

- 149 (1) The Arts Section;
- 150 (2) The Archives and History Section;
- 151 (3) The Museums Section;
- 152 (4) The Historic Preservation Section;
- 153 (5) The State Library Section;
- 154 (6) The National Coal Heritage Area Commission;
- 155 (7) The Administrative Section;
- 156 (8) The Educational Broadcasting Commission;
- 157 (9) A Commission on the Arts;
- 158 (10) A Commission on Archives and History;

CHAPTER 11B. DEPARTMENT OF REVENUE.

ARTICLE 1. DEPARTMENT OF REVENUE.

**§11B-1-2. Agencies, boards, commissions, divisions and offices comprising the
department of finance and revenue.**

(a) There shall be in the Department of Revenue the following agencies, boards, commissions, divisions and offices, including all of the allied, advisory, affiliated or related entities are incorporated in and shall be administered as part of the Department of Revenue:

(1) The Alcohol Beverage Control Commissioner provided for in article sixteen, chapter one of this code and article one, chapter sixty of this code;

(2) The Division of Banking provided for in article two, chapter thirty-one-a of this code;

(3) The board of banking and financial institutions provided for in article three, chapter one-a of this code;

(4) The state budget office, heretofore known as the budget section of the Finance Department of Administration, previously provided for in article two, chapter five-a of this and new provided for in article two of this chapter;

(5) The agency of Insurance Commissioner provided for in article two, chapter thirty-three code;

(6) The lending and credit rate board provided for in chapter forty-seven-a of this code;

(7) The Lottery Commission and the position of lottery director provided for in article -two, chapter twenty-nine of this code;

(8) The Municipal Bond Commission provided for in article three, chapter thirteen of this

(9) (8) The office of tax appeals provided for in article ten-a, chapter eleven of this code;

(10) (9) The state athletic commission provided for in article five-a, chapter twenty-nine of
de;

(11) (10) The Tax Division provided for in article one, chapter eleven of this code; and

(12) (11) The West Virginia Racing Commission provided for in article twenty-three, section nineteen of this code.

(b) The department shall also include any other agency, board, commission, division, office unit subsequently incorporated in the department by the Legislature.

CHAPTER 12. PUBLIC MONEYS AND SECURITIES.

ARTICLE 6A. THE DEBT MANAGEMENT ACT OF 1991.

§12-6A-8. Treasurer as chair of Municipal Bond Commission, the state's fiscal agent, and to provide support to the Municipal Bond Commission.

- 1 (a) The Treasurer shall chair the Municipal Bond Commission as specified in §13-3-1 *et*
- 2 *seq.* of this code, and his or her office shall hire its own employees, consultants, managers, and
- 3 advisors, fix compensation, prescribe job duties, and provide suitable office space necessary to
- 4 provide support to the Municipal Bond Commission.
- 5 (b) The commission shall produce quarterly financial statements for the assets managed
- 6 by the commission and send them to each member of the commission and provide copies as
- 7 reasonably requested.
- 8 (c) The commission shall provide any other information requested in writing by the
- 9 Department of Revenue, the Joint Committee on Finance, or any member of the Legislature.
- 10 (d) *Annual Audits.* -- Beginning with fiscal year ending June 30, 2026, and each fiscal year
- 11 thereafter, the commission shall have an annual financial and compliance audit of the assets,
- 12 accounts, payments, and transfers made by the commission.
- 13 (e) *Purchasing Exemption.* -- Notwithstanding any other provision to the contrary, the
- 14 commission is exempt from all requirements of the Purchasing Division, authorized under W. Va.
- 15 Code §5A-3-1 *et seq.* of this code.

CHAPTER 13. PUBLIC BONDED INDEBTEDNESS.

ARTICLE 3. MUNICIPAL BOND COMMISSION.

§13-3-3. Officers; employees; chief administrative officer; meetings; quorum; compensation and expenses; legal representation.

- 1 (a) The Tax Commissioner State Treasurer or his or her designee shall be chair of the

2 commission.

3 (b) The members of the commission shall appoint a chief administrative officer and may fix
4 his or her title and duties. Notwithstanding the provisions of section two-a, article seven, chapter
5 six of this code, the commission shall have the authority to set the compensation of the chief
6 administrative officer. The chief administrative officer shall serve as secretary to the board and
7 treasurer of the commission. The chair may designate a board member to serve as secretary in
8 the absence of the chief administrative officer. The chair is authorized with the approval of the
9 commission, to employ other employees and consultants as the commission deems advisable and
10 fix their compensation and prescribe their duties.

11 (c) Appointed members of the commission shall be paid \$50 \$500 for each day or
12 substantial portion thereof that they are engaged in the work of the commission. Each member of
13 the commission may be reimbursed for all reasonable and necessary expenses actually incurred
14 in the performance of duties on behalf of the commission.

15 (d) The commission shall hold at least three meetings in each fiscal year, one of which
16 meetings shall be within sixty days of the end of the fiscal year and shall be the annual meeting.
17 The meetings shall be held on dates and at places prescribed by the chair. Additional meetings
18 may be held at the call of the chair or upon the written request of three members at such time and
19 place as designated in such call or request. Three members of the commission constitute a
20 quorum.

21 (e) The chair with the consent of the commission is authorized to provide or designate legal
22 advisory services to the commission.

§13-3-6. Powers and duties of commission.

1 (a) The commission shall serve as fiscal agent for all issuers of general obligation bonds
2 issued by the counties, municipalities, and school districts of the State of West Virginia when the
3 commission is specifically named as the fiscal agent by statute.

4 (b) The commission shall serve as fiscal agent for all issuers of revenue bonds issued by

5 the counties, municipalities, and school districts of this state when the commission is specifically
6 named as the fiscal agent by statute.

7 (c) The commission shall serve as fiscal agent for the issuers of revenue bonds issued by
8 the State of West Virginia through its departments, commissions, boards, or agencies, when the
9 commission is specifically named as the fiscal agent by statute.

10 (d) The commission may serve as fiscal agent for the issuer of other public purpose
11 revenue bond issues when so provided by bond ordinance.

12 (e) The commission may agree to serve as paying agent for all issuers when so provided
13 by bond ordinance.

14 (f) The commission may conduct business by telephonic conference when necessary.

15 (g) The commission may use any contract or agreement of the State Treasurer's Office,
16 Investment Management Board, or the West Virginia Board of Treasury Investments.

17 (h) The commission is hereby granted, has and may exercise all powers necessary or
18 appropriate to effectuate the purposes of this article.

**§13-3-7. Permissible investments; limitations and prohibitions on purchase, sale or
exchange of securities; public records; combining funds and proration of interest;
custody of securities.**

1 (a) Notwithstanding any provisions of this code to the contrary, the commission may invest
2 funds under its control in the following classes of securities and not otherwise:

3 (1) Securities of the United States or any agency thereof which are guaranteed by or for
4 which the full faith and credit of the United States is pledged for the payment of the principal and
5 interest;

6 (2) ~~General obligations of this state or any of its agencies, boards or commissions;~~

7 (3) ~~General obligations of any county, municipality or school district in this state;~~

8 (4) (2) Pools of investment operated by the West Virginia Board of Investments provided
9 that their investments are limited to the above named securities, and provided that securities

10 purchased for these pools following the date of the enactment of this article shall not have
11 maturities greater than five years in length; and

12 (5) (3) Repurchase agreements or similar banking arrangements with a member bank of
13 banks of the federal reserve system or a bank, the deposits of which are insured by the federal
14 deposit insurance corporation, or its successor: *Provided*, That such investments shall only be
15 made to the extent insured by the federal deposit insurance corporation or to the extent that the
16 principal amount thereof shall be fully collateralized by direct obligations of or obligations
17 guaranteed by the United States of America.

18 (b) Securities purchased or held under the provisions of this article may be sold or
19 exchanged for other securities: *Provided*, That: (1) No security shall be purchased, sold or
20 exchanged without the concurrence or ratification of a majority of all members of the commission;
21 (2) no security shall be purchased at a price above, nor sold or exchanged at a price below, its
22 prevailing fair market value; (3) no security shall be purchased, sold or exchanged for the purpose
23 of aiding any individual, firm or corporation by the payment of brokerage commissions or fees
24 thereto; (4) no security purchased, sold or exchanged shall benefit any member or employee of
25 the commission; and (5) no security shall be received in exchange which does not comply with the
26 requirements of this article.

27 (c) The commission shall record all pertinent information related to any purchase, sale or
28 exchange of securities and make such information available for public inspection during normal
29 office hours of the commission.

30 (d) Funds from several or all accounts may be combined for investment and any interest
31 earned shall be prorated and credited quarterly to the various contributing accounts on the basis of
32 based on the amount thereof invested, calculated according to an average periodic balance or
33 other generally accepted accounting principle.

34 (e) All securities purchased by the commission as an investment for the funds shall remain
35 in the custody of the state Board of Investments until the same are sold, exchanged, retired or

36 mature and are paid.

NOTE: The purpose of this bill is to change how the Municipal Bond Commission is governed.
