1 A BILL to amend and reenact §3-8-4 of the Code of West Virginia, 1931, as amended, relating to
2 requiring contact information for the chair of a political committee; and adding to the
3 statement of organization an acknowledgment of legal compliance with campaign finance
4 reporting requirements.

Be it enacted by the Legislature of West Virginia:

ARTICLE 8. REGULATION AND CONTROL OF ELECTIONS.

§3-8-4. Treasurers and financial agents; written designation requirements.

1 (a) No person may act as the treasurer of any political action committee or political party
2 committee supporting, aiding, or opposing the nomination, election, or defeat of any candidate for
3 an office encompassing an election district larger than a county unless a written statement of
4 organization, on a form to be prescribed by the Secretary of State, is filed with the Secretary of
5 State. A change of treasurer or financial agent may be made at any time by filing a written
6 statement with the Secretary of State.

7 (b) No person may act as the treasurer for any candidate committee for a candidate for any
8 office encompassing an election district larger than a county, any legislative office, or any circuit
9 judgeship unless a written statement of organization designating that person as the treasurer or
10 financial agent is filed with the Secretary of State. A change of treasurer or financial agent may be
11 made at any time by filing a written statement with the Secretary of State.

12 (c) No person may act as treasurer of any political committee advocating for candidates to
13 be nominated or elected by the voters of a county or a district therein, except legislative and circuit
14 judge candidates, unless a written statement of organization designating him or her as the
15 treasurer is filed with the clerk of the county commission or the Secretary of State. A change of
16 treasurer may be made at any time by filing a written statement with the clerk of the county
17 commission.

18 (d) Prior to engaging in any activity, a political committee shall file a statement of
19 organization required by subsection (a) of this section. A statement of organization form required

20 by this section shall be certified as accurate and true and signed by the treasurer and the chairman
21 of the committee, and shall include the following information:

22 (1) The name of the political committee;

23 (2) The name of the treasurer;

24 (3) The mailing address, telephone number, and e-mail address of the committee;

25 (4) The mailing address, telephone number, and e-mail address of the treasurer, if different
26 from the committee information;

27 (5) The name, address, telephone number, and e-mail address of the chairman of the
28 committee;

29 (6) The affiliate organization, if any;

30 (7) The type of political committee, as determined by the description of types of committees
31 included in the definitions of "political committee" and "political action committee" in §3-8-1a of this
32 code; and

33 (8) Whether the committee will participate in statewide or local elections; and

34 (9) An acknowledgement that the political committee shall adhere to the reporting
35 requirements set forth in this article.

36 (e) Notwithstanding the provisions of subsections (a), (b), and (c) of this section, a filing
37 designating a treasurer for a state, county, or municipal political committee may be made any time
38 before the committee either accepts or spends funds. Once a designation is made by a state,
39 county, or municipal political committee, no additional designations are required under this section
40 until a successor treasurer is designated.

41 (f) A state, county, or municipal political committee may terminate a designation made
42 pursuant to this section by making a written request to terminate the designation on a form
43 prescribed by the Secretary of State and by filing a report of financial information required in §3-8-
44 5 of this code indicating that the political committee has no funds or debts remaining in the
45 committee's account. This written request shall be filed with either the Secretary of State or the

46 clerk of the county commission as provided by subsections (a), (b), and (c) of this section.

NOTE: The purpose of this bill is add contact information of the committee chair and require and acknowledgment in the statement of organization that the committee must adhere to the reporting requirements set forth in the campaign finance laws of West Virginia.
