1 A BILL to amend and reenact §11-13MM-2 of the Code of West Virginia, 1931, as amended,
2 relating to disabled veteran taxpayers; and clarifying the definition of a "disabled veteran
3 taxpayer".

Be it enacted by the Legislature of West Virginia:

ARTICLE 13MM. WEST VIRGINIA PROPERTY TAX ADJUSTMENT ACT.

§11-13MM-2.

Definitions.

1 (a) General. — When used in this article, or in the administration of this article, terms
2 defined in subsection (b) of this section have the meanings ascribed to them by this section unless
3 a different meaning is clearly required by the context in which the term is used.

4 (b) Terms defined. —

5 (1) "Ad valorem property tax" means and is limited to the West Virginia ad valorem property
6 tax.

7 (2) "Business" means any activity taxable under article §11-12-1 *et seq.* of this code, which
8 is engaged in by any person in this State.

9 (3) "Disabled veteran taxpayer" means a person given an honorable discharge from any
10 branch of the armed services of the United States and ~~who is considered at least 90 percent totally~~
11 ~~and permanently disabled due solely to service-connected disabilities by the United States~~
12 ~~Department of Veterans Affairs has been rated as having a 90% or greater service-connected~~
13 ~~disability by the United States Department of Veterans Affairs or meets the eligibility requirements~~
14 ~~for individual unemployability according to the disability ratings of the Department of Veterans~~
15 ~~Affairs as a result of a service-related injury suffered since September 11, 2001.~~

16 (4) "Eligible motor vehicle" means a motor vehicle on which the ad valorem property tax
17 has been paid for the taxable year by the eligible taxpayer, and which is a motor vehicle as defined
18 in this article.

19 (5) "Eligible widowed spouse" means the unmarried surviving spouse of a disabled veteran
20 taxpayer who had previously received the disabled veteran real property tax credit authorized by

21 §11-13MM-4 of this code.

22 (6) "Flow-through entity", "conduit entity", or "pass through entity" means an S Corporation,
23 partnership, limited partnership, limited liability partnership, or limited liability company. The term
24 "flow-through entity", "conduit entity", or "pass through entity" includes a publicly traded
25 partnership as that term is defined in section 7704 of the Internal Revenue Code that has equity
26 securities registered with the Securities and Exchange Commission under section 12 of Title I of
27 the Securities Exchange Act of 1934, 15 U.S.C. § 781: *Provided*, That a publicly traded
28 partnership as defined in section 7704 of the Internal Revenue Code having equity securities
29 registered with the Securities and Exchange Commission under section 12 of Title I of the
30 Securities Exchange Act of 1934, 15 U.S.C. § 781, and any other person or entity that is treated as
31 a C corporation for federal income tax purposes, shall be treated as a corporation taxable under
32 article §11-24-1 *et seq.* of this code for purposes of this article.

33 (7) "Motor Vehicle" means the following class of vehicles defined in §17A-10-1 of this code:
34 Class A, Class B, Class G, Class H, Class T, Class V, Class X, and all-terrain vehicles and utility
35 terrain vehicles as defined in §20-15-2 of this code.

36 (8) "Person" means and includes an individual, a trust, estate, partnership, pass through
37 entity, association, company, or corporation.

38 (9) "Personal property" shall have the same meaning as in §11-5-1 *et seq.* of this code:
39 *Provided*: That, for the purposes of this article, the term "personal property" shall not include a
40 working interest in any oil, natural gas, or natural gas liquid producing property or any property of a
41 public service company.

42 (10) "Personal property taxes paid" means the aggregate of regular levies, excess levies,
43 and bond levies extended against personal property that are paid during the calendar year and
44 determined after any application of any discount for early payment of taxes. "Personal property
45 taxes paid" does not include any untimely ad valorem property tax paid, or any payment of
46 delinquent ad valorem property tax, or payment of "back tax" ad valorem property taxes, or any

47 penalty or interest for late payment of property taxes.

48 (11) "Public service company" means a corporation or other business entity which delivers
49 services considered essential to the public interest that are regulated by the applicable federal or
50 state regulatory body, including, but not limited to, businesses furnishing electricity, natural gas,
51 telecommunications, and water, and those transporting personal property or passengers,
52 including, but not limited to, airlines, railroads, trucking, and bus companies, and which are
53 centrally assessed by the state for property tax purposes.

54 (12) "Real property taxes paid" means the aggregate of regular levies, excess levies, and
55 bond levies that are paid during the calendar year and determined after any application of any
56 discount for early payment of taxes. "Real property taxes paid" does not include any untimely ad
57 valorem property tax paid, or any payment of delinquent ad valorem property tax, or payment of
58 "back tax" ad valorem property taxes, or any penalty or interest for late payment of property taxes.

NOTE: The purpose of this bill is to clarify the definition of a disabled veteran taxpayer.

Strike-throughs indicate language that would be stricken from a heading or the present law
and underscoring indicates new language that would be added.
