Senate Bill 786

[Passed March 12, 2026; in effect from passage]

1 AN ACT making a supplementary appropriation of public moneys out of the Treasury to the
2 Department of Human Services, Child Support Enforcement Fund, fund 5094, fiscal year
3 2026, organization 0511, by decreasing and increasing existing items of appropriation for
4 the fiscal year ending June 30, 2026.

1 WHEREAS, The Governor has established that there now remains an unappropriated
2 balance in the Department of Human Services, Child Support Enforcement Fund, fund 5094, fiscal
3 year 2026, organization 0511, that is available for expenditure during the fiscal year ending June
4 30, 2026, which is hereby appropriated by the terms of this supplementary appropriation bill;
5 therefore

Be it enacted by the Legislature of West Virginia:

1 That the total appropriation for the fiscal year ending June 30, 2026, to fund 5094, fiscal
2 year 2026, organization 0511, be supplemented and amended by decreasing an existing item of
3 appropriation as follows:
