### **Senate Bill 816**

By Senators Smith (Mr. President) and Woelfel

(By Request of the Executive)

[Introduced February 6, 2026; referred  
to the Committee on Finance]

1 A BILL supplementing and amending the appropriations of public moneys out of the Treasury from  
2 the balance of moneys remaining as an unappropriated surplus balance in the State Fund,  
3 General Revenue, to the Department of Homeland Security, Department of Homeland  
4 Security, Office of the Secretary, fund 0430, fiscal year 2026, organization 0601, by  
5 supplementing and amending the appropriations for the fiscal year ending June 30, 2026,  
6 by adding a new item of appropriation.

1 WHEREAS, The Governor submitted the Executive Budget Document to the Legislature  
2 on January 14, 2026, containing a statement of the State Fund, General Revenue, setting forth  
3 therein the cash balance as of July 1, 2025, and further included the estimate of revenue for the  
4 fiscal year 2026, less net appropriation balances forwarded and regular and surplus  
5 appropriations for the fiscal year 2026, and further included recommended expirations to the  
6 unappropriated surplus balance of the State Fund, General Revenue; and

1 WHEREAS, It appears from the Governor's Statement of the State Fund, General  
2 Revenue, there now remains an unappropriated surplus balance in the Treasury which is available  
3 for appropriation during the fiscal year ending June 30, 2026; therefore

*Be it enacted by the Legislature of West Virginia:*

1 That the total appropriation for the fiscal year ending June 30, 2026, to fund 0430, fiscal  
2 year 2026, organization 0601, be supplemented and amended adding a new item of appropriation  
3 as follows:
