### **Senate Bill 831**

BY SENATORS SMITH (MR. PRESIDENT) AND WOELFEL

[Passed March 12, 2026; in effect from passage]



1 AN ACT making a supplementary appropriation of federal funds out of the Treasury to the  
2 Department of Human Services – Community Mental Health Services, fund 8794, fiscal  
3 year 2026, organization 0511, by decreasing and increasing the appropriations for the  
4 fiscal year ending June 30, 2026.

1 WHEREAS, The Governor has established the availability of federal funds for expenditure  
2 in the fiscal year ending June 30, 2026, which is hereby appropriated by the terms of this  
3 supplementary appropriation bill; therefore

*Be it enacted by the Legislature of West Virginia:*

1 That the total appropriation for the fiscal year ending June 30, 2026, to fund 8794, fiscal  
2 year 2026, organization 0511, be supplemented and amended by decreasing an existing item of  
3 appropriation as follows:
