### **Senate Bill 848**

[Introduced February 9, 2026; referred  
to the Committee on Finance]

1 A BILL supplementing and amending the appropriations of public moneys out of the Treasury from  
 2 the balance of moneys remaining as an unappropriated surplus balance in the State Fund,  
 3 General Revenue, to the Department of Homeland Security, Division of Corrections and  
 4 Rehabilitation – Correctional Units, fund 0450, fiscal year 2026, organization 0608, by  
 5 supplementing and amending the appropriations for the fiscal year ending June 30, 2026,  
 6 by adding a new item of appropriation.

1 WHEREAS, The Governor submitted the Executive Budget Document to the Legislature  
 2 on January 14, 2026, containing a statement of the State Fund, General Revenue, setting forth  
 3 therein the cash balance as of July 1, 2025, and further included the estimate of revenue for the  
 4 fiscal year 2026, less net appropriation balances forwarded and regular and surplus  
 5 appropriations for the fiscal year 2026, and further included recommended expirations to the  
 6 unappropriated surplus balance of the State Fund, General Revenue; and

1 WHEREAS, It appears from the Governor’s Statement of the State Fund, General  
 2 Revenue, there now remains an unappropriated surplus balance in the Treasury which is available  
 3 for appropriation during the fiscal year ending June 30, 2026; therefore

*Be it enacted by the Legislature of West Virginia:*

1 That the total appropriation for the fiscal year ending June 30, 2026, to fund 0450, fiscal  
 2 year 2026, organization 0608, be supplemented and amended by adding a new item of  
 3 appropriation as follows:
