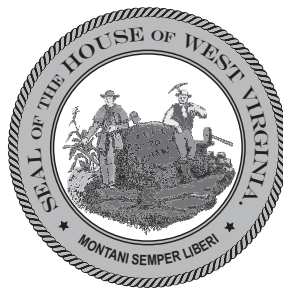

### THIRTEENTH DAY

[DELEGATE HANSHAW, MR. SPEAKER, IN THE CHAIR]

The House of Delegates was called to order by the Honorable Roger Hanshaw, Speaker.

Prayer was offered and the House was led in recitation of the Pledge of Allegiance.

## **Special Calendar**

### **Third Reading**

**Com. Sub. for H. B. 2530**, Relating to the extension of the expiration of temporary registration plates from sixty days to ninety days; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (**Roll No. 21**), and there were—yeas 98, nays none, absent and not voting 2, with the absent and not voting being as follows:

Absent and Not Voting: Anderson and Ward.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (Com. Sub. for H. B. 2530) passed.

*Ordered*, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

**H. B. 2533**, Relating to a permanent windshield placard to be valid for the duration of the applicant's life; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (**Roll No. 22**), and there were—yeas 98, nays none, absent and not voting 2, with the absent and not voting being as follows:

Absent and Not Voting: Anderson and Ward.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (H. B. 2533) passed.

### **Second Reading**

**S. B. 128**, Clarifying authority of Governor and Legislature to proclaim and declare state of emergency and preparedness; on second reading, coming up in regular order, was read a second time.

At the request of Delegate Householder, and by unanimous consent, the bill was advanced to third reading with amendments pending and the right to amend, and the rule was suspended to permit the offering and consideration of amendments on that reading.

**H. B. 2310**, Provide the Division of Motor Vehicles authority to develop an "Antique Fleet" program so that multiple antique motor vehicles may utilize a single registration plate; on second reading, coming up in regular order, was read a second time and ordered to engrossment and third reading.

**H. B. 2564**, Repeal of administrative hearing procedures for DUI offenses; on second reading, coming up in regular order, was read a second time and ordered to engrossment and third reading.

**H. B. 2602**, Reestablishing certain specialized school service personnel classifications; on second reading, coming up in regular order, was read a second time and ordered to engrossment and third reading.
