[DELEGATE HANSHAW, MR. SPEAKER, IN THE CHAIR]

The House of Delegates was called to order by the Honorable Roger Hanshaw, Speaker.

In lieu of Prayer and the recitation of the Pledge of Allegiance, the John Marshall Fife and Drum Corps performed "Amazing Grace", "The Star Spangled Banner", and "The West Virginia Hills".

The Clerk proceeded to read the Journal of Tuesday, January 31, 2023, being the first order of business, when the further reading thereof was dispensed with and the same approved.

Delegate Summers, Chair of the Committee on Health and Human Resources, submitted the following report, which was received:

Your Committee on Health and Human Resources has had under consideration:

H. B. 3141, Relating to the practice of dentistry,

And reports the same back with the recommendation that it do pass.

Delegate Storch, Chair of the Committee on Pensions and Retirement, submitted the following report, which was received:

Your Committee on Pensions and Retirement has had under consideration:

H. B. 2893, Establishing a one-time bonus payment for certain retirants,

And reports the same back with the recommendation that it do pass, but that it first be referred to the Committee on Finance.

Third Reading

S. B. 207, Relating to state allocation of funding to regional councils; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 61), and there were—yeas 99, nays none, absent and not voting 1, with the absent and not voting being as follows:

Absent and Not Voting: Clark.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (S. B. 207) passed.

Delegate Clark, who was absent on Roll No. 61, noted to the Clerk that he would have voted "Yea" thereon.

Ordered, That the Clerk of the House communicate to the Senate the action of the House of Delegates.

Com. Sub. for H. B. 2596, To modify when a nonresident student's transfer may be denied; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 62), and there were—yeas 99, nays none, absent and not voting 1, with the absent and not voting being as follows:

Absent and Not Voting: Clark.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (Com. Sub. for H. B. 2596) passed.

Delegate Clark, who was absent on Roll No. 62, noted to the Clerk that he would have voted "Yea" thereon.

On motion of Delegate Ellington, the title of the bill was amended to read as follows:

Com. Sub. for H. B. 2596 – "A Bill to amend and reenact §18-5-16 of the Code of West Virginia, 1931, as amended, relating to open enrollment; clarifying the circumstances in which a county board shall permit the transfer of resident and nonresident students; amending provisions pertaining to the contents of county board of education policies for open enrollment; modifying the process for transfer application denials and appeals; and requiring county boards and the State Department of Education to report annually on the number of transfer approvals and denials made pursuant to open enrollment policies."

Ordered, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

H. B. 2613, Relating to the administration of anesthetics; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 63), and there were—yeas 77, nays 21, absent and not voting 2, with the nays and the absent and not voting being as follows:

Nays: Cannon, Capito, Criss, Dillon, Ellington, Foggin, Hanna, Heckert, Keaton, Kirby, Kump, Nestor, Riley, Ross, Skaff, Steele, Storch, Vance, Walker, Westfall and Willis.

Absent and Not Voting: Bridges and Linville.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (H. B. 2613) passed.

Delegate Householder moved that the bill take effect from its passage.

On this question, the yeas and nays were taken **(Roll No. 64)**, and there were—yeas 92, nays 6, absent and not voting 2, with the nays and the absent and not voting being as follows:

Nays: Dillon, Kirby, Kump, Nestor, Steele and Vance.

Absent and Not Voting: Bridges and Linville.

So, two thirds of the members elected to the House of Delegates having voted in the affirmative, the Speaker declared the bill (H. B. 2613) takes effect from its passage.

Ordered, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

Com. Sub. for H. B. 2870, Correcting a reference relating to siting certificates for certain electric generating facilities; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 65), and there were—yeas 98, nays 1, absent and not voting 1, with the nays and the absent and not voting being as follows:

Nays: Vance.

Absent and Not Voting: Mallow.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (Com. Sub. for H. B. 2870) passed.

Ordered, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

Com. Sub. for H. B. 3061, Relating to updating the authority of the Foster Care Ombudsman; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (**Roll No. 66**), and there were—yeas 100, nays none, absent and not voting none.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (Com. Sub. for H. B. 3061) passed.

Delegate Householder moved that the bill take effect from its passage.

On this question, the yeas and nays were taken (Roll No. 67), and there were—yeas 100, nays none, absent and not voting none.
