#### TWENTY-EIGHTH DAY

[DELEGATE HANSHAW, MR. SPEAKER, IN THE CHAIR]

**H. B. 2611**, To remove certain territorial limitations on a banking institution's ability to offer messenger services or mobile banking facilities; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 82), and there were—yeas 98, nays none, absent and not voting 2, with the absent and not voting being as follows:

Absent and Not Voting: Smith and Steele.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (H. B. 2611) passed.

*Ordered*, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

**Com. Sub. for H. B. 2789**, Removing birthing centers from certificate of need; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 83), and there were—yeas 73, nays 26, absent and not voting 1, with the nays and the absent and not voting being as follows:

Nays: Cannon, Capito, Chiarelli, Criss, Ferrell, Hanna, Hansen, Holstein, Hornbuckle, Hornby, Hott, Keaton, Kirby, Martin, Maynor, Nestor, Reynolds, Rowe, Sheedy, Steele, Storch, Vance, Walker, Ward, Westfall and Willis.

Absent and Not Voting: Smith.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (Com. Sub. for H. B. 2789) passed.

Delegate Kimble moved that the bill take effect from its passage.

On this question, the yeas and nays were taken (**Roll No. 84**), and there were—yeas 84, nays 14, absent and not voting 2, with the nays and the absent and not voting being as follows:

Nays: Chiarelli, Ferrell, Hanna, Hansen, Hott, Kirby, Martin, Nestor, Rowe, Steele, Vance, Walker, Ward and Westfall.

Absent and Not Voting: Cooper and Smith.

So, two thirds of the members elected to the House of Delegates having voted in the affirmative, the Speaker declared the bill (Com. Sub. for H. B. 2789) takes effect from its passage.

*Ordered*, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

**Com. Sub. for H. B. 3055**, To create a vocational math class for students interested in careers in the trades.; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 85), and there were—yeas 97, nays none, absent and not voting 3, with the absent and not voting being as follows:

Absent and Not Voting: Cooper, Smith and Steele.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (Com. Sub. for H. B. 3055) passed.

*Ordered*, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

#### **Second Reading**

**S. B. 241**, Relating to Patient Brokering Act; on second reading, coming up in regular order, was read a second time.

An amendment was recommended by the Committee on Health and Human Resources, and adopted, on page 2, line 27, by striking subsection (c) in its entirety and inserting a new subsection (c) to read as follows:

"(c) The Office of the Inspector General shall develop a tool that facilitates the submission of complaints. The Office of the Inspector General shall investigate complaints and enforce the provisions of this article."

The bill was then ordered to third reading.
