FORTY-FIRST DAY

The House of Delegates was called to order by the Honorable Roger Hanshaw, Speaker.

Prayer was offered and the House was led in recitation of the Pledge of Allegiance.

Special Calendar

Third Reading

Com. Sub. for S. B. 89, Requiring hospitals to staff qualified personnel to perform sexual assault forensic exams; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (**Roll No. 182**), and there were—yeas 94, nays none, absent and not voting 6, with the absent and not voting being as follows:

Absent and Not Voting: Bridges, Jeffries, Kirby, Linville, Westfall and Young.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (Com. Sub. for S. B. 89) passed.

The question being on the passage of the bill, the yeas and nays were taken (**Roll No. 183**), and there were—yeas 93, nays 1, absent and not voting 6, with the nays and the absent and not voting being as follows:

Com. Sub. for H. B. 2848, Water and Sewer Operator licensing reciprocity; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (**Roll No. 184**), and there were—yeas 94, nays none, absent and not voting 6, with the absent and not voting being as follows:

Absent and Not Voting: Bridges, Jeffries, Kirby, Linville, Westfall and Young.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (Com. Sub. for H. B. 2848) passed.

Ordered, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

Com. Sub. for H. B. 3101, Relating to notification of breast density; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (**Roll No. 185**), and there were—yeas 94, nays none, absent and not voting 6, with the absent and not voting being as follows:

Absent and Not Voting: Bridges, Jeffries, Kirby, Linville, Westfall and Young.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (Com. Sub. for H. B. 3101) passed.

Ordered, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

Com. Sub. for H. B. 3147, To create the Upper Ohio Valley Trail Network; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (**Roll No. 186**), and there were—yeas 92, nays 2, absent and not voting 6, with the nays and the absent and not voting being as follows:

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (Com. Sub. for H. B. 3147) passed.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (H. B. 3215) passed.

H. B. 3428, Relating to the West Virginia Business Ready Sites Program; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (**Roll No. 188**), and there were—yeas 89, nays 5, absent and not voting 6, with the nays and the absent and not voting being as follows:

Nays: Dean, Dillon, McGeehan, C. Pritt and Vance.

Absent and Not Voting: Bridges, Jeffries, Kirby, Linville, Westfall and Young.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (H. B. 3428) passed.

Ordered, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

Delegates Hornbuckle and Walker moved to amend the bill on page 37, section 5b, line 57, following the words "study areas" by striking out the period, inserting a colon, and the following proviso:

"*Provided*, That state institutions of higher education may establish residence halls where deadly weapons are prohibited to allow students that do not what to reside in residences where deadly weapon residences are authorized may reside."

The question being on adoption of the amendment, the same was put and did not prevail.

Delegates Hansen and Walker moved to amend the bill on page 39, section 5b, lines 102 and 103, by striking out the words "or §61-7-4a".

The question being on adoption of the amendment, the same was put and did not prevail.

There being no further amendments, the bill was ordered to third reading.

H. B. 2283, Relating to authorized expenditures of revenues from certain state funds for fire departments; on second reading, coming up in regular order, was read a second time and ordered to engrossment and third reading.

Com. Sub. for H. B. 2498, To require medication-assisted treatment programs to have written policies concerning community relations; on second reading, coming up in regular order, was read a second time.

On motion of Delegate Nestor, the bill was amended on page 1, by striking subsection (d) in its entirety and inserting in lieu thereof a new subsection (d) to read as follows:

<u>"(d) At least 60 days prior to location or re-location, a medication-assisted treatment program</u> shall publish a Class 1 legal advertisement notifying the residents of the county of its desired location of its intent to begin its operation within. Notice shall also be communicated to the desired location's county commissioners and to the mayor of every municipality within the county by certified mail at least 60 days prior to the program's location or re-location.

(1) In its correspondence to the county commissioners and mayors, a medication-assisted treatment program shall describe its reasons for selecting the location, and shall detail its policies for ensuring that its activities will not disrupt any public or private function of the county or of any municipality therein contained;

(2) Not later than 30 days following receipt of notification, the county commission and the municipality wherein the treatment facility is intended to be located shall convene to discuss whether such location should be permitted. A medication-assisted treatment program may not be allowed locate or relocate to a new location without the express approval of the county commission and the municipality wherein it will be located."

The bill was then ordered to engrossment and third reading.

Com. Sub. for H. B. 2538, Requiring usage of child welfare information technology systems; on second reading, coming up in regular order, was read a second time and ordered to engrossment and third reading.

Rev. Com. Sub. for H. B. 3110, Relating to funding the Office of Oil and Gas in the Department of Environmental Protection; on second reading, coming up in regular order, was read a second time.

Delegate Hansen moved to amend the bill on page 8, section 2, lines 55 and 56 by striking out the words "of the first 400 wells" and inserting in lieu thereof the words "for each well";

And,

On page 8, Section 2, lines 60 and 61 by striking out the words "of the first 400 wells" and inserting in lieu thereof the words "for each well";

And

On page 9, Section 2, lines 66 and 67 by striking out the words "of the first 4,000 wells" and inserting in lieu thereof the words "for each well".

The question being on adoption of the amendment, the same was put and did not prevail.

The bill was then ordered to engrossment and third reading.

Com. Sub. for H. B. 3148, Relating to financing municipal policemen's and firemen's pension and relief funds; on second reading, coming up in regular order, was read a second time and ordered to engrossment and third reading.

H. B. 3166, To permit a hospital to hold a patient experiencing a psychiatric emergency for up to 72 hours; on second reading, coming up in regular order, was read a second time and ordered to engrossment and third reading.

Com. Sub. for H. B. 3233, Relating generally to uniform and equipment allowances for the National Guard; on second reading, coming up in regular order, was read a second time and ordered to engrossment and third reading.

Com. Sub. for H. B. 3278, Relating to the practice of optometry; on second reading, coming up in regular order, was read a second time and ordered to engrossment and third reading.

H. B. 3353, Relating to the limitations on the financial relationships with foreign entities that have values antithetical to those of the State of West Virginia; on second reading, coming up in regular order, was reported by the Clerk.

At the request of Delegate Householder, and by unanimous consent, the bill was postponed one day.

H. B. 3376, Relating to changing the term teacher in residence to clinical teacher of record; on second reading, coming up in regular order, was read a second time and ordered to engrossment and third reading.

H. B. 3441, Revising the training requirements for members of the Higher Education Policy Commission, Council for Community and Technical College Education and the institutional governing boards; on second reading, coming up in regular order, was read a second time and ordered to engrossment and third reading.

H. B. 3547, Increasing the number of personal leave days that county board of education employees may use; on second reading, coming up in regular order, was read a second time.

Delegate Foggin moved to amend the bill on page 1, section §18A-4-14, line 17, after the word "notice" by striking the remainder of the sentence.

On the adoption of the amendment, the yeas and nays were demanded, which demand was sustained.

The bill was then ordered to engrossment and third reading.

On motion of Delegate Clark, the bill was amended on page 1, section §18A-4-14, line 5, after the word "employee" by removing the strike-through of the word "shall" and on line 6, by deleting the underscored word "may".
