[DELEGATE HANSHAW, MR. SPEAKER, IN THE CHAIR]

The House of Delegates was called to order by the Honorable Roger Hanshaw, Speaker.

Prayer was offered and the House was led in recitation of the Pledge of Allegiance.

Your Committee on Finance has had under consideration:

**Com. Sub. for H. B. 5065**, Regarding continuing education requirements and compensation of Guardians Ad Litem.

And reports the same back, with amendment, with the recommendation that it do pass, as amended.

Delegate Criss, Chair of the Committee on Finance, submitted the following report, which was received:

**H. B. 5441**, Relating to raising the threshold from \$25,000 to \$50,000 for the requirement of bids for municipal public works projects,

B. 5223 - "A Bill to amend the Code of West Virginia, 1931, as amended, by adding thereto a new section, designated §5B-2-22, relating to creating the Southern Coalfield Resiliency and Revitalization Program for a period of five years; defining terms; finding that there are challenges facing the counties in which the southern coalfields are located; establishes the Southern Coalfield Resiliency and Revitalization Program; provides that the program will terminate five years after this section goes into effect; establishing revitalization council to organize and prioritize state resources and technical assistance for these counties: directing revitalization council to develop strategies to stimulate economic activity in and around the municipalities in Boone, Logan, McDowell, Mingo, and Wyoming counties in coordination with certain contributing partners to the extent possible; directing revitalization council to annually report to the Governor and the Legislature; directing Department of Economic Development and revitalization council to facilitate economic development incentives for the counties in which the southern coalfields are located; authorizing Department of Economic Development or other state body to provide state property and equipment to businesses investing in the counties of the southern coalfield area of the state at a reduced cost; providing that the program shall prioritize and West Virginia's natural resources, industries, business, raw materials, agricultural commodities, and reliable forms of energy."

#### ARTICLE III. BILL OF RIGHTS.

#### §3-23. Protection from medically-assisted suicide.

No physician or health care provider in the State of West Virginia shall participate in the practice of medically-assisted suicide, euthanasia, or mercy killing of a person. Nothing in this section prohibits the administration or prescription of medication for the purpose of alleviating pain or discomfort while the patient's condition follows its natural course; nor does anything in this section prohibit the withholding or withdrawing of life-sustaining treatment, as requested by the patient or the patient's decision-maker, in accordance with State law, so long as the intention is not to kill the patient.

Resolved further, That in accordance with the provisions of article eleven, chapter three of the Code of West Virginia, 1931, as amended, such amendment is hereby numbered "Amendment 1" and designated as the "Protection of persons from medically-assisted suicide" and the purpose of the proposed amendment is summarized as follows: "The purpose of this amendment is to recognize that West Virginians shall not have medically-assisted suicide or euthanasia forced upon them by prohibiting such actions."

- **S. B. 606**, Relating to Natural Resources Police Officers Retirement System; on second reading, coming up in regular order, was read a second time and ordered to third reading.
- **S. B. 607**, Clarifying Municipal Police Officers and Firefighters Retirement System surviving spouse benefits; on second reading, coming up in regular order, was read a second time and ordered to third reading.
- **H. B. 4654**, Removing bona fide schools, public libraries, and museums from the list of exemptions from criminal liability relating to distribution and display to minor of obscene matter; on second reading, coming up in regular order, was read a second time.

At the request of Delegate Kimble, and by unanimous consent, the bill was advanced to third reading with the right to amend, and the rule was suspended to permit the offering and consideration of amendments on that reading.

**Com. Sub. for H. B. 4807**, Establishing limitations on billing practices of Internet or telecommunications providers that fail to provide subscribed customers service for five or more days; on second reading, coming up in regular order, was read a second time.

On motion of Delegate Hillenbrand, the bill was amended on page 2, section 111, line 27, immediately following the word "shall" by inserting the following: "seek a resolution of the violation and may".

The bill was then ordered to engrossment and third reading.

**Com. Sub. for H. B. 4809**, Health Care Sharing Ministries Freedom to Share Act; on second reading, coming up in regular order, was read a second time and ordered to engrossment and third reading.

At the request of Delegate Kimble, and by unanimous consent, the bill was advanced to third reading with amendment pending and the right to amend, and the rule was suspended to permit the offering and consideration of amendments on that reading.

- **H. B. 5128**, Directing transfer of moneys into fire protection funds at the end of each year; on second reading, coming up in regular order, was read a second time and ordered to engrossment and third reading.
- **Com. Sub. for H. B. 5137**, Relating to requiring the State Auditor to conduct audits of all county boards of education; on second reading, coming up in regular order, was reported by the Clerk.

At the request of Delegate Kimble, and by unanimous consent, the bill was postponed one day.

- **H. B. 5170**, Increasing the size of matching grants for local economic development from \$30,000 to \$50,000; on second reading, coming up in regular order, was read a second time and ordered to engrossment and third reading.
- **Com. Sub. for H. B. 5294**, Revising state law regulating farm wineries; on second reading, coming up in regular order, was read a second time and ordered to engrossment and third reading.
- **Com. Sub. for H. B. 5319**, Creating the offense of exposing a law-enforcement officer, probation officer, parole officer, courthouse security officer, correctional officer, the State Fire Marshal, a deputy or assistant fire marshal, firefighter, or emergency medical service personnel to fentanyl; on second reading, coming up in regular order, was read a second time.

On motion of Delegates Howell and Kelly, the bill was amended by striking everything after the enacting clause and inserting in lieu thereof the following:

#### "ARTICLE 5. CRIMES AGAINST PUBLIC JUSTICE.

#### §61-5-17b. Exposing a person to fentanyl; penalties.

(a) Notwithstanding any provision of this code to the contrary, any person who commits any act in violation of any of the provisions of §60A-4-401 et seq. of this code or any provision of §61-5-8 of this code and thereby proximately causes the death of another person as a result of exposure to fentanyl used or possessed in the commission of the act is guilty of a felony, and upon conviction thereof, shall be imprisoned in a state correctional facility for a term of 15 years to life.

(b) Notwithstanding any provision of this code to the contrary, any person who commits any act in violation of any of the provisions of §60A-4-401 et seq. of this code or any provision of §61-5-8 of this code and thereby proximately causes the bodily injury of another person as a result of exposure to fentanyl used or possessed in the commission of the act is guilty of a felony, and upon conviction thereof, shall be imprisoned in a state correctional facility for a term of not less than three nor more than 15 years.

#### (c) For purposes of this section:

- (1) 'Bodily injury' means substantial physical pain, illness, or any impairment of physical condition, including, but not limited to, loss of consciousness or other symptoms of a fentanyl overdose which result in the immediate administration of an opioid antagonist medication.
- (2) 'Death' means the death of any exposed person which ensues within one year as a proximate result of a bodily injury received in violation of this section.
- (3) 'Exposure' includes without limitation skin contact, inhalation, ingestion, or contact with a needlestick or a mucus membrane, including without limitation the mouth, eyes, or nose. Proof of exposure shall be based on a confirmed positive test for fentanyl administered by a medical professional immediately following the death or bodily injury of the exposed person.
- (4) 'Fentanyl' refers to the substance identified in §60A-2-206 of this code, and any analog or derivative thereof.
- (d) The offenses set forth in this section shall be in addition to any other offenses set forth in this code."

The bill was then ordered to engrossment and third reading.

- **H. B. 5337**, Establishing the legislative oversight committee of the Division of Corrections and Rehabilitation; on second reading, coming up in regular order, was read a second time and ordered to engrossment and third reading.
