[DELEGATE HANSHAW, MR. SPEAKER, IN THE CHAIR]

The House of Delegates was called to order by the Honorable Roger Hanshaw, Speaker.

Prayer was offered and the House was led in recitation of the Pledge of Allegiance.

The Clerk proceeded to read the Journal of Tuesday, February 27, 2024, being the first order of business, when the further reading thereof was dispensed with and the same approved.

Reordering of the Calendar

Pursuant to the action of the Committee on Rules, Delegate Householder announced that Com. Sub. for S. B. 331, Com. Sub. for S. B. 603, S. B. 712 and H. B. 5245, on Third Reading, Special Calendar, had been transferred to the House Calendar; and Com. Sub. for S. B. 714, on Second Reading, Special Calendar, had been transferred to the House Calendar.

Committee Reports

Delegate Linville, Chair of the Committee on Technology and Infrastructure, submitted the following report, which was received:

Your Committee on Technology and Infrastructure has had under consideration:

S. B. 173, Modifying certain guidelines for motor vehicle dealers, distributors, wholesalers, and manufacturers.

S. B. 802, Updating consumer credit and protection laws on certain agricultural vehicles and equipment,

Unanimous consent was obtained to move all items (Com. Sub. for S. C. R. 4, S. C. R. 21, Com. Sub. for S. C. R. 22, S. C. R. 23, S. C. R. 25 and Com. Sub. for S. C. R. 26) on Unfinished Business to the foot of all bills.

Third Reading

Com. Sub. for H. B. 4010, Relating to providing notification of utility service disruption to its' customers; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 344), and there were—yeas 93, nays none, absent and not voting 7, with the absent and not voting being as follows:

Absent and Not Voting: Bridges, Ferrell, Hillenbrand, Holstein, Linville, Shamblin and Steele.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (Com. Sub. for H. B. 4010) passed.

Ordered, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

Com. Sub. for H. B. 4258, To require railroad companies to provide alternative entry and exit ways; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 345), and there were—yeas 94, nays none, absent and not voting 6, with the absent and not voting being as follows:

Absent and Not Voting: Bridges, Ferrell, Hillenbrand, Holstein, Linville and Steele.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (Com. Sub. for H. B. 4258) passed.

Ordered, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

H. B. 4305, Relating to granting in-state resident status to economic development participants; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 346), and there were—yeas 85, nays 11, absent and not voting 4, with the nays and the absent and not voting being as follows:

Nays: Coop-Gonzalez, Dillon, Fast, Kimble, Kirby, Longanacre, Martin, McGeehan, C. Pritt, Vance and Ward.

Absent and Not Voting: Bridges, Ferrell, Hillenbrand and Steele.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (H. B. 4305) passed.

Ordered, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

Com. Sub. for H. B. 4313, Creating the Parents' Bill of Rights; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 347), and there were—yeas 83, nays 14, absent and not voting 3, with the nays and the absent and not voting being as follows:

Nays: Fehrenbacher, Fluharty, Garcia, Griffith, Hamilton, Hansen, Hornbuckle, Lewis, Pushkin, Rowe, Stephens, Williams, Winzenreid and Young.

Absent and Not Voting: Bridges, Hillenbrand and Steele.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (Com. Sub. for H. B. 4313) passed.

Ordered, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

Com. Sub. for H. B. 4408, To allow the development of a specialized intermediate care facility for individuals with intellectual and developmental disabilities; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the year and nays were taken (Roll No. 348), and there were—year 96, nays none, absent and not voting 4, with the absent and not voting being as follows:

Absent and Not Voting: Bridges, Hillenbrand, McGeehan and Steele.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (Com. Sub. for H. B. 4408) passed.

Ordered, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

Com. Sub. for H. B. 4591, Give a 10-day right to appeal to the Supreme Court of Appeals a Secretary of State decision to not certify a candidacy; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 349), and there were—yeas 96, nays none, absent and not voting 4, with the absent and not voting being as follows:

Absent and Not Voting: Bridges, Hillenbrand, McGeehan and Steele.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (Com. Sub. for H. B. 4591) passed.

Delegate Householder moved that the bill take effect January 1, 2025.

Com. Sub. for H. B. 4709, Relating to vocational and technical education programs; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 351), and there were—yeas 97, nays none, absent and not voting 3, with the absent and not voting being as follows:

Absent and Not Voting: Hillenbrand, McGeehan and Steele.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (Com. Sub. for H. B. 4709) passed.

Ordered, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

H. B. 4721, Require Surveyors to offer to record surveys of property; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 352), and there were—yeas 96, nays none, absent and not voting 4, with the absent and not voting being as follows:

Absent and Not Voting: Hillenbrand, McGeehan, Steele and Willis.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (H. B. 4721) passed.

Ordered, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

Com. Sub. for H. B. 4722, Create a credit against the severance tax to encourage private companies to make infrastructure improvements to highways, roads and bridges in this state; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 353), and there were—yeas 94, nays 3, absent and not voting 3, with the nays and the absent and not voting being as follows:

Nays: Hansen, Kimble and Pushkin.

Absent and Not Voting: Hillenbrand, Steele and Young.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (Com. Sub. for H. B. 4722) passed.

Ordered, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

Com. Sub. for H. B. 4734, To provide a pay increase to state correctional workers in West Virginia; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 354), and there were—yeas 99, nays none, absent and not voting 1, with the absent and not voting being as follows:

Absent and Not Voting: Steele.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (Com. Sub. for H. B. 4734) passed.

Ordered, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

Com. Sub. for H. B. 4784, Establish setback from residential properties for new windmills being constructed throughout the state; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 355), and there were—yeas 84, nays 10, absent and not voting 6, with the nays and the absent and not voting being as follows:

Nays: Bridges, T. Clark, Garcia, Hamilton, Hansen, Pushkin, Rowe, Vance, Williams and Young.

Absent and Not Voting: Foster, Hornbuckle, Linville, Longanacre, Mallow and Steele.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (Com. Sub. for H. B. 4784) passed.

Ordered, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

Com. Sub. for H. B. 4812, Capping amount of moneys to third party vendors who collect business and occupation taxes on behalf of cities; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 356), and there were—yeas 93, nays 6, absent and not voting 1, with the nays and the absent and not voting being as follows:

Nays: Dittman, Fast, Hansen, Jennings, Pushkin and Shamblin.

Absent and Not Voting: Steele.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (Com. Sub. for H. B. 4812) passed.

Ordered, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

H. B. 4822, Creating the Certified Sites and Development Readiness Program; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 357), and there were—yeas 86, nays 13, absent and not voting 1, with the nays and the absent and not voting being as follows:

Nays: Bridges, Coop-Gonzalez, Dean, Dillon, Foster, Kimble, Kirby, Longanacre, McGeehan, C. Pritt, Ridenour, Steele and Vance.

Absent and Not Voting: Hardy.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (H. B. 4822) passed.

Ordered, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

Com. Sub. for H. B. 4883, Relating to increasing annual salaries of certain employees of the state; on third reading, coming up in regular order, was read a third time.

Delegates Barnhart, Campbell, Dillon, Dittman, Foggin, Holstein, Householder, Kirby, Longanacre, E. Pritt, Pushkin, Shamblin, Stephens, Toney, Ward and Westfall requested to be excused from voting under the provisions of House Rule 49.

The Speaker ruled that the Delegates were members of a class of persons possibly to be affected and did not excuse the Members from voting.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 358), and there were—yeas 99, nays none, absent and not voting 1, with the absent and not voting being as follows:

Absent and Not Voting: Hardy.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (Com. Sub. for H. B. 4883) passed.

Ordered, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

Com. Sub. for H. B. 4919, Relating to the Promise Scholarship; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 359), and there were—yeas 97, nays none, absent and not voting 3, with the absent and not voting being as follows:

Absent and Not Voting: Hardy, Ward and Willis.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (Com. Sub. for H. B. 4919) passed.

Ordered, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

H. B. 4945, Relating generally to the Hope Scholarship Program; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken **(Roll No. 360)**, and there were—yeas 76, nays 21, absent and not voting 3, with the nays and the absent and not voting being as follows:

Nays: Anderson, Bridges, Dean, Dillon, Ferrell, Fluharty, Garcia, Griffith, Hamilton, Hansen, Hornbuckle, Kirby, Lewis, E. Pritt, Pushkin, Ross, Rowe, Stephens, Toney, Williams and Young.

Absent and Not Voting: Hillenbrand, Longanacre and Mazzocchi.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (H. B. 4945) passed.

Ordered, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

Com. Sub. for H. B. 4956, Creating the Oral Health and Cancer Rights Act; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 361), and there were—yeas 96, nays 1, absent and not voting 3, with the nays and the absent and not voting being as follows:

Nays: Coop-Gonzalez.

Absent and Not Voting: Criss, Hansen and Longanacre.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (Com. Sub. for H. B. 4956) passed.

Ordered, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

Com. Sub. for H. B. 4975, Relating to establishing a foster parent information system; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 362), and there were—yeas 100, nays none, absent and not voting none.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (Com. Sub. for H. B. 4975) passed.

Delegate Householder moved that the bill take effect from its passage.

On this question, the yeas and nays were taken (**Roll No. 363**), and there were—yeas 97, nays none, absent and not voting 3, with the absent and not voting being as follows:

Absent and Not Voting: Bridges, Moore and E. Pritt.

So, two thirds of the members elected to the House of Delegates having voted in the affirmative, the Speaker declared the bill (Com. Sub. for H. B. 4975) takes effect from its passage.

Ordered, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

Com. Sub. for H. B. 5077, Establishing residency requirements for candidates seeking nomination and election to United States Congress; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 364), and there were—yeas 97, nays none, absent and not voting 3, with the absent and not voting being as follows:

Absent and Not Voting: Longanacre, E. Pritt and Ridenour.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (Com. Sub. for H. B. 5077) passed.

Delegate Householder moved that the bill take effect January 1, 2025.

On this question, the yeas and nays were taken (**Roll No. 365**), and there were—yeas 95, nays none, absent and not voting 5, with the absent and not voting being as follows:

Absent and Not Voting: Burkhammer, Longanacre, C. Pritt, E. Pritt and Ridenour.

So, two thirds of the members elected to the House of Delegates having voted in the affirmative, the Speaker declared the bill (Com. Sub. for H. B. 5077) takes effect January 1, 2025.

Ordered, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

Com. Sub. for H. B. 5137, Relating to requiring the State Auditor to conduct audits of all county boards of education; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 366), and there were—yeas 98, nays none, absent and not voting 2, with the absent and not voting being as follows:

Absent and Not Voting: Burkhammer and Longanacre.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (Com. Sub. for H. B. 5137) passed.

On motion of Delegate Phillips, the title of the bill was amended to read as follows:

Com. Sub. for H. B. 5137 - "A Bill to amend and reenact §12-4A-2 of the Code of West Virginia, 1931, as amended, relating to county board of education finances; authorizing the State Auditor to conduct financial assessments of all county boards of education; requiring each county board of education to be audited at least once every six years; providing for assessment requirements; requiring submission of certain reports to the Joint Committee on Government and Finance; requiring use of the Local Government Purchasing Card Program; authorizing the State Auditor to charge certain fees; and providing an effective date."

Ordered, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

Com. Sub. for H. B. 5188, Relating to awards and benefits for duty related disability in the municipal police officers and firefighters retirement system; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 367), and there were—yeas 99, nays none, absent and not voting 1, with the absent and not voting being as follows:

Absent and Not Voting: Burkhammer.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (Com. Sub. for H. B. 5188) passed.

Ordered, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

H. B. 5192, Relating to requiring the Board of Pharmacy to promulgate rules; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 368), and there were—yeas 96, nays 2, absent and not voting 2, with the nays and the absent and not voting being as follows:

Nays: Foster and Vance.

Absent and Not Voting: Burkhammer and Miller.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (H. B. 5192) passed.

Ordered, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

H. B. 5194, Requiring purchases of certain commodities and services from state use program partners; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 369), and there were—yeas 99, nays 1, absent and not voting none, with the nays being as follows:

Nays: Gearheart.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (H. B. 5194) passed.

On motion of Delegate Phillips, the title of the bill was amended to read as follows:

H. B. 5194 – "A Bill to amend and reenact §5A-3-10 of the West Virginia Code, 1931, as amended, relating to requiring certain purchases of commodities and services; requiring the Director of Purchasing to purchase certain goods and services produced and offered for sale by nonprofit workshops; requiring the director to consult with the Committee for the Purchase of Commodities and Services from the Handicapped in making purchasing decisions; and providing that the amendments to this section amended during the 2024 legislative session shall apply to all applicable purchases made on or after July 1, 2025."

Ordered, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

H. B. 5213, To allow Gold Star spouses to receive one free Gold Star vehicle registration for personal use; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 370), and there were—yeas 100, nays none, absent and not voting none.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (H. B. 5213) passed.

Ordered, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

S. C. R. 21, US Army MSG James E. Jackson Jr. Memorial Road; on unfinished business, was reported by the Clerk.

On motion of Delegate Householder, the resolution was on line 5, following the word "in" by striking "New York City" and inserting in lieu thereof "Talcott, West Virginia".

The resolution, as amended, was then adopted.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (Com. Sub. for H. B. 5289) passed.

Com. Sub. for H. B. 5297, Relating to prohibiting pubertal modulation and hormonal therapy when provided to assist in a gender transition; on third reading with amendments pending and the right to amend, was reported by the Clerk.

Delegate Pushkin moved to amend the bill on page 2, Section 20, line 40, following the semicolon by striking out the word "and"; and on line 43, by striking out the period, inserting a semicolon and the following:

"and

(5) Pubertal modulating and hormonal therapy for severe gender dysphoria if the treatment was initiated prior to the effective date of this section.";

And,

On page 5, Section 17, line 39, following the semicolon by striking out the word "and"; and on line 42, by striking out the period, inserting a semicolon and the following:

"and

(5) Pubertal modulating and hormonal therapy for severe gender dysphoria if the treatment was initiated prior to the effective date of this section."

On the question of the adoption of the amendment, the same was put and the amendment was rejected.

Delegate Pushkin moved to amend the bill on page 2, Section 20, line 40, following the semicolon by striking out the word "and"; and on line 43, by striking out the period, inserting a semicolon and the following:

(5) The adolescent's attending physician expresses in a written opinion that treatment is medically necessary to treat the minor's psychiatric symptoms that makes the minor a danger to commit suicide without such treatment.":

On page 5, Section 17, line 39, following the semicolon, by striking out the word "and"; and on line 42, by striking out the period, inserting a semicolon and the following:

"and

(5) The adolescent's attending physician expresses in a written opinion that treatment is medically necessary to treat the minor's psychiatric symptoms that makes the minor a danger to commit suicide without such treatment."

On the question of the adoption of the amendment, the same was put and the amendment was rejected.

There being no further amendments, and having become the engrossed bill, the bill was read a third time.

On motion of Delegate Fluharty, the bill was amended on page 1, by striking everything after the enacting clause and inserting in lieu thereof:

"§29-22D-4. Commission duties and powers.

(a) In addition to the duties set forth elsewhere in this article, §29-22-1 et seq., §29-22A-1 et seq., §29-22B-1 et seq., §29-22C-1 et seq., and §29-25-1 et seq. of this code, the commission

shall have the authority to regulate sports pools and the conduct of sports wagering under this article.

- (b) The commission shall examine the regulations implemented in other states where sports wagering is conducted and shall, as far as practicable, adopt a similar regulatory framework through promulgation of rules and regulations.
- (c) The commission has the authority, pursuant to §29A-1-1, *et seq.* and §29A-3-1, *et seq.* of this code, to promulgate or otherwise enact any legislative, interpretive, and procedural rules the commission considers necessary for the successful implementation, administration, and enforcement of this article. Rules proposed by the commission before December 1, 2018, may be promulgated as emergency rules pursuant to §29A-3-15 of this code.
- (1) Regulations promulgated by the commission may include, but are not limited to, those governing the acceptance of wagers on a sports event or a series of sports events; maximum wagers which may be accepted by an operator from any one patron on any one sports event; type of wagering tickets which may be used; method of issuing tickets; method of accounting to be used by operators; types of records which shall be kept; use of credit and checks by patrons; type of system for wagering; protections for patrons placing wagers; and promotion of social responsibility, responsible gaming, and inclusion of the statement, "If you or someone you know has a gambling problem and wants help, call 1-800 GAMBLER," in every designated area approved for sports wagering and on any mobile application or other digital platform used to place wagers.
- (2) The commission shall establish minimum internal control standards (MICS) and approve minimum internal control standards proposed by licensed operators for administration of sports wagering operations, wagering equipment and systems, or other items used to conduct sports wagering, as well as maintenance of financial records and other required records.
- (d) The commission shall promulgate a legislative rule pursuant to §29A-3-1 *et seq.* of this code that enumerates the reasons for which patrons of sports gaming may be banned from engaging in sports betting. The list of reasons for which patrons may be banned shall include, but not be limited to:
 - (1) A prior conviction under §61-2-15a of this code;
 - (2) A prior violation of an order of the commission; and
- (3) If the commission determines that the person poses a threat to the safety of patrons or participants in a sporting event or determines that the person has engaged in a pattern of conduct of harassing a sports official, coach, or any participants.

Such rule shall also set forth the procedure by which complaints against patrons are lodged with and investigated by the commission. The commission shall notify a person of the commission's intent to ban such person from sports betting, and such person is entitled to a hearing before the commission pursuant to §29A-5-1 et seq. of this code.

(d) (e) The commission shall determine the eligibility of a person to hold or continue to hold a license, shall issue all licenses, and shall maintain a record of all licenses issued under this article. The commission may accept applications, evaluate qualifications of applicants, and undertake

initial review of licenses prior to promulgation of emergency rules upon the effective date of this article.

- (e) (f) The commission shall levy and collect all fees, surcharges, civil penalties, and weekly tax on adjusted gross sports wagering receipts imposed by this article, and deposit all moneys into the sports wagering fund, except as otherwise provided under this article.
- (f) (g) The commission may sue to enforce any provision of this article or any rule of the commission by civil action or petition for injunctive relief.
- (g) (h) The commission may hold hearings, administer oaths, and issue subpoenas or subpoenas duces tecum: *Provided*, That all hearings shall be conducted pursuant to the provisions of the State Administrative Procedures Act, §29A-2-1, *et seq.* of this code and the Lottery Administrative Appeal Procedures, W.Va. CSR §179-2-1, *et seq.*
- (h) (i) The commission may exercise any other powers necessary to effectuate the provisions of this article and the rules of the commission.

§29-22D-15. Authorization of sports wagering in this state; requirements.

- (a) An operator shall accept wagers on sports events and other events authorized under this article from persons physically present in a licensed gaming facility where authorized sports wagering occurs, or from persons not physically present who wager by means of electronic devices. A person placing a wager shall be at least 21 years of age.
- (b) An operator may accept wagers from an individual physically located within this state using a mobile or other digital platform or a sports wagering device, approved by the commission, through the patron's sports wagering account.
- (c) An operator may accept wagers from an individual physically located in a state or jurisdiction with which the commission has entered into a sports wagering agreement using a mobile or other digital platform or a sports wagering device through the patron's sports wagering account, so long as the device or platform is approved by the commission and all other requirements of the agreement are satisfied.
- (d) The commission or operator may ban any person from entering a gaming area of a gaming facility conducting sports wagering or the grounds of a gaming facility licensed under this article or from participating in the play or operation of any West Virginia Lottery sports wagering. A log of all excluded players shall be kept by the commission and each licensee, and no player on the commission's exclusion list or the licensed operator's exclusion list shall wager on any West Virginia Lottery sports wagering under this article.
- (e) (d) The commission shall promulgate regulations implementing the provisions of §29-22D-15(a) of this code by interpretive rule and minimum internal control standards.
- (f) (e) The commission shall, when a federal law is enacted or repealed or when a federal court decision is issued that permits a state to regulate sports wagering, publish a notice in the State Register notifying the public of the enactment or repeal of federal law or of the issuance of such court decision. The commission shall not be authorized to conduct sports wagering in this state until the notice prescribed in this subsection is published in the State Register.

- (g) (f) No licensed gaming facility employee may place a wager on any sports wagering at the employer's facility or through any other mobile application or digital platform of their employer.
- (h) (g) No commission employee may knowingly wager or be paid any prize from any wager placed at any licensed gaming facility with West Virginia Lottery sports wagering within this state or at any facility outside this jurisdiction that is directly or indirectly owned or operated by a sports wagering licensee."

Having been engrossed, the bill was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 400), and there were—yeas 90, nays 1, absent and not voting 9, with the nays and the absent and not voting being as follows:

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (H. B. 4700) passed.

On motion of Delegate Fluharty, the title of the bill was amended to read as follows:

H. B. 4700 - "A Bill to amend and reenact §29-22D-4 and §29-22D-15 of the Code of West Virginia, 1931, as amended, all relating to giving the lottery commission rule making authority to promulgate rules relating to banning certain persons from sports wagering."

Ordered, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

Com. Sub. for H. B. 5685, Relating to Medicaid Cost Containment; on third reading, coming up in regular order, with the right to amend, was reported by the Clerk.

An amendment offered by Delegate Rohrbach, was reported by the Clerk, on page 1, by striking everything after the enacting clause and inserting in lieu thereof the following:

"CHAPTER 9. HUMAN SERVICES.

ARTICLE 5. MISCELLANEOUS PROVISIONS.

§9-5-34. Medicaid program waivers and amendments; rulemaking requirement; reporting requirements.

(a) The Bureau for Medical Services shall study all benefits and eligibility provided by the program in relation to all surrounding states, and the five states nationally with the lowest per capita costs, every three years. For each benefit or eligibility that the West Virginia Medicaid program offers which exceeds that of any of the listed states, the Bureau for Medical Services must report the differential and offer a recommendation as to whether or not the agency supports continuing that benefit and/or eligibility at the current threshold. A six-year projection for expenditures for the identified benefit must be included in a report to the Legislature. The first

- report shall be submitted no later than December 31, 2024, to the Joint Committee on Government and Finance. Thereafter, the Bureau for Medical Services shall submit a report every three years.
- (b) The Bureau for Medical Services shall submit a report by December 1 of each year to the <u>Joint Committee on Government and Finance that analyzes how to achieve a one percent state</u> match budget reduction from the previous fiscal year. An explanation must be provided with each <u>identified budget reduction item on the costs and benefits of such a program change. It is not required that these proposals be acted upon by the Bureau or the Legislature.</u>
- (c) The Bureau for Medical Services shall undertake an annual study, in conjunction and with support of any state government agency that may be impacted by state Medicaid program funding, to determine if those functions can be financially covered by the state Medicaid program or more efficiently covered by the state Medicaid program. Analysis shall be undertaken where programs leveraging state Medicaid program funding have services evaluated to determine if they are in excess of bottom quartile of United States. This report shall be submitted to the Joint Committee on Government and Finance by December 1 with any recommendations concerning state budgetary savings.
- (d) The Bureau for Medical Services shall conduct a study to determine if existing waiver programs have generated financial offsets as originally planned. This initial study must be submitted to the Joint Committee on Government and Finance by December 1, 2024. This study must be conducted before any reauthorization is submitted to the federal Centers for Medicare and Medicaid Services.
- (e) The Bureau for Medical Services shall study and submit a report to Joint Committee on Government and Finance by July 1, 2025, concerning strategies that may be undertaken by the state to mitigate the benefit cliff. The benefit cliff occurs when an increase in a worker's earned income causes a disproportionately greater loss of critical public assistance healthcare benefits. A cliff can be prompted by a modest raise or a worker taking a new job with higher pay, or by someone rejoining the workforce after some time away.
- (f) The Bureau for Medical Services shall submit to Joint Committee on Government and Finance, each year by December 1, a report on West Virginia's improper payment rate. The Bureau must include in this report the following:
 - (1) The national average:
 - (2) Three states with the lowest improper payment rate;
- (3) The amount of improper payment with breakdown of where these payments were made and why; and
 - (4) Strategies on how to improve state improper payment rate.
- (g) The Bureau for Medical Services shall develop a population health outcomes report that quantifies the highest expenditure services, fastest growing expenditures, and areas actuarially identified as having the greatest elasticity in driving down long-term expenditures. This report shall provide where West Virginia ranks relative to other states, if available. The report shall also quantify rates across demographics for obesity, diabetes, substance use disorder, heart disease, cancer, infections following or during care, intrauterine substance exposure, neonatal abstinence syndrome, dental health, diabetes, chronic obstructive pulmonary disease, and other chronic

conditions as determined a priority by the Secretary. This report shall be submitted to the Joint Committee on Government and Finance by December 1 each year.

CHAPTER 16. PUBLIC HEALTH.

ARTICLE 29E. LEGISLATIVE OVERSIGHT COMMISSION ON HEALTH AND HUMAN RESOURCES ACCOUNTABILITY.

§16-29E-12. Medicaid program waivers and amendments.

- (a) The Bureau for Medical Services shall submit Medicaid Waivers and State Plan Amendments that grow total program expenditures \$3 million in state dollars or more beyond current expenses of the most recent available fiscal year to the commission.
 - (b) Within 60 days of submission, the commission shall recommend to the bureau that:
 - (1) it proceeds with the submission of the Medicaid Waiver or State Plan Amendment;
 - (2) it should change the Medicaid Waiver or State Plan Amendment; or
 - (3) it withdraws the Medicaid Waiver or State Plan Amendment.
- (c) The commission shall provide its recommendations to the Chairs of the Finance committees."

An amendment offered by Delegates Williams was reported by the Clerk.

Whereupon,

Delegate Williams obtained unanimous consent to withdraw the amendment.

Delegate Williams moved to amend the amendment on page 3, Section 12, line 2, by striking out the words "\$3 million in state dollars or more beyond" and inserting in lieu thereof the words "an amount equal to or greater than the inflation indicator for Medicare and Medicaid, as published by the Congressional Budget Office for".

On the question of the adoption of the amendment to the amendment offered by Delegate Williams, the same was put and rejected.

On the question of the adoption of the amendment offered by Delegate Rohrbach, the same was put and adopted.

Having been engrossed, the bill was read a third time.
