1 A BILL to amend and reenact §18-2-7a of the Code of West Virginia, 1931, as amended, relating to
2 requiring each child enrolled in the public schools of this state to actively participate in
3 physical education classes during the school year to the level of his or her ability.

Be it enacted by the Legislature of West Virginia:

ARTICLE 2. STATE BOARD OF EDUCATION.

§18-2-7a. Legislative findings; required physical education; program in physical fitness.

1 (a) The Legislature hereby finds that obesity is a problem of epidemic proportions in this
2 state. There is increasing evidence that all segments of the population, beginning with children,
3 are becoming more sedentary, more overweight and more likely to develop health risks and
4 diseases including Type II Diabetes, high blood cholesterol and high blood pressure. The
5 Legislature further finds that the promotion of physical activity during the school day for school
6 children is a crucial step in combating this growing epidemic and in changing the attitudes and
7 behavior of the residents of this state toward health promoting physical activity.

8 (b) As a result of these findings, the state Department of Education shall establish the
9 requirement that each child enrolled in the public schools of this state actively participates in
10 physical education classes during the school year to the level of his or her ability as follows:

11 (1) *Elementary school grades.* — Not less than thirty minutes of physical education,
12 including physical exercise and age-appropriate physical activities, for not less than three days a
13 week.

14 (2) *Middle school grades.* — Not less than one full period of physical education, including
15 physical exercise and age-appropriate physical activities, each school day of one semester of the
16 school year:— Provided, That an optional and supervised academic study hall period, rather than a
17 period of physical education, shall be made available to any student who can successfully
18 demonstrate by written and signed form, affidavit, or other evidence, a history of and intent to
19 continue with participation in an average of five hours or more of school sponsored or privately
20 organized sports or physical education each week of the required semester.

21 (3) *High school grades.* -- Not less than one full course credit of physical education,
22 including physical exercise and age-appropriate physical activities, which shall be required for
23 graduation and the opportunity to enroll in an elective lifetime physical education course:
24 Provided, That an optional and supervised academic study hall period, rather than a period of
25 physical education, shall be made available and shall satisfy the graduation requirement for any
26 student who can successfully demonstrate by written and signed form, affidavit, or other evidence,
27 a history of and intent to continue with participation in an average of five hours or more of school
28 sponsored or privately organized sports or physical education each week of the required course.

29 (c) Enrollment in physical education classes and activities required by the provisions of this
30 section shall not exceed, and shall be consistent with, state guidelines for enrollment in all other
31 subjects and classes: *Provided*, That schools which do not currently have the number of certified
32 physical education teachers, do not currently have the required physical setting or would have to
33 significantly alter academic offerings to meet the physical education requirements may develop
34 alternate programs that will enable current staff, physical settings and offerings to be used to meet
35 the physical education requirements established herein. These alternate programs shall be
36 submitted to the state Department of Education and the Healthy Lifestyle Council for approval.
37 Those schools needing to develop alternate programs shall not be required to implement this
38 program until the school year commencing two thousand six.

39 (d) The state board shall prescribe a program within the existing health and physical
40 education program which incorporates fitness testing, reporting, recognition, fitness events and
41 incentive programs which requires the participation in grades four through eight and the required
42 high school course. The program shall be selected from nationally accepted fitness testing
43 programs designed for school-aged children that test cardiovascular fitness, muscular strength
44 and endurance, flexibility and body composition: *Provided*, That nothing in this subsection shall be
45 construed to prohibit the use of programs designed under the auspices of the President's Council
46 on Physical Fitness and Sports. The program shall include modified tests for exceptional students.

47 Each school in the state shall participate in National Physical Fitness and Sports Month in May of
48 each year and shall make every effort to involve the community it serves in the related events.

49 (e) The state board shall promulgate a rule in accordance with the provisions ~~article three-~~
50 ~~b, chapter twenty-nine-a of §29A-3B-1 et seq.~~ of this code that includes at least the following
51 provisions to provide for the collection, reporting and use of body mass index data in the public
52 schools:

53 (1) The data shall be collected using the appropriate methodology for assessing the body
54 mass index from student height and weight data;

55 (2) The data shall be collected on a scientifically drawn sample of students;

56 (3) The data shall be collected and reported in a manner that protects student
57 confidentiality;

58 (4) The data shall be reported to the Department of Education; and

59 (5) All body mass index data shall be reported in aggregate to the Governor, the state
60 Board of Education, the Healthy Lifestyles Coalition and the Legislative Oversight Commission on
61 Health and Human Resources Accountability for use as an indicator of progress toward promoting
62 healthy lifestyles among school-aged children.

NOTE: The purpose of this bill is to require each child enrolled in the public schools of this state to actively participate in physical education classes during the school year to the level of his or her ability.
