[DELEGATE HANSHAW, MR. SPEAKER, IN THE CHAIR]

The House of Delegates was called to order by the Honorable Roger Hanshaw, Speaker.

Prayer was offered and the House was led in recitation of the Pledge of Allegiance.

The Clerk proceeded to read the Journal of Wednesday, March 19, 2025, being the first order of business, when the further reading thereof was dispensed with and the same approved.

Committee Reports

Mr. Speaker (Mr. Hanshaw), Chair of the Committee on Rules, submitted the following report, which was received:

Your Committee on Rules has had under consideration:

Com. Sub. For H. B. 2043, Relating to use of dog and/or drones for tracking or locating mortally wounded deer, elk, turkey, wild boar or bear,

And reports back a committee substitute therefor, as follows:

Com. Sub. for H. B. 2043 - "A Bill to amend and reenact §20-2-5j of the Code of West Virginia, 1931, as amended, relating to tracking of wounded animals; authorizing the use of unmanned aerial vehicles; authorizing the use of dogs while hunting; describing their use; and requiring licensure if operating on private property."

With the recommendation that the committee substitute do pass.

On motion for leave, a bill was introduced (Originating in the Committee on Rules and reported with the recommendation that it do pass), which was read by its title, as follows:

H. B. 2475, To provide a raise for special education aides, as well as a raise for self-contained special education teachers,

B. 2475** "A Bill to amend and reenact §18A-2-2b of the Code of West Virginia, 1931, as amended; and to amend said code by adding thereto a new section, designated §18A-4-5c of said code, relating to matching the salaries of Aide V (Special Education Aides) with that of Early Childhood Classroom Assistant Teachers and then increasing that amount by 5% for the Aide V position; increasing the pay of self-contained, special education teachers by 10%; defining a critical vacancy; and to require board staff who are certified in the subject area of a critical vacancy to go to the classroom and fill that position until someone is hired to do so,"
- **H. B. 2610**, Tuition and fee exemptions for service-connected Disabled Veterans and their dependents,

B. 2610 - "A Bill to amend the Code of West Virginia, 1931, as amended, by adding a new section, designated §18B-10-7e, relating to tuition and fees at state institutions of higher education; defining terms; requiring state institutions of higher education to provide waivers of tuition and fees to military veterans, their spouses and their dependents under certain circumstances; and setting forth requirements that must be met to receive waiver,"

H. B. 2879, Relating to the creation of the West Virginia Math & Science Teacher Scholarship Act,

Com. Sub. for S. B. 336, Authorizing Department of Homeland Security to promulgate legislative rules; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 116), and there were—yeas 94, nays none, absent and not voting 6, with the absent and not voting being as follows:

Absent and Not Voting: Bridges, Dittman, Fehrenbacher, Riley, Steele and Vance.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (Com. Sub. for S. B. 336) passed.

Delegate McGeehan moved that the bill take effect from its passage.

Com. Sub. for H. B. 3024, Guaranteed course transfer bill; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 125), and there were—yeas 95, nays none, absent and not voting 5, with the absent and not voting being as follows:

Absent and Not Voting: Bridges, W. Clark, Dittman, Steele and Vance.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (Com. Sub. for H. B. 3024) passed.

Ordered, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

Com. Sub. for Com. Sub. for H. B. 3089, Mandate the use of WV DMV electronic lien and title system for certain entities and persons; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 126), and there were—yeas 95, nays none, absent and not voting 5, with the absent and not voting being as follows:

Absent and Not Voting: Bridges, W. Clark, Dittman, Steele and Vance.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (Com. Sub. for Com. Sub. for H. B. 3089) passed.

Ordered, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

Com. Sub. for H. B. 3190, Controlled Substances and arrestable offenses; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 127), and there were—yeas 91, nays 4, absent and not voting 5, with the nays and the absent and not voting being as follows:

Nays: Flanigan, Hansen, Pushkin and Young.

Absent and Not Voting: Bridges, W. Clark, Dittman, Steele and Vance.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (Com. Sub. for H. B. 3190) passed.

On motion of Delegate Akers, the title of the bill was amended to read as follows:

Com. Sub. for H. B. 3190 — "A BILL to amend and reenact §60-6-9 of the Code of West Virginia, 1931, as amended, relating to expanding and clarifying that the offense of public intoxication shall also include persons intoxicated by controlled substances, also relating to expanding the counseling available upon arrest to include counseling on controlled substance dependence, also clarifying that three convictions for public intoxication within the previous six months is considered evidence of dependence on controlled substances.";

Ordered, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

Com. Sub. for H. B. 3192, To repeal obsolete, conflicting or inoperative provisions of code that pertain to higher education; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 128), and there were—yeas 95, nays none, absent and not voting 5, with the absent and not voting being as follows:

Absent and Not Voting: Bridges, W. Clark, Dittman, Steele and Vance.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (Com. Sub. for H. B. 3192) passed.

Ordered, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

Second Reading

Com. Sub. for S. B. 369, Authorizing miscellaneous boards and agencies to promulgate legislative rules; on second reading, coming up in regular order, was read a second time,

On motion of Delegate Phillips, the amendment was adopted.

An amendment was recommended by the Committee on Government Organization, on page 6, section 3, lines 4 through 7, by striking out all of subsection (b) and inserting in lieu thereof a new subsection (b) to read as follows:

(b) The legislative rule filed in the State Register on August 13, 2024, authorized under the authority of §31I-1-13 of this code, modified by the State Auditor to meet the objections of the Legislative Rule-Making Review Committee and refiled in the State Register on October 17, 2024, relating to the State Auditor (private trust companies, <u>155 CSR 12</u>), is authorized with the following amendment:

On page 1, by striking out all of subsection 1.6. and inserting in lieu thereof a new subsection 1.6. to read as follows:

1.6. Confidentiality. – Notwithstanding any provision to the contrary in Chapter 29B of the W. Va. Code, none of the following, which are submitted as part of any application for licensure under this Title, shall be subject to disclosure under the provisions of the Freedom of Information Act of the State of West Virginia or otherwise: any Form WVSAO-PTC-Bio, "Biographical Report," incorporated by reference in W. Va. Code R. 155-12-9.6, provided as Exhibit E or F to Form WVSAO-PTC-01 or otherwise; any list of Family Members or list of current or former employees provided as Exhibit H to Form WVSAO-PTC-01 or otherwise; and any Genealogical Chart provided as Exhibit I to Form WVSAO-PTC-01 or otherwise.;

On page 12, section 17, by striking out the section heading;

And,

On page 12, section 17, lines 1 through 4, by striking out all of section 17 and renumbering the remaining sections accordingly.

Com. Sub. for Com. Sub. for H. B. 2003, Prohibiting Cell phones in class; on second reading, coming up in regular order, was read a second time and ordered to engrossment and third reading,

Com. Sub. for H. B. 2349, To offer long-acting reversible contraception to patients receiving methadone and suboxone at the treatment facility for the methadone and suboxone; on second reading, coming up in regular order, was read a second time,

On motion of Delegate Worrell, the amendment was adopted.

Delegate Worrell moved to amend the bill on page 4, section 3, line 81, by striking the period and the following, "(6) The opioid treatment program shall offer long-acting reversible contraception to patients recovering from addiction"

An amendment offered by Delegate Pushkin was reported by the Clerk.

Whereupon,

Delegate Pushkin asked and obtained unanimous consent to withdraw the amendment.

The bill was then ordered to engrossment and third reading.

- **Com. Sub. for H. B. 2389**, Relating to Dietitian Licensure Compact; on second reading, coming up in regular order, was read a second time and ordered to engrossment and third reading,
- **H. B. 2479**, Relating to Management and control of county authority vested in board; on second reading, coming up in regular order, was read a second time and ordered to engrossment and third reading,
- **Com. Sub. for H. B. 2502**, Establishing limitations on billing practices of Internet or telecommunications providers that fail to provide subscribed customers service for five or more days; on second reading, coming up in regular order, was read a second time,

On motion of Delegate Hillenbrand, the amendment was adopted.

Delegate Hillenbrand moved to amend the bill on page 1, section 111, line 3, immediately following the word "120" by inserting the word "continuous"

And,
