[DELEGATE ROHRBACH, MR. SPEAKER PRO TEMPORE, IN THE CHAIR]

The House of Delegates was called to order by the Honorable Matthew Rohrbach, Speaker Pro Tempore.

Prayer was offered and the House was led in recitation of the Pledge of Allegiance.

The Clerk proceeded to read the Journal of Friday, March 21, 2025, being the first order of business, when the further reading thereof was dispensed with and the same approved.

Committee Reports

Mr. Speaker (Mr. Hanshaw), Chair of the Committee on Rules, submitted the following report, which was received:

Your Committee on Rules has had under consideration:

H. C. R. 72, Recognizing Black Lung Awareness Day 2025 as March 20th, 2025,

And reports back a committee substitute therefor, as follows:

Com. Sub. for H. C. R. 72 - "Proclaiming March 'Black Lung Awareness Month' in West Virginia to both pay tribute to those who have or are suffering from coal worker's pneumoconiosis and to help reduce the risk of black lung disease in coal miners," with the recommendation that the committee substitute be adopted.

At the request of Delegate Jeffries, and by unanimous consent, the resolution (H. C. R. 72) was taken up for immediate consideration and put upon its adoption.

The question being on adoption of the House Concurrent Resolution, the yeas and nays were taken **(Roll No. 159)**, and there were--yeas 96, nays 0, absent and not voting 4, with the absent and not voting being as follows:

- **H. B. 2963**, To ensure that the survivor of a merger, reorganization, purchase, or assumption of liabilities of a bank chartered by West Virginia is insured by the Federal Deposit Insurance Corporation,

B. 2377 - "A Bill to amend and reenact §49-2-809, §49-5-101, and §49-11-101 of the Code of West Virginia, 1931, as amended; and to amend the code by adding a new article, designated §61-12B-1, §61-12B-2, §61-12B-3, §61-12B-4, §61-12B-5, §61-12B-6, and §61-12B-7 relating to child welfare; updating abuse and neglect reporting; permitting the Foster Care Ombudsman to have access to information related to proceedings involving child abuse or neglect; providing the public shall have access to reports of child abuse or neglect adding additional terms to the child welfare dashboard; providing for effective date; creating the Critical Incident Review Team; defining terms; setting forth responsibilities of the Critical Incident Review Team; requiring reporting; providing the Critical Incident Review Team access to information and providing for confidentiality,"
