#### FORTY-THIRD DAY

[DELEGATE HANSHAW, MR. SPEAKER, IN THE CHAIR]

The House of Delegates was called to order by the Honorable Roger Hanshaw, Speaker.

Prayer was offered and the House was led in recitation of the Pledge of Allegiance.

The Clerk proceeded to read the Journal of Tuesday, March 25, 2025, being the first order of business, when the further reading thereof was dispensed with and the same approved.

#### Reordering of the Calendar

Pursuant to the action of the Committee on Rules, Delegate McGeehan announced that H. B. 2146, on second reading, Special Calendar, had been transferred to the House Calendar; H. B. 3387, on second reading, Special Calendar, had been transferred to the House Calendar; and 3452, on first reading, Special Calendar, had been transferred to the House Calendar.

#### **Committee Reports**

On motion for leave, a bill was introduced (Originating in the Committee on Finance and reported with the recommendation that it do pass), which was read by its title, as follows:

By Delegates Barnhart, Hall, Rohrbach, Hott, Riley, Fehrenbacher, J. Cannon, Dittman, Mazzocchi, Statler and Canterbury:

**H. B. 3505** - "A Bill to amend the Code of West Virginia, 1931, as amended, by adding seven new sections, designated §5-16-8b, §9-5-34, §33-15-24, §33-16-20, §33-24-15, §33-25-23 and §33-25A-37, relating to insurance; and providing health insurance coverage for scalp cooling systems for the preservation of hair during cancer chemotherapy treatment."

Delegate Worrell, Chair of the Committee on Health and Human Resources submitted the following report, which was received:

Your Committee on Health and Human Resources has had under consideration:

**H. B. 2780**, Providing any employee working 20 hours or more per week in a licensed childcare center or certified family childcare (FCC) home is eligible for a childcare subsidy, regardless of their household income,

And reports back a committee substitute therefor, as follows:

**Com. Sub. for H. B. 2780** - "A Bill to amend the Code of West Virginia, 1931, as amended, by adding thereto a new section, designated §49-2-131, relating to services rendered to children of childcare program employees,"

With the recommendation that the committee substitute do pass, but that it first be referred to the Committee on Finance.

In accordance with the former direction of the Speaker, the bill (Com. Sub. for H. B. 2780) was referred to the Committee on Finance.

Delegate Worrell, Chair of the Committee on Health and Human Resources, submitted the following report, which was received:

Your Committee on Health and Human Resources has had under consideration:

H. B. 2575, Relating to the establishment of a full-time Dementia Services Director position,

And reports the same back with the recommendation that it do pass.

Delegate Ellington, Chair of the Committee on Education, submitted the following report, which was received:

Your Committee on Education has had under consideration:

H. B. 2167, Relating to public charter schools code provisions,

And reports back a committee substitute therefor, as follows:

Com. Sub. for H. B. 2167 - "A Bill to amend and reenact §18-5G-3, §18-5G-4, and §18-5G-7 of the Code of West Virginia, 1931, as amended, relating to providing for technical cleanup of certain provisions of the public charter school code provisions; providing that public charter schools may not charge full-time tuition and may only charge such tuition or fees as may be imposed by noncharter public schools in this state, such as for part-time Hope Scholarship enrollment or for participation in student activities; providing that a closing public school shall be eligible for a fast-track charter school conversion for its upcoming school year; providing a tracking process for when a parent or guardian withdraws a student from a public charter school; and providing that public charter school teachers shall be permitted to proctor state assessments in the event they are not certified or licensed,"

H. B. 3279, Relating to requirements for WVU and WVSU Board of Governors,

And reports back a committee substitute therefor, as follows:

Com. Sub. for H. B. 3279 - "A Bill to amend and reenact §18B-2A-1 and §18B-2A-2 of the Code of West Virginia, 1931, as amended, relating to institutional boards of governors; amending legislative findings; increasing number of Board of Governors members at West Virginia University; clarifying that elected faculty, student, and classified or non-classified employees serve as nonvoting advisory members; increasing the number of lay members appointed by the Governor to West Virginia University's Board of Governors; requiring one person of the West Virginia University Board of Governors and of the West Virginia State University Board of Governors to have a background in agriculture, forestry, or the agricultural or silvicultural sciences; clarifying that graduates of West Virginia Institute of Technology of West Virginia University and West Virginia Potomac State College of West Virginia University have a representative serve on West Virginia University's Board of Governors; adding a requirement that the Governor consider the needs of the state of West Virginia and its citizens in making appointments to the institutional board of governors; and making technical changes,"

**H. B. 3422**, Relating to requiring the State Board of Education to design, test, and deploy an internet-based reporting system to be known as the School Choice Portal,

And reports back a committee substitute therefor, as follows:

**Com. Sub. for H. B. 3422** - "A Bill to amend the Code of West Virginia, 1931, as amended, by adding thereto a new article, designated §18-36-1, relating to the creation of a school choice portal; and requiring the Board of Education to adopt a school choice portal,"

With the recommendation that the committee substitutes each do pass.

Delegate Ellington, Chair of the Committee on Education, submitted the following report, which was received:

Your Committee on Education has had under consideration:

**H. B. 3438**, To allow retired teachers in long-term substitute positions with specialties in maths, sciences, English, and foreign languages to remain in the substitute teaching positions for the entire school year without interruption to their retirement pay in order to allow students to have a quality, uninterrupted education,

And reports the same back with the recommendation that it do pass, but that it first be referred to the Committee on Finance.

In accordance with the former direction of the Speaker, the bill (H. B. 3438) was referred to the Committee on Finance.

Delegate Ellington, Chair of the Committee on Education, submitted the following report, which was received:

Your Committee on Education has had under consideration:

H. B. 3446, Requiring public high school students submit FAFSA prior to graduation,

And reports the same back with the recommendation that it do pass.

Delegate Ellington, Chair of the Committee on Education, submitted the following report, which was received:

Your Committee on Education has had under consideration:

**H. B. 3209**, To provide at least one counselor for every 250 students in public schools and public charter schools in this state,

And reports back a committee substitute therefor, as follows:

**Com. Sub. for H. B. 3209** - "A Bill to amend and reenact §18-5-18b and §18-9A-8 of the Code of West Virginia, 1931, as amended, relating to requiring a statewide full-time professional counselor to student ratio of one to every 250 students; and requiring that every public school in the state have at least one professional counselor,"

With the recommendation that the committee substitutes each do pass, and with the recommendation that second reference to the Committee on Finance be dispensed with.

In the absence of objection, reference of the bill (Com. Sub. for H. B. 3209) to the Committee on Finance was abrogated.

Delegate Anderson, Chair of the Committee on Energy and Public Works, submitted the following report, which was received:

Your Committee on Energy and Public Works has had under consideration:

**H. B. 2156**, Relating to time limits imposed on the Division of Highways to grant a highway entrance permit,

And reports back a committee substitute therefor, as follows:

- **Com. Sub. for H. B. 2156** "A Bill to amend and reenact §17-16-6 of the Code of West Virginia, 1931, as amended, relating to imposing a time limit for the Department of Highways to grant an entrance permit for work on a highway; describing the time limit for requested changes; describing when a permit shall be considered approved; and improving obsolete language,"
  - H. B. 3179, Funding for failing public utilities,

And reports back a committee substitute therefor, as follows:

**Com. Sub. for H. B. 3179** - "A Bill to amend and reenact §24-2H-7 of the Code of West Virginia, 1931, as amended, relating to utility acquisitions; limiting the commission's authority on ordering the acquisition of distressed or failing authorities; and establishing guidelines for when the commission can order acquisitions,"

H. B. 3276, Provide mechanism for rate increases for water and sewer utilities,

B. 2787 - "A Bill to amend and reenact §7-1-3k of the Code of West Virginia, 1931, as amended; relating to permitting county commissions to lease, rent, or permit the use of county-owned wireless towers or any portions thereof to any entity or entities meeting certain criteria, with equipment and systems meeting minimum requirements, and for purposes not prohibited; and prohibiting county commissions from levying charges for use of county-owners wireless towers or any portions thereof by public safety operations, the West Virginia Department of Highways, or any other state agencies provided the same requirements are met as for other applicants,"

**H. B. 3432**, Revising the statutes to clarify and separate duties identified in the code between the Division of Emergency Management and the West Virginia Department of Environmental Protection.

**Com. Sub. for H. B. 2880**, Relating to parent resource navigators; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (**Roll No. 193**), and there were--yeas 92, nays 1, absent and not voting 7, with the nays and the absent and not voting being as follows:

Absent and Not Voting: Anders, Cooper, Devault, Jennings, Kelly, Lewis and Stephens.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (Com. Sub. for H. B. 2880) passed.

**Com. Sub. for H. B. 2987**, Relating to the Consumer Data Protection Act; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 194), and there were--yeas 94, nays 1, absent and not voting 5, with the nays and the absent and not voting being as follows:

Nays: Steele.

Absent and Not Voting: Bridges, Cooper, Devault, Jennings and Stephens.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (Com. Sub. for H. B. 2987) passed.

Delegate McGeehan moved that the bill take effect July 1, 2026.

On this question, the yeas and nays were taken (Roll No. 195), and there were--yeas 94, nays none, absent and not voting 6, with the absent and not voting being as follows:

Absent and Not Voting: Bridges, Cooper, Devault, Flanigan, Jennings and Stephens.

So, two thirds of the members elected to the House of Delegates having voted in the affirmative, the Speaker declared the bill (Com. Sub. for H. B. 2987) takes effect July 1, 2026.

**Com. Sub. for H. B. 3289**, Relating to expungement of certain criminal convictions; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 196), and there were--yeas 93, nays 4, absent and not voting 3, with the nays and the absent and not voting being as follows:

Nays: Butler, Martin, Pinson and Ward.

Absent and Not Voting: Bridges, Jennings and Pritt.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (Com. Sub. for H. B. 3289) passed.

*Ordered*, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

**Com. Sub. for H. B. 3343**, Relating to drugs and adding a provision relating to the scheduling of crystalline polymorph psilocybin approved by the Food and Drug Administration; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 197), and there were--yeas 92, nays 5, absent and not voting 3, with the nays and the absent and not voting being as follows:

Nays: Eldridge, Gearheart, Heckert, Sheedy and Vance.

Absent and Not Voting: Bridges, Foggin and Jennings.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (Com. Sub. for H. B. 3343) passed.

An amendment was recommended by the Committee on Health and Human Resources that the title of the bill was amended to read as follows:
