The House of Delegates was called to order by the Honorable Roger Hanshaw, Speaker.

Prayer was offered and the House was led in recitation of the Pledge of Allegiance.

B. 2014 - "A Bill to amend and reenact §5B-2-21, §24-2-1d, §24-2-1g, §24-2-15, §24-2-19 of the Code of West Virginia, 1931, as amended; to amend the code by adding four new sections, designated §5B-2-21a, §5B-2-21b, §5B-2N-2a, and §11B-2-33, and to amend the code by adding a new article, designated §11-6N-1, §11-6N-2, §11-6N-3, §11-6N-4, and §11-6N-5, enacting the Power Generation and Consumption Act of 2025 which creates the Certified Microgrid Program administered by the Division of Economic Development; renaming business expansion development program administered by the department; renaming high impact business development districts certified by the department; providing that any plant or facility may participate in the business expansion development program; removing requirement that high impact business development districts be located on certain lands; eliminating requirement that electrical service to business development districts be generated from renewable sources; providing for certification of high impact data centers; prohibiting payment in lieu of taxes and tax increment financing under certain circumstances; providing for special valuation by the Board of Public Works of a high impact data center property, applying a specialized reapportionment formula for the property tax proceeds of a high impact data center; defining terms; and specifying dates,"

H. B. 3377, Non-State Owned Roads Improvement Act,

B. 3377 - "A BILL to amend the Code of West Virginia, 1931, as amended, by adding thereto a new article designated §17-2E-1, §17-2E-2, §17-2E-3; §17-2E-4, and §17-2E-5; by adding thereto a new section designated §17-4-1; and by adding thereto a new article designated §36C-1-1, §36C-1-2, §36C-1-3, §36C-1-4, §36C-1-5, §36C-1-6, §36C-1-7, and §36C-1-8, all relating to the maintenance of roads and infrastructure; establishing a county and municipal orphan road program; permitting counties and municipalities to acquire or maintaining roads and bridges which are not maintained by any governmental entity for that purpose; providing for the procedure required to find and designate such roads or bridges; establishing public notification and transparency; authorizing funding; providing for an online map of state roads; creating Infrastructure Only Common Ownership Associations; providing for uniformity of application; determining the construction and validity of Infrastructure Only Common Ownership Associations; providing for the filing of required plats and plans; and providing for the management, termination, and scope of Infrastructure Only Common Ownership Associations,"

After submission of my recommended FY 2026 Executive Budget on February 12, 2025, there are areas that require adjustment.

 - (2) The average amount of cases an appointed panel attorney served as a guardian ad litem;
- (3) The average length of time that a child abuse or neglect proceeding lasts from the date of the initial appointment of a panel guardian ad litem until an order is entered that finds that permanency for the child has been achieved;
- (4) The average number of in-person visits or conferences that appointed guardians ad litem have with their clients, or when appropriate the client's parents or caretaker, including the aggregate number of cases that appointed guardians ad litem have an in-person visit, or conference, with their client, or when appropriate a client's parents or caretaker, and the aggregate number of cases that guardians ad litem did not have an in-person visit or conference with their client, or client's parents or caretaker: *Provided*, That nothing in this subsection will require the disclosure by any guardian ad litem of any information protected by attorney client privilege.
- (5) The average number of out-of-court hours itemized and billed in each case by an appointed panel attorney serving as guardian ad litem from the initial appointment date until permanency for the child has been achieved as reflected by court order;
- (6) The average number of in-court hours itemized and billed in each case by an appointed panel attorney serving as guardian ad litem from the initial appointment date until permanency for the child has been achieved as reflected by court order;
- (7) The average number of hours itemized and billed in each case as travel time by an appointed panel attorney serving as guardian ad litem from the initial appointment date until permanency for the child has been achieved as reflected by court order."

On the adoption of the amendment, the yeas and nays were demanded, which demand was sustained.

On motion of Delegate Pushkin, the amendment was rejected.

Delegate Pushkin moves to amend "HB3305 HFA Holstein 3-27 #1" on page 1, line 3 by striking out subdivision (6) in its entirety and inserting in lieu thereof the following:

"(6) For partisan elections, the name of the candidate's political party, if any, on the date the certificate of announcement is submitted and a statement that the candidate:

- (A) is a member of and affiliated with that political party as evidenced by the candidate's current registration as a voter affiliated with that party, if any; and
- (B) has not been registered as a voter affiliated with any other political party, or independent of any political party, for a period of 60 180 days before the date of filing the announcement; and
- (C) If a candidate has been registered as an independent or unaffiliated and intends to run as member of a political party, that person must have registered as a member of that party at least 60 days prior to filing."

Notwithstanding any other provision of this Code to the contrary, no excise tax may be levied, assessed, or collected within any municipal economic opportunity development district established under this code. Any authorization of such taxes under existing law is hereby null and void within the jurisdiction of this article. This prohibition shall include, but is not limited to, excise taxes on the sale of goods, services, food, beverages, lodging, fuel, telecommunications, or any other transaction or activity.

Delegate Gearheart arose to inquire of the Chair regarding the germaneness of the amendment.
