[DELEGATE RILEY, MR. SPEAKER PRO TEMPORE, IN THE CHAIR]

The House of Delegates was called to order by the Honorable Clay Riley, Speaker Pro Tempore.

Prayer was offered and the House was led in recitation of the Pledge of Allegiance.

The Clerk proceeded to read the Journal of Thursday, March 27, 2025, being the first order of business, when the further reading thereof was dispensed with and the same approved.
