The Senate met at 10:01 a.m.

(Senator Smith, Mr. President, in the Chair.)

Prayer was offered by the Honorable Vince S. Deeds, a senator from the tenth district.

The Senate was then led in recitation of the Pledge of Allegiance by the Honorable Christopher A. Rose, a senator from the second district.

The Senate proceeded to the second order of business and the introduction of guests.

The Senate proceeded to the fourth order of business.

Senator Chapman, from the Committee on Health and Human Resources, submitted the following report, which was received:

Your Committee on Health and Human Resources has had under consideration

Senate Bill 460, Relating to vaccine requirements.

And reports back a committee substitute for same with the following title:

Com. Sub. for Senate Bill 460 (originating in the Committee on Health and Human Resources)—A Bill to amend and reenact §16-3-4 of the Code of West Virginia, 1931, as amended, relating to exemptions for compulsory immunization requirements; providing specific duties for the state health officer; removing reporting requirements; revising medical exemption

process; eliminating state immunization officer; permitting religious exemption to mandatory vaccination requirements; permitting philosophical exemption to mandatory vaccination requirements; prohibiting entities from excluding participation in extracurricular activities based upon exercising an exemption; prohibiting entities from excluding attendance at school-based events based upon exercising an exemption; permitting a civil action for violations of this section; and setting forth public policy supporting exemptions.

With the recommendation that the committee substitute do pass.

Senate Bill 464—A Bill to amend the Code of West Virginia, 1931, as amended, by adding a new section, designated as §17A-3-14j, relating to the issuance of special plates to recipients of the distinguished Medal of Valor.

Referred to the Committee on Transportation and Infrastructure; and then to the Committee on Finance.

By Senator Rose:

Senate Bill 465—A Bill to amend the Code of West Virginia, 1931, as amended, by adding a new article designated §12-4C-1, §12-4C-2, §12-4C-3, §12-4C-4, and §12-4C-5, relating to investments by the state; providing a short title; providing definitions; clarifying investment opportunities for the Board of Treasury and state retirement fund; and establishing rules.

Referred to the Committee on Banking and Insurance; and then to the Committee on Finance.

By Senator Willis:

Senate Bill 466—A Bill to amend and reenact §16-3-4 of the Code of West Virginia, 1931, as amended, relating to immunizations; establishing voluntary vaccinations and eliminating certain compulsory immunization requirements; eliminating vaccine mandates for all citizens of West Virginia; providing immunization information upon request by parents of newborns; providing that all vaccinations for West Virginia citizens be voluntary; and establishing that vaccinations are not required as a condition of school enrollment, attendance, or employment.

Senate Bill 467—A Bill to amend the Code of West Virginia, 1931, as amended, by adding a new article, designated §49-12-101, §49-12-102, §49-12-103, and §49-12-104, relating to clothing and necessity allowance; setting forth the requirements to obtain funding from the Bureau

for Social Services for approved necessities, an adequate wardrobe, and any supplementary clothing assistance; and setting forth the amount and form of payment.

By Senator Rose:

Senate Bill 468—A Bill to amend the Code of West Virginia, 1931, as amended, by adding a new section, designated §15-1B-1a, relating to the West Virginia National Guard; and requiring an official declaration of war or an action to call forth the state militia by the United States Congress before members of the West Virginia National Guard may be released from state control to participate in active-duty combat.

Referred to the Committee on Military; and then to the Committee on the Judiciary.

By Senators Rose and Thorne:

Senate Bill 469—A Bill to amend and reenact §61-7-3, §61-7-6, and §61-7-7 of the Code of West Virginia, 1931, as amended, relating to allowing those persons 18 to 20 years old to be able to carry a concealed deadly weapon without a permit, as is presently allowed for those persons 21 years and older.

Senate Bill 470—A Bill to amend the Code of West Virginia, 1931, as amended, by adding a new section, designated §18-2-25f, relating to allowing students, coaching staff, and athletic trainers to participate in non-school athletic activities.

Senate Bill 471—A Bill amend the Code of West Virginia, 1931, as amended, by adding a new article, designated §18-9H-1, §18-9H-2, §18-9H-3, §18-9H-4, and §18-9H-5, relating to the revision of the school funding formula to be student-based; and ensuring equal accessibility to funds for school maintenance and consolidation.

Referred to the Committee on Education; and then to the Committee on Finance.

By Senator Deeds:

Senate Bill 472—A Bill to amend and reenact §49-2-809, §49-5-101, and §49-11-101 of the Code of West Virginia, 1931, as amended; and adding a new article, designated §61-12B-1, §61-12B-2, §61-12B-3, §61-12B-4, §61-12B-5, §61-12B-6, and §61-12B-7, relating to child welfare; amending abuse and neglect reporting; permitting the Foster Care Ombudsman to have access to information related to proceedings involving child abuse or neglect, or both, including information related to the identity of the person reporting or making a complaint of child abuse or neglect; providing the public shall have access to reports of child abuse or neglect, or both, in conformity with the Critical Incident Review Team's reporting; adding additional terms to the child welfare dashboard; providing for effective date; creating the Critical Incident Review Team; setting forth purpose; defining terms; setting forth responsibilities of the Critical Incident Review Team; requiring reporting; providing the Critical Incident Review Team access to information; and providing for confidentiality.

Referred to the Committee on Health and Human Resources; and then to the Committee on the Judiciary.

By Senator Tarr:

Senate Bill 473—A Bill to amend the Code of West Virginia, 1931, as amended, by adding a new section, designated §55-7-33, relating to damages for medical monitoring; establishing requirements for an order for payment of medical monitoring expenses; and providing that an increased risk of disease is not a compensable basis for damages in any civil action.

By Senators Smith (Mr. President) and Woelfel (By Request of the Executive):

Senate Bill 474—A Bill to amend the Code of West Virginia, 1931, as amended, by adding two new articles, designated §5-33-1, §5-33-2, §5-33-3, §18B-1G-1, §18B-1G-2, §18B-1G-3, §18B-1G-4, §18B-1G-5, and four new sections, designated §18-2-9b, §18-5-29, §18B-14-5, §18B-14-6, relating to the elimination of diversity, equity, and inclusion programs, trainings, activities, offices, and officers from the executive branch, primary and secondary schools, and institutions of higher education of the state.

Senate Bill 475—A Bill to amend the Code of West Virginia, 1931, as amended, by adding a new section, designated §61-7-18, relating to the creation of the Violent Crime Prevention Act; requiring ballistic data be submitted to the National Integrated Ballistic Information Network for alleged use of a firearm in connection with charges for certain crimes; and providing a time frame for law enforcement to submit the data.

Senate Bill 476—A Bill to amend and reenact §31-15A-17c of the Code of West Virginia, 1931, as amended, relating to permissible expenditures by the Water Development Authority from the Infrastructure Fund; modifying the upper limit of funds which may be transferred to sub account; raising the cap on total project costs for certain facilities for use of Critical Needs and Failing Systems Sub Account funding; and allowing the authority to grant infrastructure grant money from the Critical Needs and Failing Systems Sub Account to certain projects for the upgrading of a water facility or wastewater facility to reduce maintenance costs, operations costs, or waterline leakages.

Senate Bill 477—A Bill to amend and reenact §18-2-25c of the Code of West Virginia, 1931, as amended, relating to requiring an ambulance at any middle school or high school football game under the control, supervision, and regulation of the West Virginia Secondary School Activities Commission.

Senate Bill 478—A Bill to repeal §18-2-25e of the Code of West Virginia, 1931, as amended, relating to repealing athletic eligibility of transfer students.

Senate Bill 479—A Bill to amend and reenact §6B-2-2, §6B-3-2, and §6B-3-5 of the Code of West Virginia, 1931, as amended, relating to disclosure forms, statements, and reports of the Ethics Commission; requiring disclosure forms, statements, and reports to be prescribed by procedural rule and made available on the commission website; requiring certain information be included on lobbyist registration form; and requiring reports of expenditures over \$5,000 in grassroots campaigns specify media outlet.

Senate Bill 480—A Bill to amend the Code of West Virginia, 1931, as amended, by adding a new section, designated §18A-2-3a, relating to allowing licensed substitute and full-time teachers to serve as parent volunteers without an additional background check.

Senate Bill 481—A Bill to amend and reenact §61-7-11a of the Code of West Virginia, 1931, as amended, relating to allowing off duty law-enforcement officers to carry concealed weapons in public schools and at public school events.

Senate Bill 482—A Bill to amend the Code of West Virginia, 1931, as amended, by adding a new article, designated §30-44-1, §30-44-2, §30-44-3, §30-44-4, §30-44-5, §30-44-6, §30-44-7, §30-44-8, §30-44-9, §30-44-10, §30-44-11, §30-44-12, and §30-44-13, relating to creating the Certified Professional Midwife Licensing and Regulation Act.

Referred to the Committee on Government Organization.

By Senators Woodrum and Oliverio:

Senate Bill 483—A Bill to amend and reenact §3-8-7 of the Code of West Virginia, 1931, as amended, relating to increasing the civil penalties for failure to file required campaign finance reports, or filing grossly incomplete or grossly inaccurate campaign finance reports, from \$10 per day to a maximum of \$500 for the first violation, and \$1,000 per report for each subsequent violation; requiring notice to be provided to any political committees violating the filing requirements prior to assessing any civil fines; giving the Secretary of State authority to grant additional time for compliance not to exceed an additional 14 days; authorizing the Secretary of State to negotiate and enter into settlement agreements for payment of the civil penalty, including but not limited to, entering into an installment payment plan; and requiring the Secretary of State to refer any civil penalties that remain outstanding for a period greater than 30 days to a debt collection agency or similar other responsible agent for collection.

Senate Bill 484—A Bill to amend the Code of West Virginia, 1931, as amended, by adding a new section, designated §3-8-12a, relating to disclosures and penalties associated with the use of synthetic media and artificial intelligence.

Senate Bill 485—A Bill to amend and reenact §5A-3-1 of the Code of West Virginia, 1931, as amended, relating to the Purchasing Division; and exempting the Secretary of State from the competitive bidding process for specific purchases of securing, facilitating, or supporting critical election infrastructure.

Senate Bill 486—A Bill to amend and reenact §3-1-3 of the Code of West Virginia, 1931, as amended, relating to clarifying the eligibility requirements to vote in West Virginia elections.

Senate Bill 487—A Bill to amend and reenact §3-2-25 of the Code of West Virginia, 1931, as amended, relating to systematic purging program and additional systematic confirmation procedure for the removal of ineligible voters from active voter rolls; removing obsolete reference to combined voter registration and licensing fund; decreasing the period of voting inactivity from four to two years; and providing an internal effective date.

Senate Bill 488—A Bill to amend and reenact §3-9-9 of the Code of West Virginia, 1931, as amended, relating to clarifying the definition of "electioneering" communications to include buttons, hats, pins, and other campaign paraphernalia, as well as express calls to vote for or against a ballot question; exempting from the definition of "electioneering" educational materials about a ballot question that do not expressly advocate for or against a ballot question; allowing voters to use cellular phones within the electioneering prohibition zone for personal use including a list of candidates or ballot questions the voter intends to support as long as the voter does not engage in electioneering within the prohibited zone; prohibiting taking photos or videos within the prohibited zone or inside the polling place except for the purpose of capturing potential violations of law; and permitting precinct election officials to enforce election laws and maintain law and order inside the prohibited zone, and seek assistance from any law-enforcement officer for that purpose.

Senate Bill 489—A Bill to amend §3-1-50 of the Code of West Virginia, 1931, as amended, relating to prescribing administrative procedures and ultimate disposition of election law violation complaints and investigations thereof by the Secretary of State.

Senate Bill 490—A Bill to amend the Code of West Virginia, 1931, as amended, by adding a new section, designated §3-1-52, relating to prohibiting ranked-choice voting in elections in West Virginia.

Senate Bill 491—A Bill to amend and reenact §3-8-2 of the Code of West Virginia, 1931, as amended, relating to expanding the time frame for certain independent expenditure reporting requirements from 15 to 30 days; reducing the spending threshold for reporting independent expenditures made for any statewide, legislative, or multicounty judicial candidate from \$5,000 to \$1,000; reducing the spending threshold in the aggregate for independent expenditures from \$10,000 to \$2,500; and requiring both written and spoken disclaimers on certain digital communications.
