Charleston, West Virginia, Friday, March 21, 2025

The Senate met at 10:08 a.m.

(Senator Smith, Mr. President, in the Chair.)

**Eng. Com. Sub. for House Bill 2056**—A Bill to amend and reenact §1-1-4 and §49-4-701 of the Code of West Virginia, 1931, as amended; and to amend said code by adding a new section designated §1-1-6, relating to concurrent juvenile jurisdiction on military installations; addresses

concurrent juvenile jurisdiction and allowing the transfer of exclusive federal legislative jurisdiction back to the state with respect to juveniles.

Sub. for House Bill 3024**—A Bill to amend and reenact §18B-14-2 of the Code of West Virginia, 1931, as amended, relating to the guaranteed transfer of credit for courses completed in career pathways between high schools, career and technical education centers, community and technical colleges and baccalaureate institutions, establishing a statewide guaranteed transfer and articulation advisory committee; setting forth membership of the advisory committee; allowing for subcommittees; requiring the commission and the council to oversee the development of a statewide articulation and guaranteed transfer agreement and setting forth parameters therefore; requiring the commission and the council, in collaboration with the advisory committee, to develop, coordinate, and maintain guaranteed degree transfer pathways for selected baccalaureate programs and the parameters therefore; setting forth additional requirements for guaranteed statewide transfer pathways; and requiring the commission and council to propose rules for legislative approval.

**Senate Bill 864**—A Bill to amend and reenact §61-3-11 of the Code of West Virginia, 1931, as amended, relating to crimes against property; and clarifying the inference of criminal intent in a burglary prosecution.

#### By Senator Chapman:

**Senate Bill 865**—A Bill to amend the Code of West Virginia, 1931, as amended, by adding a new section, designated §49-4-611, relating to the best interests of the child standard; establishing that the best interests of the child shall be the paramount consideration in all decisions made by specific state entities and individuals; providing that it is a comprehensive assessment; laying out the factors to assess; providing that all policies must be consistent with this principle; providing for review and appeal of decisions; and providing that guardian ad litem must advocate solely for the best interest of the child.

Referred to the Committee on Health and Human Resources; and then to the Committee on the Judiciary.

#### By Senator Grady:

**Senate Bill 866**—A Bill to amend the Code of West Virginia, 1931, as amended, by adding a new section, designated §18-5-22f, relating to requiring the West Virginia Board of Education to promulgate a legislative rule in consultation with the West Virginia Board of Physical Therapy, that governs concussion protocol, education, and training to prevent concussions and the development of a Concussion Education Prevention and Response Plan; allowing the West Virginia Board of Physical Therapy to provide a draft rule; specifying to whom the rule applies; requiring initial rule to comply with certain concussion-related code; allowing recommendation for code to be amended or repealed; requiring rule to specify individuals who are to receive concussion-related education; and requiring a school to adopt a Concussion Education, Prevention, and Response Plan in accordance with the rule.

#### By Senator Helton:

**Senate Bill 867**—A Bill to amend and reenact §9-5-29a of the Code of West Virginia, 1931, as amended, relating to requiring the Bureau for Medical Services to make necessary filings and obtain licensures and accreditation by July 1, 2025; and requiring compliance for certain substance use disorder treatment facilities by an earlier date to accommodate the need for such facilities.

#### By Senator Stuart:

**Senate Bill 868**—A Bill to amend the Code of West Virginia, 1931, as amended, by adding a new section, designated §17A-10-3d; and by adding a new article, designated §17C-16A-1, §17C-16A-2, §17C-16A-3, §17C-16A-4, §17C-16A-5, §17C-16A-6, §17C-16A-7, and §17C-16A-8; and to repeal §17C-16-1, §17C-16-2, §17C-16-3, §17C-16-4, §17C-16-5, §17C-16-6, §17C-16-7, §17C-16-8; and §17C-16-9, all relating to removing the requirement of inspections and inspection stickers for non-commercial motor vehicles, trailers, semitrailers, or pole trailers, or any combination thereof; and establishing the West Virginia road security fee added to annual or biennial motor vehicle registrations and renewals for non-commercial motor vehicles, trailers, semitrailers, or pole trailers which shall be allocated to the West Virginia State Police.

**Senate Bill 869**—A Bill to amend Chapter 231, Acts of the Legislature, Regular Session, 1997, by amending section two, relating to members, appointment and officers of the Robert C. Byrd Corridor H Highway Authority; adding three new sections designated three-a, three-b, and three-c, creating the Corridor H Advanced Energy and Economic Corridor Authority; providing for legislative findings; appointing authority members; providing for terms of membership; providing for certain membership and meeting requirements; providing that members are not compensated; providing for certain powers and duties; and requiring annual reporting to the Joint Committee on Government and Finance.

Referred to the Committee on Economic Development; and then to the Committee on Finance.

#### By Senator Rucker:

**Senate Bill 870**—A Bill to amend and reenact §8-1-5a of the Code of West Virginia, 1931, as amended, relating generally to fees imposed by municipalities; prohibiting municipalities participating in the home rule program from imposing new fees on businesses that are already paying the municipality sales tax, hotel motel tax, existing fees for fire or emergency services, or the municipal home rule sales tax; and preserving the ability of businesses to voluntarily remit any new taxes or fees to a municipality by agreement.

On page 1, by striking out all of subsection 2.2. and inserting in lieu thereof a new subsection 2.2. to read as follows:

2.2. A person who is 18 years of age or older must be at each rented campsite and is responsible for the actions and safety of all campsite occupants and shall be held liable for any damages caused by campsite occupants. Except that, at the discretion of the area superintendent, adjacent campsites occupied by youth organization groups may be considered supervised by a single person who is 18 years of age or older.;

And,

On page 2, by striking out all of subsection 2.5. and inserting in lieu thereof a new subsection 2.5. to read as follows:

2.5. No more than two motor vehicles are permitted on a campsite at any time. No more than one camping unit (tent, trailer, motor home, camper van, etc.) is permitted on a campsite; *Provided*, That a family camping group or youth organization group, at the discretion of the area superintendent, may be permitted to have one or two small tents on its campsite in addition to the main camping unit: *Provided*, *however*, That the additional units may not be ecologically detrimental to the campsite. For purposes of this section, a family camping group is defined as a parent or guardian and his or her dependent children or other minor children accompanying the adult.
