Minutes for FEBRUARY 06, 2020, 3:00 PM

Pursuant to the call of the Chair, the Senate Committee on Finance met on February 06, 2020, 3:00 PM in Room 451-M.

A silent roll call being taken, the presence of a quorum was established.

On motion of Senator Tarr, the minutes of the previous meeting were approved.

The Chairman announced the SB 285 – Eliminating WV Greyhound Breeding Development Fund was being removed from this afternoon's agenda. The Chairman then announced that there would a meeting with all interested parties in the bill tomorrow, February 7, 2020 at 3:00 pm in the Senate Finance Committee room.

SB 180 – Relating to Second Chance Driver's License Program

The Chairman recognized Jeff Johnson, Counsel to the Senate Finance Committee, to explain the bill and to answer questions from the committee. Vice-Chairman Tarr was recognized to move adoption of SB 180 with the recommendation that it do pass. The Chairman put the questions on the motion and declared the motion adopted.

SB 545 – Authorizing transfer of moneys from Insurance Commission Fund to Workers' Compensation Old Fund



Vice-Chairman Tarr was recognized to move adoption of the SB 545 with the recommendation it do pass. The Chairman put the question on the motion and declared the motion adopted.

SB 571 – Expiring funds from State Excess Lottery Revenue Fund to various accounts

Chairman Blair recognized Chris DeWitte, Budget Analyst to the Senate Finance Committee, to explain the bill and the draft committee substitute and to answer questions from the committee. Vice-Chairman Tarr was recognized to move adoption of the committee substitute. The Chairman put the question on the motion and declared the committee substitute adopted. The Vice-Chairman was again recognized to move adoption of Committee Substitute for SB 571 with the recommendation it do pass. The Chairman put the question on the motion and declared the motion adopted.

There was no further business to come before the committee.
