### **Committee on Health and Human Resources**

**Minutes for JANUARY 30, 2020, 1:00 PM**

Pursuant to the call of the Chair, the Senate Committee on Health and Human Resources met on January 30, 2020, 1:00 PM in Room Room.

Members present: Senators Maroney, Tarr, Azinger, Maynard, Roberts, Rucker, Takubo, Weld, Palumbo, Plymale, Prezioso, Stollings

Members absent: Senators Unger

A silent roll call being taken, the presence of a quorum was established.

On motion of Senator Tarr, the minutes of the previous meeting were approved.

Chairman Maroney recognized Cindy Dellinger, Counsel, Senate Committee on Health and Human Resources, who presented Senate Bill 560 along with a Committee Substitute permitting nursing home use trained individuals administer medication. Chairman Maroney recognized Senator Stollings who requested unanimous consent to withdraw his previous amendment in a prior meeting. The Chairman put the question on the motion. The motion to withdraw the amendment was adopted. Chairman Maroney recognized Vice-Chairman Tarr who moved to accept the language of the Committee Substitute for SB560, as presented by counsel. The Chairman put the question on the motion. The motion was adopted. Chairman Maroney again recognized Vice-Chairman Tarr who moved that the Committee Substitute for SB560 be reported to the full Senate with recommendation that it do pass. The Chairman put the question on the motion. The motion was adopted.

Chairman Maroney recognized Cindy Dellinger, Counsel, Senate Committee on Health and Human Resources, who presented Senate Bill 269 along with a Committee Substitute, establishing advisory council on rare diseases. Chairman Maroney recognized Vice-Chairman Tarr who moved to accept the language of the Committee Substitute for SB269, as presented by counsel. The Chairman put the question on the motion. The motion was adopted. Chairman Maroney again recognized Vice-Chairman Tarr who moved that the Committee Substitute for SB269 be reported with recommendation that it do pass, but under the original double committee reference, first be referred to the Committee on Government Organization. The Chairman put the question on the motion. The motion was adopted.

Chairman Maroney recognized Cindy Dellinger, Counsel, Senate Committee on Health and Human Resources, who presented Senate Bill 544 along with a Committee Substitute authorizing pharmacists and pharmacy interns administer vaccines. Counsel responded to questions from the committee. Chairman Maroney recognized Vice-Chairman Tarr who moved to accept the language of the Committee Substitute for SB544, as presented by counsel. The Chairman put the question on the motion. The motion was adopted. Chairman Maroney again recognized Vice-Chairman Tarr who moved that the Committee Substitute for SB544 be reported

to the full Senate with recommendation that it do pass. The Chairman put the question on the motion. The motion was adopted.

Chairman Maroney recognized Cindy Dellinger, Counsel, Senate Committee on Health and Human Resources, who presented House Bill 4007 along with a Committee Substitute, Born-Alive Abortion Survivors Act. Counsel responded to questions from the committee. Chairman Maroney recognized Vice-Chairman Tarr who moved to accept the language of the Committee Substitute for HB4007, as presented by counsel. The Chairman put the question on the motion. The motion was adopted. Chairman Maroney again recognized Vice-Chairman Tarr who moved that the Committee Substitute for HB4007 be reported with recommendation that it do pass, but under the original double committee reference, first be referred to the Committee on Judiciary. The Chairman put the question on the motion. Vice-Chairman Tarr demanded for a roll call. The demand was sustained. Roll call was taken by the Committee Clerk reflecting 11 yea votes, 1 nay vote and 1 Senator was absent. Specifically, Senators Azinger, Maynard, Plymale, Prezioso, Roberts, Rucker, Stollings, Takubo, Tarr, Weld and Maroney voted yea; Senator Palumbo voted nay; Senator Unger was absent. The motion was adopted.



Chairman Maroney again recognized Vice-Chairman Tarr who moved that the Committee Substitute for SB291 be reported with recommendation that it do pass, but under the original double committee reference, first be referred to the Committee on Finance. The Chairman put the question on the motion. The motion was adopted.

There being no further business to come before the committee, the Chairman recognized Senator Tarr.
