### Committee on Health and Human Resources

Minutes for January 25, 2024, 1:00 PM

Pursuant to the call of the Chair, the Senate Committee on Health and Human Resources met on January 25, 2024, 1:00 PM in Room 451-M.

Members present: Senators Maroney, Takubo, Azinger, Chapman, Deeds, Grady, Hamilton, Hunt, Jeffries, Plymale, Roberts, Rucker, Tarr, Weld

Members absent: None

A silent roll call being taken, the presence of a quorum was established.

On motion of Senator Takubo, the minutes of the previous meeting were approved.

Chairman Maroney recognized Ryan Vick, Counsel, Senate Health and Human Resources, who explained Senate Bill 313 and the committee substitute. Counsel answered questions from the Committee. Chairman Maroney recognized Senator Chapman, who moved to amend Senate Bill 313. By voice vote, the amendment was adopted. The language of the committee substitute was agreed to, as amended. Vice-Chair Takubo moved that the Committee Substitute for Senate Bill 313 be reported to the full Senate with recommendation that it do pass, but under the original double committee reference, first be referred to the Committee on Finance. The motion carried.

Chairman Maroney recognized Cindy Dellinger, Counsel, Senate Health and Human Resources who explained Senate Bill 474 and the committee substitute. The language of the committee substitute was agreed to. Vice-Chair Takubo moved that the Committee Substitute for Senate Bill 474 be reported to the full Senate, with recommendation that it do pass. The motion carried.


