### **Committee on Health and Human Resources**

**Minutes for March 27, 2025, 1:00 PM**

Pursuant to the call of the Chair, the Senate Committee on Health and Human Resources met on March 27, 2025, 1:00 PM in Room 451-M.

Members present: Senators Chapman, Deeds, Azinger, Bartlett, Grady, Maynard, Roberts, Rose, Rucker, Takubo, Taylor, Willis, Garcia

Members absent: Senators Martin, Queen

A silent roll call being taken, the presence of a quorum was established.

On motion of Senator Deeds, the minutes of the previous meeting were approved.

Senator Chapman recognized Cindy Dellinger, Counsel, Senate Health and Human Resources, who explained Senate Bill 810 and the committee amendment. Senator Deeds moved the amendment as explained by Counsel. By voice vote, the amendment was adopted. Senator Deeds moved that Senate Bill 810 be reported to the full Senate with recommendation that it do pass, as amended. The motion carried.

Senator Chapman recognized Jenna Fonner, Counsel, Senate Health and Human Resources, who explained Senate Bill 886. Senator Deeds moved that Senate Bill 886 be reported to the full Senate with recommendation that it do pass. The motion carried.

Senator Chapman recognized Cindy Dellinger, Counsel, Senate Health and Human Resources, who explained Senate Bill 517. Senator Deeds moved that Senate Bill 517 be reported to the full Senate with recommendation that it do pass. The motion carried.

Senator Chapman recognized Cindy Dellinger, Counsel, Senate Health and Human Resources, who explained Senate Bill 904 and the committee substitute. The language of the committee substitute was agreed to. Senator Deeds moved that the Committee Substitute for Senate Bill 904 be reported to the full Senate with recommendation that it do pass. The motion carried.

Senator Chapman recognized Cindy Dellinger, Counsel, Senate Health and Human Resources, who explained Senate Bill 873. Counsel answered questions from the Committee. Senator Garcia offered a conceptual amendment. Counsel understood the amendment. By voice vote, the amendment was adopted. The language of the committee substitute was agreed to. Senator Deeds moved that the Committee Substitute for Senate Bill 873 be reported to the full Senate with recommendation that it do pass, but under the original double committee reference, first be referred to the Committee on Finance. The motion carried.

Senator Chapman recognized Jenna Fonner, Counsel, Senate Health and Human Resources, who explained Senate Bill 632 and the committee substitute. Counsel answered questions from the Committee.

With leave of committee, Senator Chapman recognized Mike Thomas and administered the oath pursuant to Senate Rule 28a. Dr. Thomas answered questions from the Committee.

The language of the committee substitute was agreed to. Senator Deeds moved that the Committee Substitute for Senate Bill 632 be reported to the full Senate with recommendation that it do pass, but under the original double committee reference, first be referred to the Committee on Finance. The motion carried.


