The Board of Education's mishandling of our submitted paperwork has caused an unnecessary delay in funding for the Hope Scholarship. This kind of oversight is unacceptable, as it directly impacts students and families relying on these funds for their education. We need better accountability and efficiency to ensure this doesn't happen again. We have had multiple occurrences with our local Board of Education, where we have submitted paperwork or end of your assessments and we have email confirmation of receipt. But none of that matters because in the weeks or months following they report they never received it and our funding was withdrawn for the Hope scholarship. When I called the Board of Education to send them the receipt that we had submitted it, they said there was an error in their system but it did not change that my son's funding was put on hold for more than 30 days. This also did not change the report they submitted to the West Virginia Board of Education, stating all of the noncompliance related to homeschooling, when in reality, it was an error on the Board of Education part. This story as well as many other others is a reason why the local board of education cannot be trusted to handle and to be the sole reporter of Homeschool/hopeschool compliance.

To the Honorable Members of the West Virginia Legislature,

I write to express my strong opposition to House Bill 2777 as currently written. While I respect the intent to provide families with greater educational choices, this bill significantly reduces oversight for homeschooled students, learning pods, and microschools—potentially putting West Virginia’s most vulnerable children at risk.

### Concerns Regarding Child Safety and Well-Being

1. Weakening Local Oversight Increases the Risk of Abuse and Neglect
  - Schools serve as mandatory reporters for child abuse and neglect. Teachers, school counselors, and staff are often the first line of defense in identifying and intervening when children are in unsafe situations.
  - By reducing reporting requirements and eliminating regular check-ins with the local county board of education, this bill makes it easier for children to disappear from the system with no oversight, potentially leading to tragic consequences, including abuse, neglect, and even death.
2. At-Risk Children Will Lose Access to Essential Services
  - Many children in West Virginia depend on public schools for meals, medical referrals, and mental health support.
  - Without structured oversight, there is no guarantee that children who are homeschooled or placed in alternative education settings will receive basic nutrition, healthcare, or intervention services when needed.
3. Lack of Accountability for Educational Progress
  - While parental rights are important, we must ensure that children receive an adequate education.

- By removing certain academic reporting requirements and reducing assessment submissions, HB 2777 creates the potential for children to be left uneducated without intervention.
4. Increased Risk for Children with Disabilities
- The bill allows special education students to be placed in homeschooling, learning pods, and microschools without clear safeguards ensuring they receive proper support services.
  - If oversight is removed, children with disabilities may lose access to critical therapies and accommodations, setting them further behind their peers.

## **Recommended Amendments to Ensure Child Safety**

While I oppose HB 2777 in its current form, I urge lawmakers to consider the following amendments to balance educational freedom with child protection:

1. Mandatory Welfare Check-Ins for Homeschooled and Alternative Education Students
  - Require an annual in-person meeting with a designated school official, county board representative, or social services professional for all students not enrolled in a traditional school.
  - Ensure that homeschooled and microschool students are seen by a trusted adult outside the home at least once a year.
2. Preserve Accountability Measures for Academic Progress
  - Maintain annual assessment submissions for all students, rather than limiting reporting to grades 3, 5, 8, and 11.
  - Require documentation of regular instruction to ensure children are being educated at an appropriate level.
3. Ensure Children Retain Access to Critical Public School Services
  - Allow homeschooled, microschool, and learning pod students to receive free or reduced-price meals at public schools if they qualify.
  - Ensure access to mental health resources, special education services, and medical referrals for all children, regardless of their educational setting.
4. Enhance Oversight for Families with a History of Abuse or Educational Neglect
  - Require additional home visits or monitoring for families with a documented history of child abuse, neglect, or truancy violations before allowing home instruction exemptions.
  - Allow the county superintendent to impose stricter oversight in cases where a child's welfare is at risk.

## **Conclusion**

HB 2777, as written, removes critical protections that help ensure West Virginia's children are safe, fed, and receiving a proper education. While I support parental choice in education, we cannot pass a bill that opens the door for neglect and harm to go unnoticed. I urge lawmakers to reject this bill in its current form and instead amend it to prioritize both educational freedom and child safety.
