Please reject SB 592, which puts our drinking water at risk. This bill undermines progress made via the Aboveground Storage Tank Act following the 2014 water crisis.

SB 592 weakens the protections enacted after MCHM leaked into the Elk River contaminating the drinking water of over 300,000 people. The very type of tank that caused this crisis will be deregulated with this bill. Only 11 percent of aboveground storage tanks are currently regulated across the state. The bill brings the percentage down to just 8.7 percent removing upwards of 1,000 more tanks located upstream from water intakes from required inspections under current law.
