COURT OF CLAIMS

ABSTRACTS OF CLAIMS AWARDED

CLAIM AGAINST DEPARTMENT OF ADMINISTRATION

CC-01-0451 EMMANUEL TSITSILIANOS, dba INTERNATIONAL RESTORATION SPECIALISTS V. DEPARTMENT OF ADMINISTRATION

Claimant brings this claim for \$108,800.00 in damages stemming from a State contract with Claimant for restoration and gold leafing of the State Capitol dome in Charleston. Claimant performed work pursuant to the parties' 1986 contract, and following its completion in 1991, Claimant submitted change orders for additional work done to the dome. The change orders included a request for \$108,000.00. Claimant received a payment voucher in 1992 in the amount of \$36,500.00 toward that sum, but testified that he never signed the voucher based upon his belief that doing so would waive the full amount of his claim. The project engineer had informed Claimant that the reduced payment amount was due to an unexpected time extension for completion. The Court found that Claimant's delay in prosecuting the present claim was prejudicial to Respondent, and that Claimant failed to offer any documentation supporting his claims regarding the 1992 voucher. The Court granted an award in the amount of \$36,500.00, which total had been approved by Respondent's agent but was never paid to Claimant.

AMOUNT CLAIMED: \$205,888.22 AMOUNT AWARDED: \$36,500.00

CLAIM AGAINST DEPARTMENT OF EDUCATION

CC-15-1734 COLYAR CONSULTING GROUP V. DEPARTMENT OF EDUCATION

Claimant seeks to recover \$2,000.00 for services rendered to Respondent and documented by an unpaid invoice. Respondent admitted the validity and amount of the claim, and stated that sufficient funds were allocated in the appropriate fiscal year from which the invoice could have been paid.

AMOUNT CLAIMED: \$2,000.00 AMOUNT AWARDED: \$2,000.00

CLAIMS AGAINST DIVISION OF CORRECTIONS

CC-13-0111 WILTON FREDERICK BLAND V. DIVISION OF CORRECTIONS

Claimant, an inmate at Huttonsville Correctional Center at the time of the incident, seeks to recover \$510.52 for personal property items that were taken from his cell and never returned to him. The Court found that the parties had created a bailor/bailee relationship with respect to Claimant's property, and that Respondent breached its duty to ensure that inmates' personal property was secure from theft.

AMOUNT CLAIMED: \$510.52 AMOUNT AWARDED: \$510.52

CC-13-0349 LLOYD DALE BUCKHANNON V. DIVISION OF CORRECTIONS

Claimant, an inmate at Mount Olive Correctional Center at the time of the incident, seeks to recover \$682.94 for personal property items that he alleges were converted by Respondent while Claimant was in punitive segregation. The Court found that the parties had created a bailor/bailee relationship with respect to Claimant's property upon Claimant's entry into segregation, and that Respondent failed to return all of Claimant's items to him upon his return to general population. The Court found that an award of 50% of the claimed total was a fair and reasonable resolution of the claim.

AMOUNT CLAIMED: \$682.94 AMOUNT AWARDED: \$341.47

CC-13-0460 KENNETH E. CHANCE JR. V. DIVISION OF CORRECTIONS

Claimant, an inmate at Northern Correctional Center at the time of the incident, seeks to recover \$7.08 for envelopes he alleges were improperly confiscated and destroyed by Respondent. Claimant argues that he was incorrectly advised by a counselor at intake that the envelopes in question were permitted at the facility, and Respondent's officers subsequently destroyed them pursuant to facility policy. The Court found that there was no evidence Claimant was properly notified of the contraband policy, and that Respondent improperly disposed of the items prior to completion of the grievance procedure.

AMOUNT CLAIMED: \$7.08 AMOUNT AWARDED: \$7.08

CC-13-0138 STEPHEN FIELDER V. DIVISION OF CORRECTIONS

Claimant, an inmate at Mount Olive Correctional Complex at the time of the incident, seeks to recover \$508.36 for personal property items he alleges were removed from his cell while he was away. The Court found that the parties had created a bailor/bailee relationship with respect to Claimant's items, and Respondent breached its duty to ensure that Claimant's single-person cell was secure pursuant to facility protocol.

AMOUNT CLAIMED: \$508.36 AMOUNT AWARDED: \$508.36

CC-13-0180 MARK F. HANNA V. DIVISION OF CORRECTIONS

Claimant, an inmate at Mount Olive Correctional Complex at the time of the incident, seeks to recover \$201.32 for food items he alleges were improperly confiscated and disposed of by Respondent during Claimant's time in solitary confinement. The Court found that the parties had created a bailor/bailee relationship with respect to Claimant's food items, and Respondent breached its duty to follow established food confiscation procedures.

AMOUNT CLAIMED: \$201.32 AMOUNT AWARDED: \$201.32

CC-13-0202 MARK F. HANNA V. DIVISION OF CORRECTIONS

Claimant, an inmate at Mount Olive Correctional Complex at the time of the incident, seeks to recover \$139.49 for basketball shoes and other items he alleges were missing from his cell upon his return from solitary confinement. The Court found that the parties had created a bailor/bailee relationship with respect to Claimant's property, and Respondent breached its duty to follow established personal property security procedures.

AMOUNT CLAIMED: \$139.49 AMOUNT AWARDED: \$139.49

CC-13-0334 MARK F. HANNA V. DIVISION OF CORRECTIONS

Claimant, an inmate at Mount Olive Correctional Complex at the time of the incident, seeks to recover \$24.00 for food items he alleges were converted by Respondent while Claimant was in punitive segregation. The Court found that Claimant had ordered the food as part of a fund-raiser prior to his segregation, and Respondent failed to deliver Claimant's items or otherwise refund him as it did similarly situated inmates.

AMOUNT CLAIMED: \$24.00 AMOUNT AWARDED: \$24.00

CC-12-0326 RICHARD KARTMAN V. DIVISION OF CORRECTIONS

Claimant, an inmate at Northern Correctional Center at the time of the incident, seeks to recover \$209.38 for personal property items he alleges were lost by Respondent while Claimant was being transferred from another Respondent facility. The Court found that the parties had created a bailor/bailee relationship with respect to Claimant's property during transport, and Respondent breached its duty to correctly inventory Claimant's items and return them following his arrival at Northern Correctional Center. The Court excluded the value of two bags of coffee from the total award per Respondent's policy.

AMOUNT CLAIMED: \$209.38 AMOUNT AWARDED: \$203.38

CC-12-0422 CHARLES LATIMER V. DIVISION OF CORRECTIONS

Claimant, an inmate at Mount Olive Correctional Complex at the time of the incident, seeks

to recover \$180.00 for a television set he alleges was broken in Respondent's storage area while Claimant was in punitive segregation. The Court found that the parties had created a bailor/bailee relationship with respect to the television, and Respondent breached its duty to ensure the items confiscated from inmates pursuant to established procedures are secure and sufficiently preserved until they are returned to the inmate.

AMOUNT CLAIMED: \$180.00 AMOUNT AWARDED: \$180.00

CC-12-0481 WILLIAM W. MCCALLISTER V. DIVISION OF CORRECTIONS

Claimant, an inmate at Northern Correctional Center at the time of the incident, seeks to recover \$147.41 for a television that he alleges was damaged by Respondent's corrections officers during a routine search of the inmate housing area. The Court found that the parties had created a bailor/bailee relationship with respect to Claimant's property, and Respondent breached its duty to return Claimant's lawfully possessed property to him in its prior condition following the cell search. The Court granted an award less than the claimed amount, accounting for depreciation of the television prior to the damage.

AMOUNT CLAIMED: \$147.41 AMOUNT AWARDED: \$130.00

CC-13-0055 LAWRENCE STUCKEY V. DIVISION OF CORRECTIONS

Claimant, an inmate at Mount Olive Correctional Complex at the time of the incident, seeks to recover \$200.00 for a television he alleges was confiscated by Respondent and was damaged upon its return to him. Respondent admits the validity of the claim and agrees that the amount claimed is fair and reasonable.

AMOUNT CLAIMED: \$200.00 AMOUNT AWARDED: \$200.00

CC-13-0050 DANNY SUMMERFIELD V. DIVISION OF CORRECTIONS

Claimant, an inmate at St. Mary's Correctional Center at the time of the incident, seeks to recover \$21.00 for a pair of headphones he alleges were missing from his cell following a routine search of the inmate housing area by Respondent's corrections officers. The Court found that the parties had created a bailor/bailee relationship with respect to Claimant's property, and Respondent breached its duty to ensure that Claimant's personal items, though subject to a thorough search, were secure and accounted for upon completion.

AMOUNT CLAIMED: \$21.00 AMOUNT AWARDED: \$21.00

CC-15-1477 EDWIN L. WRIGHT V. DIVISION OF CORRECTIONS

Claimant, an inmate at Mount Olive Correctional Center at the time of the incident, seeks to recover \$7.99 for items of personal property he alleges were broken by staff during a search of

the facility. In its Answer, Respondent admits the validity of the claim and agrees that the amount claimed is fair and reasonable.

AMOUNT CLAIMED: \$7.99 AMOUNT AWARDED: \$7.99

CLAIMS AGAINST THE DIVISION OF HIGHWAYS

<u>CC-14-1358 SHARON BELCHER AND ARTHUR BELCHER V. DIVISION OF</u> HIGHWAYS

The parties stipulated as follows: On May 28, 2013, the Claimants were involved in a head-on collision with another vehicle on the bridge on Route 47 near Elkview, Kanawha County. The Claimants allege that the accident was caused at least in part by obstructions on both sides of the bridge. Respondent was responsible for the maintenance of the bridge on Route 47, and for purposes of settlement alone acknowledges some culpability for the incident. An award of \$30,000.00 is a fair and reasonable amount to settle the claim.

AMOUNT CLAIMED: \$1,000,000.00 AMOUNT AWARDED: \$30,000.00

CC-14-1252 BRIAN BLAKE V. DIVISION OF HIGHWAYS

Claimant, Brian Blake, brought this action for vehicle damage which occurred when his 2006 BMW 330xi was hit by a rock, then struck a large hole while he was traveling along Interstate 70 in Wheeling, Ohio County. Respondent admitted liability with respect to damage caused by the hole, but argued that it had no notice of the rock in the road. Claimant's insurance required a \$500.00 deductible per incident. In the instant case, the Court is of the opinion that Respondent had, at the least, constructive notice of both the hole in the road and broken pavement in and around the hole, which could foreseeably loosen and further endanger motorists. Since the condition of the road created a hazard to the traveling public, the Court finds that Respondent was negligent. Thus, Claimant may make a recovery for the damage to his vehicle.

AMOUNT CLAIMED: \$1,218.53 AMOUNT AWARDED: \$707.72

CC-14-1240 DEBORAH DOWLER V. DIVISION OF HIGHWAYS

The parties stipulated as follows: Respondent is responsible for the maintenance of Camden Avenue in Parkersburg, Wood County. Claimant alleges that due to the poor maintenance of a culvert located near her property on Camden Avenue, water backed up and flooded her basement.

Respondent has denied liability in this matter, but admitted that the Court of Claims would likely make an award to Claimant should the case proceed to hearing. The parties agree that for this incident, the sum of \$20,716.54 is a fair and reasonable amount to settle the claim.

AMOUNT CLAIMED: \$30,000 AMOUNT AWARDED: \$20,716.54

CC-12-0136 JERRY EDWARD DUNN AND CHARLOTTE R. DUNN V. DIVISION OF HIGHWAYS

Claimants brought this action for vehicle damage which occurred when their 2008 KZ Montego Bay fifth wheel camper struck the roof of a tunnel on Route 14/60 near Caldwell, Greenbrier County. In the instant case, the Court is of the opinion that Respondent had, at the least, constructive notice of the nature of traffic flow through the tunnel as the result of a culvert located therein, and that the incline on one side of the tunnel could present a hazard to the traveling public. Although the signs indicating the height of the tunnel were technically accurate, Respondent failed to notify motorists of the unusual traffic pattern caused by the culvert or of the incline immediately on one end of the tunnel. Thus, there is sufficient evidence of negligence by Respondent upon which to base an award. However, the Court further finds that Claimants had some responsibility to visually inspect the tunnel in relation to their large vehicle before deciding to pass through. Since the negligence of the Claimants, which equals 20% of their loss, is not greater than or equal to the negligence of the Respondent, Claimants may recover 80% of the loss sustained. Claimants' insurance required a \$1,000.00 deductible.

AMOUNT CLAIMED: \$3,730.50 AMOUNT AWARDED: \$800.00

CC-14-0749 NANCY ELLIOTT V. DIVISION OF HIGHWAYS

Claimant brought this action for vehicle damage which occurred when her 2006 Audi TT was struck by a piece of loose asphalt on County Route 88/2 in Morgantown, Monongalia County, near a construction zone. Claimant's insurance policy required a \$1,000.00 deductible at the time of the incident. In the instant case, the Court is of the opinion that Respondent had, at the least, constructive notice that the road was in disrepair, and that pieces of asphalt could loosen and break away from the road. The Court therefore finds that Respondent was negligent, and Claimant is entitled to an award. The Court is aware that Respondent's agreement with a third-party contractor performing construction work on the road contained an indemnity provision; thus, Respondent may seek to be reimbursed from the third-party contractor for any damages arising from this claim.

AMOUNT CLAIMED: \$12,000.00 AMOUNT AWARDED: \$1,000.00

CC-14-1168 TABATHA N. HARRISON V. DIVISION OF HIGHWAYS

The parties stipulated as follows: On July 1, 2014, Claimant was walking along Purdy Drive in Charleston, Kanawha County, when she tripped on a hole in the road. Claimant stated that the pavement then caved in and her leg became wedged under a piece of the road. Claimant suffered bruises and pain in her leg, and incurred medical charges as a result of the incident; however,

Claimant was never asked to pay any medical expenses out of pocket, and the Court finds that based on the documentation provided, the entirety of Claimant's medical charges were covered by Medicare and/or Medicaid. Because Respondent was responsible for the maintenance of Purdy Drive, which it failed to maintain properly on the date of the incident, Respondent was negligent. The Court finds that Claimant is entitled to an award as compensation for her pain and suffering.

AMOUNT CLAIMED: \$15,000.00 AMOUNT AWARDED: \$500.00

<u>CC-15-0279 DAVID HOLLEY AND LINDA LOUISE HOLLEY V. DIVISION OF</u> HIGHWAYS

The parties stipulated as follows: On March 31, 2014, Claimants were traveling on Davis Branch Road near Prichard, Wayne County, when the asphalt beneath their vehicle shifted, causing damage to the vehicle. Respondent was responsible for the maintenance of this area, which it failed to maintain properly on the date of the incident. As a result, Claimants' vehicle sustained damage in the amount of \$2,938.74. Claimants' insurance required a \$500.00 deductible; therefore, the Claimants are limited to an award equal to that amount. The sum of \$500.00 is fair and reasonable to resolve the claim.

AMOUNT CLAIMED: \$2,938.74 AMOUNT AWARDED: \$500.00

CC-13-0225 MICHAEL E. LASURE V. DIVISION OF HIGHWAYS

Claimant brought this action for the cost of adjustments to a concrete pad near his residence, which he alleges were necessitated by Respondent's negligent maintenance of the road intersecting Claimant's property. The evidence established that the surface of Route 89 near New Martinsville, Wetzel County, was raised significantly following re-paving work performed by a contractor, with Respondent's approval. The Court's in-person visual inspection of the property confirmed Claimant's statements regarding the extreme height difference between the road and Claimant's parking pad, resulting in Claimant's inability to access the pad in a standard-sized automobile. Because Respondent's actions interfered with Claimant's entrance and access rights to his property without his consent, the Court finds that Respondent is negligent and Claimant is entitled to recover the cost of raising and rebuilding the concrete pad.

AMOUNT CLAIMED: \$33,920.00 AMOUNT AWARDED: \$33,920.00

CC-13-0610 MANDY LEGG, Executrix of the Estate of JASON LEGG V. DIVISION OF HIGHWAYS

The parties stipulated as follows: Claimant's husband, Jason Legg, was traveling on Little Blue Creek Road in Procious, Kanawha County, when his vehicle hydroplaned on water in the road and went over an embankment. No guardrail was in place in the area, which was known by Respondent to be potentially dangerous. Mr. Legg was killed as a result of the incident. Respondent

was responsible for the maintenance of Little Blue Creek Road, which it failed to maintain properly on the date of the incident. The parties agree that an award in the amount of \$300,000.00 would be fair and reasonable to resolve the claim.

AMOUNT CLAIMED: \$500,000.00 AMOUNT AWARDED: \$300,000.00

CC-14-1592 DAVID W. MCDANIEL V. DIVISION OF HIGHWAYS

Claimant seeks to recover \$2,439.50 in damages to his 2001 Mercury Cougar, which was struck by a rock while traveling on an entrance ramp to Interstate 64 near South Charleston, Kanawha County. In the instant case, the Court finds that the Respondent had at least constructive notice that rocks were likely to fall in the area in question, and had failed to place signs warning motorists of the potential hazard. The Court granted an award of \$435.00, which was the total amount necessary to replace Claimant's windshield.

AMOUNT CLAIMED: \$2,439.50 AMOUNT AWARDED: \$435.00

CC-13-0480 JOHN P. MCPHAIL III V. DIVISION OF HIGHWAYS

Claimant brought this action for damage to his residence on Nunley Drive in Charleston, Kanawha County, which he alleges occurred as a result of Respondent's negligent maintenance of a drainage system. Claimant alleges that a State-maintained culvert near his property became clogged with debris, causing flooding on his property during heavy rains, large sinkholes in his yard, and damage to his carport, driveway and buildings. The Court in the instant case finds that the flooding problems were indeed caused by Respondent's failure to adequately maintain the drainage system. Despite Respondent's placement of a pipe in the culvert with an identical pipe, the flooding was not remedied until a larger pipe was installed three years later, after frequent, repeated contact from Claimant and significant damage sustained. Thus, Claimant may recover the cost of repairing the culvert, as well as compensation for his time and expenses in repairs.

AMOUNT CLAIMED: \$20,000.00 AMOUNT AWARDED: \$18,000.00

CC-13-0596 CURTIS L. MEEKS AND LORA A. MEEKS V. DIVISION OF HIGHWAYS

The parties stipulated as follows: Claimants own residential property located on Kanawha Route 12, also known as Lincoln Drive in Kanawha County. Respondent is responsible for the maintenance of Lincoln Drive, as well as a drainage ditch that runs between Lincoln Drive and Claimants' residence. Claimants experienced slippage of their property toward the ditch line over the course of several years, which caused damage to their real and personal property. Respondent made attempts to remedy the slippage, and for purposes of settlement alone acknowledges some

culpability for the damages to Claimants' property. An award of \$5,000.00 is a fair and reasonable resolution of the claim.

AMOUNT CLAIMED: \$5,000.00 AMOUNT AWARDED: \$5,000.00

CC-14-1082 RHONDA L. MOORE V. DIVISION OF HIGHWAYS

Claimant brought this action for property damage near her former residence on Old Route 7 in Fairmont, Marion County, which she alleges occurred as a result of Respondent's negligent maintenance of a nearby drainage system. Claimant stated that a culvert collapsed in 2013, which caused water to accumulate and wash out her rock driveway on several occasions. Respondent argued that the road in question was constructed solely as an access road for Interstate 79 bridges and is not intended for public use. The Court finds that Respondent received notice from area residents multiple times regarding the collapsed culvert, and Respondent is not absolved of its responsibility to maintain the drainage systems in a reasonable state of repair based solely on the road's intended purpose at construction. Further, Respondent has at times performed work on the road as a result of citizen requests. The Court therefore finds that Respondent was negligent in failing to properly maintain the culvert, and Claimant is entitled to recover her costs for replacing the driveway.

AMOUNT CLAIMED: \$488.64 AMOUNT AWARDED: \$488.64

CC-14-0860 SAMUEL B. PETERS V. DIVISION OF HIGHWAYS

The parties stipulated as follows: On April 20, 2014, Claimant was traveling on Bakerton Road in Bakerton, Jefferson County, when his vehicle struck a hole, causing damage. Respondent is responsible for the maintenance of Bakerton Road, which it failed to maintain properly on the date of the incident. As a result of the incident, Claimant's vehicle sustained damage in the amount of \$848.00, including a \$75.00 towing charge. Claimant's insurance required a \$500.00 deductible; therefore, Claimant's recovery is limited to that amount. An award of \$500.00 is a fair and reasonable resolution of this claim.

AMOUNT CLAIMED: \$848.00 AMOUNT AWARDED: \$500.00

CC-15-0003 DAVID E. POLING V. DIVISION OF HIGHWAYS

The parties stipulated as follows: On November 18, 2014, Claimant was walking along Murdock Avenue in Parkersburg, Wood County, when he tripped on part of a broken road sign that had been left uncovered on the ground following a traffic accident. Claimant fell into the travel portion of the road, injuring his arm and wrist. As a result of the incident, Claimant received medical treatment and was placed in an arm cast for six weeks. Respondent is responsible for the maintenance of Murdock Avenue, which it failed to maintain properly on the date of the incident.

The parties agreed that the amount of \$54.21 for medical expenses was fair and reasonable, and that compensation for pain and suffering was proper, at the Court's discretion. The Court finds that the sum of \$645.79 is a reasonable amount to compensate Claimant for his pain and suffering as a result of the incident.

AMOUNT CLAIMED: \$700.00 AMOUNT AWARDED: \$700.00

CC-14-1232 VICTOR A. PREISER V. DIVISION OF HIGHWAYS

The parties stipulated as follows: On March 11, 2014, Claimant was traveling on Route 817 near Winfield, Putnam County, when his 2004 Chrysler PT Cruiser struck a large hole in the travel portion of the road. Respondent was responsible for the maintenance of Route 817, which it failed to maintain properly on the date of the incident. Claimant's vehicle sustained damage in the amount of \$2,876.42. Claimant's insurance required a \$1,000.00 deductible; therefore, Claimant's recovery is limited to that amount.

AMOUNT CLAIMED: \$2,876.42 AMOUNT AWARDED: \$1,000.00

CC-12-0368 VALERIE ANN RAMSEY V. DIVISION OF HIGHWAYS

Claimant brought this action for injuries she and her dog sustained when Claimant's vehicle was struck by a falling tree limb while traveling on Chenoweth Creek Road near Elkins, Randolph County. The Court finds that Respondent had at least constructive notice that the tree branches overhanging the entirety of the travel portion of Chenoweth Creek Road could pose a risk to the traveling public. Although Respondent had received no prior complaints of downed limbs and has performed no tree removal work in that area, the potential for damage caused by a falling branch was evident in the photographs presented to the Court. The Court finds that based upon the unique set of circumstances in this case, Respondent is liable for the injuries to Claimant and her dog caused by the falling branch.

AMOUNT CLAIMED: \$510.00 AMOUNT AWARDED: \$220.00

CC-14-0957 ELLWOOD W. RYAN AND GLADYS M. RYAN V. DIVISION OF HIGHWAYS

Claimants brought this action for damages to their property which occurred when a tree fell onto a power line near their residence on Triplett Road in Spencer, Roane County, breaking their power pole and electrical box. Respondent admitted that at least a portion of the tree was within Respondent's right of way, and the evidence established that the tree had been dead for a significant period of time. The Court finds that based upon the circumstances in this case, Respondent had at least constructive notice of the dead tree and its potential hazard to the traveling public, and failed to remedy the situation in a timely manner. However, the Court further finds Claimants were

negligent for 20% of their loss by failing to contact Respondent about the danger of a fall until after the incident occurred. Since the negligence of Claimants is not greater than or equal to the negligence of the Respondent, Claimants may recover 80% of their loss sustained.

AMOUNT CLAIMED: \$897.39 AMOUNT AWARDED: \$717.91

CC-14-1202 RONNIE L. SAPP V. DIVISION OF HIGHWAYS

The parties stipulated as follows: On April 20, 2014, Claimant was traveling on Route 100 near Granville, Monongalia County, when his motorcycle struck a hole, causing Claimant to be thrown from the motorcycle. As a result, Claimant suffered both property damage and personal injuries. Respondent denied liability in this matter, but has agreed to settle the claims made by Claimant. The sum of \$34,000.00 is fair and reasonable to resolve this matter.

AMOUNT CLAIMED: \$40,000.00 AMOUNT AWARDED: \$34,000.00

CC-13-0364 MALCOLM SHAFER V. DIVISION OF HIGHWAYS

Claimant brought this action for damages to his property on Withrow Drive in Elkview, Kanawha County. Claimant alleges that several large trucks hauling asphalt traveled over and parked on his small pipe bridge, causing it to buckle and become offset at its joint. The trucks were owned by West Virginia Paving, which was operating as a contractor for Respondent at the time of the incident. The Court finds that pursuant to the valid construction contract, Respondent was responsible for the damaged caused by the contractor. Based upon Respondent's negligence, Claimant is entitled to recovery in the amount of \$10,223.70. Respondent may seek reimbursement for the damages pursuant to the contract's indemnity provision.

AMOUNT CLAIMED: \$10,223.70 AMOUNT AWARDED: \$10,223.70

CC-14-1125 ROBERT H. SHAVER AND CLARICE E. SHAVER V. DIVISION OF HIGHWAYS

Claimants brought this action for property damage near their residence on State Route 20 in Wallace, Harrison County, which they allege occurred as a result of Respondent's negligent maintenance of a drainage system. Claimants assert that water accumulated as a result of clogged pipes, causing Claimants' driveway to wash out. The Court finds that Respondent was barred from performing ordinary, thorough maintenance on the drainage system around Route 20 due to the existence of an illegal connection to Respondent's drain pipe. However, Respondent attempted to remedy the problem by flushing the pipes to the extent it was permitted by law only once in the

years Claimants have lived in their home, despite Respondent's knowledge of the clogged pipes and potential for damage. The Court therefore finds that Respondent negligently failed to maintain the subject pipes within its power, and Claimants are entitled to recover the amount they paid for the initial construction of their driveway, as no documentation of the cost of reconstruction was provided.

AMOUNT CLAIMED: \$3,000.00 AMOUNT AWARDED: \$2,500.00

CC-14-0750 LINN J. SHEIK V. DIVISION OF HIGHWAYS

Claimant brought this action for property damage to a fence near her residence adjacent to Little Vine Drive in Beaver, Raleigh County, which she alleges occurred as a result of Respondent's negligent operation of equipment while clearing a nearby culvert. Although the evidence was conflicting, both parties agreed that Respondent's workers were present cleaning the culvert on the date in question, and the evidence leads the Court to believe that the fence was not damaged prior to Respondent's arrival. The Court therefore finds that Respondent's negligent operation of its equipment led to the damage, and Claimant is entitled to recover the cost of replacing her fence.

AMOUNT CLAIMED: \$1,050.00 AMOUNT AWARDED: \$1,050.00

CC-14-1453 ROBBIE SKULL V. DIVISION OF HIGHWAYS

Claimant brought this action for damages which occurred when his 2013 Chevrolet Silverado struck a barrel while traveling along Interstate 79 near the Mink Shoals exit in Kanawha County. Claimant's vehicle sustained damage in the amount of \$531.48. Claimant's insurance required a \$500.00 deductible at the time of the incident, and Claimant's recovery is therefore limited to that amount. The Court finds that the Respondent had at least constructive notice of the risk posed by unsecured barrels on Interstate 79, and the fact that wind or other forces may have caused the barrels to move into the roadway was a foreseeable event that was not considered by Respondent. The Court therefore finds that Respondent was negligent, and Claimant is entitled to recover his damages.

AMOUNT CLAIMED: \$531.48 AMOUNT AWARDED: \$500.00

CC-13-0244 OKEY MANUEL SLATE V. DIVISION OF HIGHWAYS

The parties stipulated as follows: On October 1, 2011, Claimant was traveling on Route 16 near Bradley, Raleigh County, when his 1999 Honda Accord struck a large boulder which had fallen off the side of the roadway. As a result of the incident, Claimant suffered both property damage and personal injuries. Respondent is responsible for the maintenance of Route 16, which it failed to maintain properly on the date of the incident. The parties agree that \$963.54 is a fair and reasonable amount to resolve the claim.

AMOUNT CLAIMED: \$963.54 AMOUNT AWARDED: \$963.54

CC-14-0533 WILLIAM SPENCER V. DIVISION OF HIGHWAYS

The parties stipulated as follows: On May 23, 2012, Claimant was walking along a Statemaintained bridge near Valley View in Clendenin, Kanawha County, when the edge of the pavement collapsed, causing Claimant to fall approximately eight to nine feet. Claimant suffered personal injuries as a result of the incident. Respondent has denied liability in this matter, but has agreed to settle the claims made by Claimant. The parties agree that \$3,000.00 is a fair and reasonable amount to resolve the claim.

AMOUNT CLAIMED: \$5,000.00 AMOUNT AWARDED: \$3,000.00

CC-15-0010 NELA STENNETT AND ROBERT STENNETT V. DIVISION OF HIGHWAYS

Claimants brought this action to recover damages which occurred when their 2013 Toyota Camry struck a construction area cone on I-64 near Dunbar, Kanawha County. As a result of the incident, Claimants' vehicle sustained damage in the amount of \$851.86. Claimants' insurance required a \$500.00 deductible at the time of the incident, and Claimants' recovery is therefore limited to that amount. The Court finds that Respondent had at least constructive notice of the presence of objects in the roadway in the construction zone, and was therefore negligent in failing to act accordingly. The Court is aware that Respondent's agreement with the third-party construction contractor has an indemnity provision; thus, Respondent may seek reimbursement for any damages arising from this claim.

AMOUNT CLAIMED: \$851.86 AMOUNT AWARDED: \$500.00

CC-13-0414 CHARLES R. THIELE AND DEBRA L. THIELE V. DIVISION OF HIGHWAYS

The parties stipulated as follows: Claimants own property which abuts Route 2 near Moundsville, Marshall County. On March 27, 2013, a sinkhole developed near Claimants' property, and further collapsed on July 2, 2013, causing the material being used to fill the sinkhole to block a nearby culvert. As a result of the blockage, Claimants' property flooded on three occasions in 2013, damaging their rental home and yard. Respondent has denied liability in this matter, but has agreed to settle the claims made by Claimants. The sum of \$25,000.00 is fair and reasonable to resolve the claim.

AMOUNT CLAIMED: \$30,000.00 AMOUNT AWARDED: \$25,000.00

CC-14-1367 JAMES TREOLA V. DIVISION OF HIGHWAYS

Claimant seeks to recover \$323.94 in damages to his 2009 Chevrolet Silverado which struck a foreign object on Woodward Drive/Route 22 near Charleston, Kanawha County. The Court finds that Respondent had at least constructive notice of the risk posed by the object on Route 22, and Claimant is entitled to recovery for his damages.

AMOUNT CLAIMED: \$323.94 AMOUNT AWARDED: \$323.94

CC-14-0082 DOROTHY WELC V. DIVISION OF HIGHWAYS

The parties stipulated as follows: On March 29, 2012, Claimant stopped at a rest area located near Mile Marker 84 on Interstate 79 North in Lewis County. As she was walking across the parking lot, Claimant stepped in a hole, causing her to fall to the ground. Claimant suffered personal injuries as a result of the incident. Respondent has denied liability in this matter, but admits that in this case the Court of Claims would likely make an award; as such, Respondent has agreed to settle the claim. The sum of \$15,000.00 is fair and reasonable to resolve the claim.

AMOUNT CLAIMED: \$50,000.00 AMOUNT AWARDED: \$15,000.00

CC-14-1633 SHANE A. WILSON V. DIVISION OF HIGHWAYS

The parties stipulated as follows: On October 10, 2014, Claimant was traveling on Trace Fork Road in South Charleston, Kanawha County, when his 2013 Kia Sorento struck a large ditch in the travel portion of the roadway. Respondent was responsible for the maintenance of Trace Fork Road, which it failed to maintain properly on the date of the incident. Claimant's vehicle sustained damage in the amount of \$1,130.90; however, Claimant's insurance required a \$250.00 deductible, thereby limiting his recovery to that amount.

AMOUNT CLAIMED: \$1,130.90 AMOUNT AWARDED: \$250.00

CC-13-0526 SARAH STEELE WORKMAN V. DIVISION OF HIGHWAYS

The parties stipulated as follows: On June 23, 2013, Claimant was traveling on Route 60 near Kenova, Wayne County, when her vehicle collided with a utility pole next to the roadway, injuring her person and property. Claimant's 1999 Chevrolet Cavalier, valued at less than \$2,000.00, was a total loss. Further, Claimant sustained permanent injuries and will likely require future surgical intervention related to the incident. For purposes of settlement alone, Respondent acknowledges some culpability for the incident. The sum of \$10,000.00 is fair and reasonable to resolve the matter.

AMOUNT CLAIMED: \$50,000.00 AMOUNT AWARDED: \$10,000.00

CC-14-1574 AMY JO WRIGHT V. DIVISION OF HIGHWAYS

The parties stipulated as follows: On September 16, 2014, Claimant was traveling along

West Run Road near Morgantown, Monongalia County, when her 2013 Nissan Juke struck a large hole in the travel portion of the road, causing her vehicle to veer off the road into a tree. Claimant's vehicle was totaled as a result of the incident, and Claimant seeks reimbursement in the amount of \$13,088.72. Further, Claimant provided verification that her insurance policy did not cover charges of \$510.00 owed to the Star City Volunteer Fire Department, which amount is included in the claimed total. Claimant's insurance required a \$500.00 deductible. An award for the amount of Claimant's collision deductible and the total not covered by insurance is fair and reasonable to resolve this claim.

AMOUNT CLAIMED: \$13.088.72 AMOUNT AWARDED: \$1.010.00

CLAIM AGAINST DIVISION OF JUVENILE SERVICES

CC-15-0027 MOUNTAIN STATE JUSTICE INC. V. DIVISION OF JUVENILE SERVICES

Claimant brought this action to recover monies owed by Respondent which were ordered to be paid by the Circuit Court of Kanawha County for attorney fees and costs incurred during the ongoing law suit of *State Ex Rel D. L. And K. P. v. Stephanie Bond, Acting Director of the Respondent, et. al.*, which involved the Industrial Home for Boys in Salem, Harrison County. Respondent admitted the validity and the amount of the claim since the Circuit Court reviewed the invoices provided by Claimant and reduced these for the Order. This Court has considered the claim and makes an award pursuant to the Order of the Circuit Court.

AMOUNT CLAIMED: \$256,669.09 AMOUNT AWARDED: \$256,669.09

CLAIM AGAINST DIVISION OF LABOR

CC-15-1190 THOMSON REUTERS - WEST V. DIVISION OF LABOR

Claimant seeks to recover \$1,732.50 for services rendered to Respondent and documented by an unpaid invoice. In its Answer, Respondent admits the validity of the claim as well as the amount with respect to the services claimed, and states that there were sufficient funds expired in the appropriate fiscal year from which the invoice could have been paid.

AMOUNT CLAIMED: \$1,732.50 AMOUNT AWARDED: \$1,732.50

CLAIM AGAINST OFFICE OF THE CHIEF MEDICAL EXAMINER

CC-15-1663 TRACO BUSINESS SYSTEMS V. DEPARTMENT OF HEALTH AND HUMAN RESOURCES / BUREAU FOR PUBLIC HEALTH, OFFICE OF THE CHIEF MEDICAL

EXAMINER

Claimant seeks to recover \$13,964.25 for products supplied to Respondent and documented by an unpaid invoice. Respondent admitted the validity and amount of the claim, and stated that sufficient funds were allocated in the appropriate fiscal year from which the invoice could have been paid.

AMOUNT CLAIMED: \$13,964.25 AMOUNT AWARDED: \$13,964.25

CLAIMS AGAINST REGIONAL JAIL AUTHORITY

CC-14-1520 GARY R. BAKER V. REGIONAL JAIL AUTHORITY

Claimant brought this claim to recover the value of certain personal property items he alleges were entrusted to Respondent but have not been returned to him. At the hearing, Respondent stipulated to liability and damages. The Court finds that Respondent is liable for the loss of the property, and Claimant may recover his damages.

AMOUNT CLAIMED: \$100.00 AMOUNT AWARDED: \$100.00

CC-14-0005 ANTHONY CARTAGENA V. REGIONAL JAIL AUTHORITY

Claimant brought this action to recover \$221.51 for items of personal property he alleges were stolen from his cell during a search. At the hearing, Respondent stipulated to liability and damages in the amount of \$140.00, which Claimant agreed to accept. The Court finds that the Respondent is liable for the loss of the property, and Claimant may recover his damages as agreed.

AMOUNT CLAIMED: \$221.51 AMOUNT AWARDED: \$140.00

CC-13-0345 EARL EDMONDSON V. REGIONAL JAIL AUTHORITY

Claimant brought this action to recover \$140.00 for the cost of dentures that were necessary after the extraction of all of his teeth while he was housed at Respondent's facility. Respondent argues that it is not a proper party to this action, as the extraction and other dental services were provided by Prime Care, an independent company. The evidence adduced at the hearing established that at the time of Claimant's procedure, Respondent had a contract with Prime Care to provide medical services to inmates, which contained an indemnification provision for judgments against Respondent. Further, Respondent is required by statute to provide medical care to inmates, and was responsible for withdrawing the cost of the dentures from Claimant's inmate account. The Court therefore finds that Respondent is liable for the cost of the dentures improperly charged to Claimant. Respondent may seek reimbursement from the third-party contractor for any damages arising from this claim.

AMOUNT CLAIMED: \$140.00 AMOUNT AWARDED: \$140.00

CC-15-1507 DALE P. FIELD JR. V. REGIONAL JAIL AUTHORITY

Claimant brought this action to recover \$68.68 for items of personal property he alleges were entrusted to Respondent but have not been returned to him. At the hearing, Respondent stipulated to liability and damages. The Court finds that the Respondent is liable for the loss of the property, and Claimant may recover his damages.

AMOUNT CLAIMED: \$68.68 AMOUNT AWARDED: \$68.68

CC-15-0055 LAWRENCE GALBEARTH V. REGIONAL JAIL AUTHORITY

Claimant brought this action to recover \$119.76, plus \$500.00 in punitive damages, for certain magazines he alleges were converted by Respondent during his incarceration at Northern Regional Jail. At the hearing, Claimant testified that he had been contacted by Respondent's counsel and had agreed to settle the claim for \$25.00. Counsel confirmed that this stipulation was correct. The Court finds that Respondent is liable for the missing magazines, and Claimant may recover his damages as agreed.

AMOUNT CLAIMED: \$25.00 AMOUNT AWARDED: \$25.00

CC-15-0096 SANDRA HARRON V. REGIONAL JAIL AUTHORITY

Claimant brought this action to recover \$1,000.00 for items of personal property she alleges were entrusted to Respondent but have not been returned to her. At the hearing, Respondent stated that part of the property had been recovered, and stipulated to \$300.00 for the remaining property. The Court finds that Respondent is liable for the missing property, and Claimant may recover her damages as agreed.

AMOUNT CLAIMED: \$1,000.00 AMOUNT AWARDED: \$300.00

CC-15-0021 TRAVIS HUDSON V. REGIONAL JAIL AUTHORITY

Claimant brought this action to recover \$2,000.00 for items of personal property he alleges were converted by Respondent while he was being transferred to another facility. Respondent stipulated to liability for the loss of the property and unsuccessfully attempted to locate the Claimant's lost watch. The Court finds that Respondent is liable for the missing property, and determined that an award of \$800.00 was fair and reasonable to compensate Claimant for his loss.

AMOUNT CLAIMED: \$2,000.00 AMOUNT AWARDED: \$800.00

CC-15-0018 DANA D. LAFOND V. REGIONAL JAIL AUTHORITY

Claimant brought this action to recover \$107.00 for items of personal property he alleges were entrusted to Respondent but were not returned to him. At the hearing, Respondent stipulated to liability and damages in the amount of \$75.00, which Claimant agreed to accept. The Court finds that Respondent is liable for the missing items, and Claimant may recover his damages as agreed.

AMOUNT CLAIMED: \$107.00

CC-15-0156 STEPHEN RANDOLPH MILLER JR. V. REGIONAL JAIL AUTHORITY

Claimant seeks \$400.00 for items of personal property he alleges were entrusted to Respondent but were not returned to him. At the hearing, Respondent stipulated to liability and damages in the amount of \$275.00, which Claimant agreed to accept. The Court finds that Respondent is liable for the missing items, and Claimant may recover his damages as agreed.

AMOUNT CLAIMED: \$400.00 AMOUNT AWARDED: \$275.00

CC-12-0067 ROBERT W. MOATS V. REGIONAL JAIL AUTHORITY

Claimant brought this action to recover \$1,400.00 in damages for the loss of certain personal property items he alleges were converted by Respondent while he was being transferred to another correctional facility. This Court had previously issued an Opinion which inadvertently transposed the present claim number with that of another of Claimant's claims, and had made an award for items included in the other claim. The Court now finds the previously issued Opinion was erroneous and is hereby modified. Regarding the property items included in this claim, the Court finds that the parties had created a bailor/bailee relationship, and Respondent is liable for the missing items. The Court finds that an award of \$550.00 is fair and reasonable to compensate Claimant for his loss.

AMOUNT CLAIMED: \$1,400.00 AMOUNT AWARDED: \$550.00

CC-15-0125 VU THIEN NGUYEN V. REGIONAL JAIL AUTHORITY

Claimant seeks to recover \$420.00 for funds he was entitled to receive upon his release from Respondent's facility, but which could not be processed by the jail's money machine at that time. At the hearing, Respondent stipulated to liability and damages. The Court finds that Respondent is liable to Claimant for the full amount, and Claimant may recover his loss.

AMOUNT CLAIMED: \$420.00 AMOUNT AWARDED: \$420.00

CC-15-1438 BRIAN W. PEARL V. REGIONAL JAIL AUTHORITY

Claimant seeks to recover \$500.00 for items of personal property he alleges were entrusted to Respondent but were not returned to him. At the hearing, Respondent stipulated to liability and damages. The Court finds that Respondent is liable to Claimant for the missing items, and Claimant may recover his loss.

AMOUNT CLAIMED: \$500.00 AMOUNT AWARDED: \$500.00

CLAIM AGAINST STATE FIRE COMMISSION

<u>CC-15-0030 WEST VIRGINIA MEDIA MANAGEMENT LLC V. STATE FIRE COMMISSION</u>

Claimant seeks to recover \$50,016.00 for media services provided to Respondent and documented by multiple invoices for fiscal year 2014. In its Answer, Respondent admitted the validity of the claim as well as the amount with respect to the media services provided, and stated that there were sufficient funds expired in the appropriate fiscal year from which the invoice could have bene paid. However, Respondent stated that it was without the ability to pay the claimed amount due to its failure to adhere to purchasing laws and guidelines, as the amount exceeds the total payable for a sole source purchase order. The Court finds that Claimant provided the media services in good faith to Respondent and, based upon the principle of unjust enrichment, Claimant should be awarded the full amount.

AMOUNT CLAIMED: \$50,016.00 AMOUNT AWARDED: \$50,016.00

CLAIMS AGAINST STATE OF WEST VIRGINIA

CC-08-0022 ROGER ALLEN GREEN V. STATE OF WEST VIRGINIA

The Court had previously issued an Opinion in this matter granting in part and denying in part Respondent's Motion to Dismiss, finding that Respondent was liable to Claimant for damages relating to his unjust arrest and imprisonment on a 2006 kidnaping charge. As to damages, the Court finds that a total award of \$11,000.00 is fair and reasonable to compensate Claimant for both his economic and non-economic damages as a result of his arrest and imprisonment.

AMOUNT CLAIMED: \$47,000.00 AMOUNT AWARDED: \$11,000.00

CC-13-0457 WESLEY CHARLES HARDY V. STATE OF WEST VIRGINIA

The parties stipulated as follows: Claimant alleges in this claim that he was unjustly arrested, convicted, and incarcerated, and seeks damages to compensate him for resulting injuries. The parties agree that an award of \$1,000.00 is fair and reasonable to resolve the claim. Respondent does not admit liability in this matter, but rather agrees to settle the claim in lieu of litigation.

AMOUNT CLAIMED: \$3,000.00

CC-15-1966 CASEY JO MCGEE AND SARAH ELIZABETH ADKINS; JUSTIN MURDOCK AND WILLIAM GLAVARIS; AND NANCY ELIZABETH MICHAEL AND JANE LOUISE FENTON, AS NEXT FRIENDS OF A.S.M., A MINOR CHILD V. STATE OF WEST VIRGINIA

Claimants brought this action to recover \$99,804.64 for attorney fees and costs incurred in representation of the Claimants in an action in the U.S. District Court for the Southern District of West Virginia wherein the attorney fees and costs were ordered to be paid by the State of West Virginia. In its Answer, Respondent admitted the validity as well as the amount of the claim. The Court finds that Claimants should be awarded the sum of \$99,804.64. (Chief Judge J. David Cecil recused himself from participation in this claim.)

AMOUNT CLAIMED: \$99,804.64 AMOUNT AWARDED: \$99,804.64
